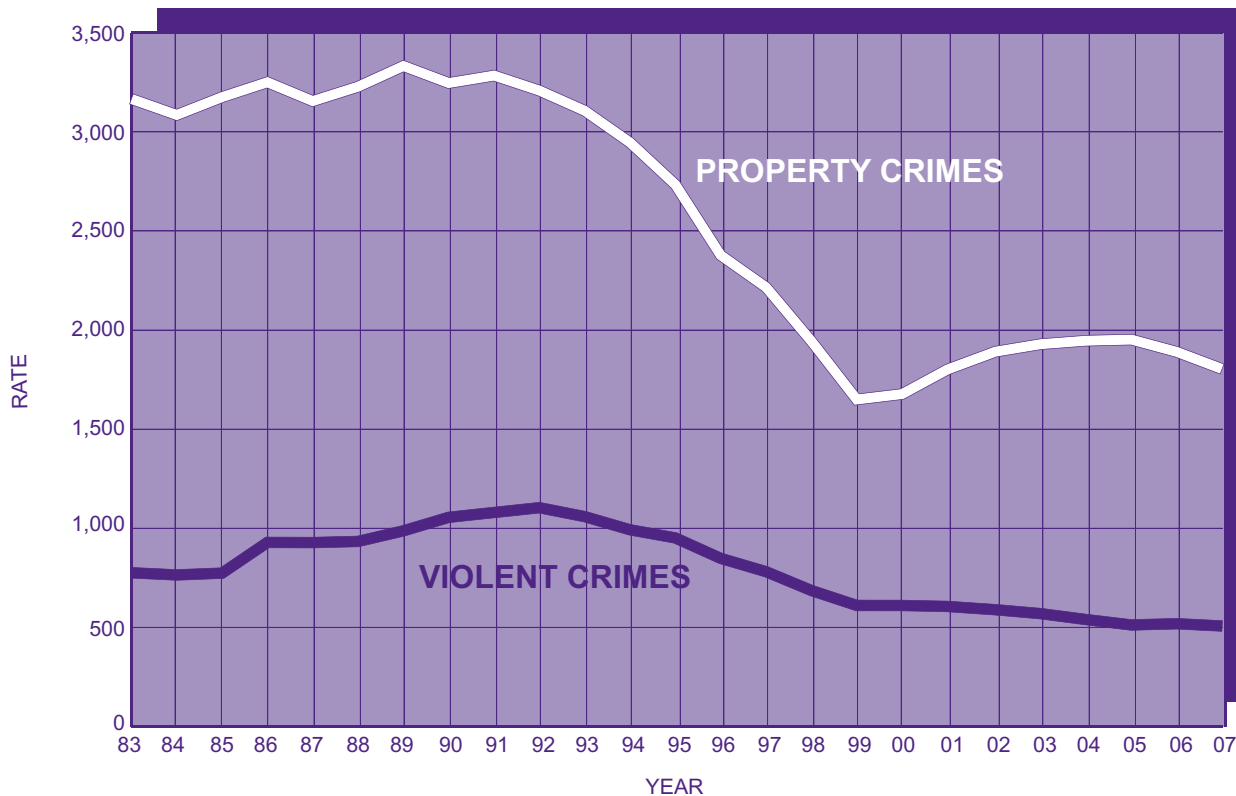

The violent crime rate:

- ☐ Decreased 2.2 percent from 2006 to 2007, and has decreased 54.1 percent since it peaked in 1992.

The property crime rate:

- ☐ Decreased 4.6 percent from 2006 to 2007, and has decreased 45.9 percent since it peaked in 1989.

Crime in California, 2007, Advance Release provides 2007 criminal justice data on crimes, arrests, adult felony arrest dispositions, and juvenile dispositions and placements. The full reports, *Crime in California, 2007* and *Juvenile Justice in California, 2007*, will be completed later in 2008.
