COMMENTS OF CALIFORNIA ATTORNEY GENERAL ON DRAFT COMMISSION LONG-TERM ENERGY EFFICIENCY STRATEGIC PLAN

Thank you for the opportunity to provide comments on the California Energy Efficiency Strategic Plan (Plan). We commend the PUC on producing a very ambitious, thoughtful and comprehensive document, and we thank you for your serious consideration of our comment letter to the previous draft dated April 15, 2008. In response to Commissioner Grueneich's letter soliciting input regarding any major gaps and/or omissions in this version of the Plan, we would like to raise one issue that seems

critical. The Plan's ambitious goals of 100% zero net energy homes by 2020 and greatly reduced energy use in existing single and multi-family homes will require a significant increase in the use of distributed generation of renewable energy on all types of residential buildings. Therefore, the Implementation Plan should include actions to address the legal and/or regulatory barriers that 1) restrict the ability to install solar PV systems that supply power to residents of condominiums and apartments and 2) prevent using a solar PV system on one building to generate electricity for multiple residences, including, for example, individual unit metering requirements that tend to preclude the use of rooftop solar power system that provides power to multiple residences.

Thank you for your attention to this important issue.
