Trial of this action proceeded on June 27, 28, and 29, 2005, in Department 68 of the Los Angeles Superior Court, Honorable Lee Smalley Edmon presiding. Following trial, parties submitted Post-Trial Briefs and returned to court on August 10, 2005, for closing arguments. Having considered the parties' trial and post-trial briefs, the evidence, the relevant authorities and the oral argument of counsel, the court issued a written [Tentative] Ruling and Statement of Decision, finding:

1. In favor of the Plaintiff and against Defendants Consumer Cause, Inc. and Morse Mehrban only, as to the single cause of action in Plaintiff's First Amended Complaint, for twenty

1 (20) separate violations of the Business & Professions Code Section 17200;

2 2. In favor of the Defendant Julie Rosolowski as to the single cause of action in
3 Plaintiff's First Amended Complaint; and

4 3. That no injunction should issue as to any defendant.

5 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

6 1. That Defendants Morse Mehrban and Consumer Cause, Inc., jointly and severally,
7 pay \$1,000 per violation, for a total of \$20,000, in penalties pursuant to Business & Professions
8 Code § 17206, and that Defendants Morse Mehrban and Consumer Cause, Inc., jointly and
9 severally, pay Plaintiffs their allowable costs of suit;

10 2. That Plaintiff recovers nothing and that this action be dismissed as to Defendant
11 Julie Rosolowski, and that Defendant Julie Rosolowski recovers from Plaintiff her allowable
12 costs of suit; and

13 3. That this Judgment be entered by the Clerk of the Court.
