We are writing to you as a participant in the Accume Partner 401(k) Plan. ("Plan")

Recently we learned of a data security breach involving a laptop belonging to WeiserMazars, LLC, the CPA firm which audits the statement of net assets available for Plan benefits in connection with the Plan's annual reporting obligations under the Employee Retirement Income Security Act of 1974. The laptop was stolen from the vehicle of a WeiserMazars employee on October 10, 2012 prior to 7:30AM in Philadelphia, Pennsylvania. The WeiserMazars employee stored certain personal information regarding plan participants on the laptop, including name and Social Security number of plan participants, and in some instances, address, date of birth, 401(k) information and payroll information for plan participants. WeiserMazars advised us that they have no reason to believe that any personal data was targeted for misuse, and we have no information that any personal data has been accessed by an unauthorized party. Nonetheless, because this incident might have compromised personally identifiable information, we urge you to consider taking steps to protect against identity theft, including considering the offer for identity theft protection service, discussed below.

We understand that WeiserMazars has notified local police and is cooperating in the investigation of the theft of the laptop. You have the right to request a police report. Accume received a letter from WeiserMazars on October 31, 2012, putting it on notice of the data breach. Since learning of the theft, we have been diligently working to identify the exact information that resides on the computer and who was affected by the data breach. WeiserMazars has assured us they have taken steps to prevent future incidents, including enhancing security policies with respect to laptops and other portable devices.

In addition to accepting the identify theft program discussed below you might wish to obtain information about steps you can take to avoid identify theft, such as fraud alerts and security freezes from the Federal Trade Commission, California Attorney General or contact the major credit reporting agencies. We will reimburse any charges imposed by the credit reporting agencies.
