1 The entities designated as the Settling Defendants, as described on Exhibit A hereto
2 (hereinafter the "Settling Defendants"), along with their respective related or affiliated settling entities,
3 as also described on Exhibit A hereto (hereinafter collectively the "Settling Entities"), and Plaintiffs,
4 the People of the State of California ("People") hereby stipulate to entry of this Consent Judgment as
5 follows:

6 1. Introduction

7 1.1 On April 10, 2003, the People filed People v. Bennigans, et al. (Los Angeles
8 Superior Court No. BC293749) and People v. Benihana, et al. (San Francisco Superior Court No.
9 CGC 03419292) (the "Complaints") in state court for Civil Penalties and Injunctive Relief under
10 Health & Safety Code sections 25249.5 et seq. and Business and Professions Code sections 17200 et
11 seq. against a variety of different entities (the "Named Defendants"), in which the People alleged that
12 each of the Named Defendants was a company that employed more than ten persons and offered for
13 sale within the State of California some or all of the following fresh or frozen fish to consumers within
14 the state of California: Swordfish, Ahi (Yellowfin) tuna, Albacore tuna, shark (hereinafter "Fish".)

15 1.2 The Complaints allege that the Named Defendants violated provisions of the
16 Safe Drinking Water and Toxic Enforcement Act of 1986, Health and Safety Code sections 25249.5 et
17 seq. ("Proposition 65"), and Business and Professions Code sections 17200 et seq. ("Unfair
18 Competition Act"), by knowingly and intentionally exposing persons to mercury, mercury
19 compounds, methyl mercury, and methylmercury compounds (hereinafter "Mercury"), chemicals
20 known to the State of California to cause cancer and/or reproductive toxicity, by the sale of Fish to
21 consumers within the State of California, without first providing a clear and reasonable warning to
22 such individuals. The Named Defendants and the Settling Entities deny these allegations.

23 1.3 On October 23, 2003, all actions were coordinated in this coordination
24 proceeding. On October 27, 2003 the Honorable Richard Kramer was assigned as the coordination
25 trial judge.

26 1.4 For purposes of this Consent Judgment only, the People, the Named Defendants
27 and the Settling Entities (hereinafter collectively the "Parties") stipulate that this Court has jurisdiction
28 over the allegations of violations contained in the Complaints and personal jurisdiction over the

1 Settling Entities as to the allegations in the Complaints, that venue is proper in the City and County of
2 San Francisco, and that this Court has jurisdiction to enter this Consent Judgment.

3 1.5 This Consent Judgment is the product of negotiation and compromise and is
4 accepted by the Parties for purposes of settling, compromising and resolving issues disputed in this
5 action, including future compliance with Section 2 of this Consent Judgment, and compliance with
6 Proposition 65 as to matters alleged in the Complaint.

7 1.6 The Parties enter into this Consent Judgment to settle certain disputed claims as
8 alleged in the Complaints and to avoid potentially lengthy and/or costly litigation between the Parties
9 hereto. By execution of this Consent Judgment, the Parties do not admit any facts or conclusions of
10 law, including, but not limited to, any facts or conclusions of law suggesting or demonstrating any
11 violations of Proposition 65, the Unfair Competition Act, or any other statutory, common law or
12 equitable requirements relating to Fish. Nothing in this Consent Judgment shall be construed as an
13 admission by the Parties of any fact, conclusion of law, issue of law or violation of law, nor shall
14 compliance with the Consent Judgment constitute or be construed as an admission by the Parties,
15 either individually or collectively, of any fact, conclusion of law, issue of law, or violation of law.
16 Nothing in this Consent Judgment shall prejudice, waive or impair any right, remedy, argument or
17 defense the Parties may have in this or any other or future legal proceedings. This paragraph shall not
18 diminish or otherwise affect the obligations, responsibilities, and duties of the parties under this
19 Consent Judgment.

20 2. Injunctive Relief - Warning Program

21 2.1 For purposes of settlement of issues concerning the warning requirements of
22 Proposition 65 for Mercury, as to sales of Fish, as well as sales of any other fish or sea food which
23 may be subject to the warning requirements of Proposition 65 for Mercury, the Settling Entities agree
24 to provide clear and reasonable warnings, either in the form set forth in Exhibit B ("Attorney General
25 Warning"), or a warning in the form provided by 22 California Code of Regulations section
26 12601(b)(4)(C) as set forth in Exhibit C ("Regulatory Warning") (collectively, "Warning Signs") as
27 indicated in Paragraphs 2.2 and 2.3 below, in restaurants in California where Fish is sold and that are
28

1 owned or operated by the Settling Entities that are the subject of the Complaints and as identified in
2 Exhibit D hereto (hereinafter the "Restaurants").

3 2.2 Within thirty (30) days of receipt of notice of entry of this Consent Judgment by
4 the Court,

5 1) All Settling Entities listed in Exhibit A, with the exception of those
6 Settling Entities listed below in section 2.2 (2), shall provide the Attorney
7 General Warning (printed on 65 pound cover stock, 8 1/2" by 11" in size, with
8 the content, form, color, and print style as set forth in Exhibit B) in each of their
9 Restaurants.

10 2) S & A Restaurant Corporation sued herein as Bennigan's, Metromedia
11 Restaurant Group and Metromedia Restaurant Services, Inc. (the "Bennigan's
12 Entities") and Morton's Restaurant Group, Inc., Morton's of Chicago, Inc. and
13 Porterhouse of Los Angeles, Inc. ("Morton's Entities") shall provide the
14 Regulatory Warning (printed on 65 pound cover stock, 8 1/2" by 11" in size,
15 with the content, form, and print style as set forth in Exhibit C) in each of its
16 Restaurants.

17 2.3 At their discretion, the Settling Entities posting the Attorney General Warning
18 may also post the Regulatory Warning but may not discontinue use of the Attorney General Warning.
19 The Settling Entities posting the Regulatory Warning may also choose to post the Attorney General
20 Warning, or may discontinue use of the Regulatory Warning and use only the Attorney General
21 Warning.

22 2.4 The warning(s) as set forth above shall be posted for that Restaurant in one of
23 the following areas: a) near the front door, b) on or near the host/hostess desk or reception area, or c)
24 at any point in or near the entryway or waiting area of the Restaurant. In each area, the warning shall
25 be posted at or near eye level in a sufficiently well-lit area, so that customers entering the Restaurant
26 will be able to immediately see the warning.

27 2.5 The Settling Entities represent that, either since (i) the date of opening of each
28 Restaurant, or (ii) one year before the date of entry of this Consent Judgment, at least one of the

1 Warning Signs described above was posted at each Restaurant where Fish is sold, and that said
2 Warning Sign(s) was or were maintained at each such Restaurant.

3 3. Settlement Payments - Civil Penalties

4 3.1 Within thirty (30) days after the notice of entry of this Consent Judgment, as
5 full, final and complete satisfaction of all claims against the Settling Entities for civil penalties or
6 restitution for the alleged violations of Proposition 65 as regards Mercury in Fish, up to and including
7 the date of entry of this Consent Judgment, the Settling Defendants shall pay 50% of the respective
8 amounts set forth in Column 1 of Exhibit E hereto by mailing a check, payable to the "Office of the
9 Attorney General of the State of California" (Attn: Susan S. Fiering, Deputy Attorney General), 1515
10 Clay Street, 20th Floor, P.O. Box 70550, Oakland, CA 94612 . Payment of the preceding amount
11 shall be made as a civil penalty pursuant to Health & Safety Code Section 25249.7(b) and
12 25249.11(c). Making this payment shall not be construed as an admission by the Settling Entities of
13 any fact, conclusion of law, or violation of law, nor shall compliance with the Consent Judgment
14 constitute or be construed as an admission by the Settling Entities of any fact, conclusion of law, or
15 violation of law after the notice of entry of this Consent Judgment.

16 4. Settlement Payments - Payment of Costs and Fee

17 4.1 Within thirty (30) days after entry of this Consent Judgment, the Settling
18 Defendants, except for Darden on behalf of Red Lobster, shall pay the respective amounts set forth in
19 Column 2 of Exhibit E hereto as reimbursement of the Attorney General's costs of investigating,
20 bringing this action and negotiating a settlement, by mailing a check, payable to the "Office of the
21 Attorney General of the State of California", 1515 Clay Street, 20th Floor, P.O. Box 70550 Oakland,
22 CA 94612 (Attn: Susan S. Fiering, Deputy Attorney General). These funds shall be placed in an
23 interest-bearing Special Deposit Fund established by the Attorney General. These funds, including
24 any interest derived therefrom, shall be used by the Attorney General, until all funds are exhausted, for
25 the costs and expenses associated with the enforcement and implementation of the Safe Drinking
26 Water and Toxic Enforcement Act of 1986 ("Proposition 65"), including investigations, enforcement
27 actions, other litigation or activities as determined by the Attorney General to be reasonably necessary
28 to carry out his duties and authority under Proposition 65. Such funding may be used for the costs of

1 the Attorney General's investigation, filing fees and other court costs, payment to expert witnesses and
2 technical consultants, purchase of equipment, travel, purchase of written materials, laboratory testing,
3 sample collection, or any other cost associated with the Attorney General's duties or authority under
4 Proposition 65. Funding placed in the Special Deposit Fund pursuant to this Paragraph, and any
5 interest derived therefrom, shall solely and exclusively augment the budget of the Attorney General's
6 Office and in no manner shall supplant or cause any reduction of any portion of the Attorney General's
7 budget.

8 4.2 Darden, on behalf of Red Lobster, shall pay the amount set forth in Column 2 of
9 Exhibit E hereto as reimbursement of As You Sow's and the Sea Turtle Restoration Project's costs of
10 investigating and bringing the action As You Sow et al v. Safeway et al., No. CGC-03-417139, by
11 mailing a check, payable to Mark S. Pollack, Esq., in care of Law Offices of Mark S. Pollock, Esq.,
12 1766 Third Street, Napa, CA 94559.

13 5. Settlement Payments - Education and Monitoring Program

14 5.1 Within thirty (30) days after the notice of entry of this Consent Judgment, the
15 Settling Defendants shall pay 50% of the respective amounts set forth in Column 1 of Exhibit E hereto
16 to the Public Health Trust ("Trust"), a program of the Public Health Institute, to be used to fund
17 programs to educate consumers concerning Mercury in fish and seafood and to be used to monitor
18 compliance with the injunctive relief portions of the Consent Judgment concerning posting of the
19 Warning Sign, by mailing a check, payable to the "Public Health Trust", 180 Grand Ave., Oakland,
20 CA 94612 (attention: Marice Ash) with a copy to the Office of the Attorney General of the State of
21 California at 1515 Clay Street, 20th Floor, P.O. Box 70550 Oakland, CA 94612 (Attn: Susan S.
22 Fiering, Deputy Attorney General).

23 5.2 Any process undertaken by the Public Health Trust to identify and choose the
24 entity that will conduct the education program or the program to monitor compliance with the
25 Warning Sign program must be open to public scrutiny and subject to public notice and comment.
26 Any proposed use of the funds must be approved by the Attorney General.

1 6. Stipulated Penalties

2 6.1 In the event that a Restaurant fails to post the required Warnings, as set forth in
3 section 2 above, the corresponding Settling Defendant shall be liable for stipulated penalties as
4 follows:

5 First Violation at a facility:	\$500
6 Second Violation at same facility:	\$1,500
7 Third and Subsequent Violations at 8 the same facility:	\$2,500

9 6.2 Except as provided in paragraph 6.4 below, within ten (10) days of receipt of
10 written notice from the People that the Warning Sign is not properly posted, the Settling
11 Defendant/Entity receiving the written notice shall pay the appropriate sum set forth in paragraph 6.1
12 above as a penalty amount. The payment shall be made to the "Office of the Attorney General of the
13 State of California" (Attn: Susan S. Fiering, Deputy Attorney General), 1515 Clay Street, 20th Floor,
14 P.O. Box 70550, Oakland, CA 94612 . Payment of the preceding amount shall be made as a civil
15 penalty pursuant to Health & Safety Code Section 25249.7(b) and 25249.11(c). The written notice
16 shall identify the facility in which the warning sign was not properly posted. The Settling
17 Defendants/Entities designate the individuals set forth respectively in Exhibit A under the heading
18 "Persons to Receive Notice" to receive the written notice as specified above.

19 6.3 Except as provided in paragraph 6.4 below, within ten (10) days after receiving
20 written notice that the Warning Sign was not properly posted, the Settling Defendant/Entity receiving
21 the written notice shall post the required warning and shall provide to the People a declaration under
22 penalty of perjury stating when the warning was posted.

23 6.4 If, after receiving the written notice specified in paragraph 6.2 above, the
24 Settling Defendant/Entity receiving the notice maintains that the Warning Sign was properly posted,
25 the Settling Defendant/Entity may challenge the stipulated penalties by filing a motion with this Court
26 to be relieved of any stipulated penalties. The only basis for challenging stipulated penalties shall be
27 that the Warning Sign was properly posted. The motion must be filed within thirty days (30) of
28

1 receipt of the written notice. The Court shall receive whatever evidence is necessary and shall
2 conduct a hearing as necessary to determine whether or not the Warning Sign was properly posted.

3 6.5 Notwithstanding paragraph 6.1 above, in the event that any Restaurant has been
4 cited with three Violations at a single facility, the People may seek to enforce this Consent Judgment
5 through any civil enforcement proceedings available by law for the fourth or subsequent Violation.

6 7. Additional Enforcement Actions; Continuing Obligations

7 7.1 By entering into this Consent Judgment, the People do not waive any right to
8 take further enforcement actions on any violations not covered by the Complaints or this Consent
9 Judgment, and the Settling Entities do not waive any rights or defenses, as to any violations not
10 covered by the Complaints or this Consent Judgment. Nothing in this Consent Judgment shall be
11 construed as diminishing any Settling Entities' obligations to comply with Proposition 65 or the Unfair
12 Competition Act in its future activities.

13 8. Enforcement of Consent Judgment

14 8.1 The Attorney General may, by motion or order to show cause before the
15 Superior Court of San Francisco, enforce the terms and conditions contained in this Consent
16 Judgment. In any action brought by the People to enforce this Consent Judgment, the People may
17 seek whatever fines, costs, attorneys fees, penalties or remedies are provided by law for failure to
18 comply with the Consent Judgment, provided, however, that the People are limited to stipulated
19 penalties pursuant to Section 6 above for the first three Violations at any single facility. Where said
20 failure to comply constitutes a fourth or subsequent Violation at a single facility, or constitutes a
21 violation of Proposition 65 or other laws not covered by this Consent Judgment, the People are not
22 limited to enforcement of this Consent Judgment but may seek in another action, whatever fines, costs,
23 attorneys fees, penalties or remedies are provided by law for failure to comply with Proposition 65 or
24 other such laws. However, the rights of the Settling Entities to defend themselves and their actions in
25 law or equity shall not be abrogated or reduced in any fashion by the terms of this paragraph, and the
26 Settling Entities shall be entitled to raise any and all applicable defenses and/or counterclaims, arising
27 in law or equity, against the Plaintiff and to seek such costs, damages, and attorneys fees as may
28

1 apply. However, this paragraph shall not diminish or otherwise affect the obligations, responsibilities,
2 and duties of the Parties under this Consent Judgment.

3 9. Application of Consent Judgment

4 9.1 The Consent Judgment shall apply to, be binding upon and inure to the benefit
5 of, the Parties, their parents, divisions, subdivisions, subsidiaries, owners, managers, officers,
6 employees, and affiliates and the predecessors, successors or assigns of each of them.

7 10. Claims Covered

8 10.1 Except as provided below, this Consent Judgment is a full and fair adjudication
9 of all claims and a final and binding resolution between the People and the Settling Entities of any and
10 all alleged violations of Proposition 65, and the Unfair Practices Act, Business and Professions Code
11 Sections 17200 et seq. or any other statutory or common law claim that could have been asserted in
12 the Complaints against the Settling Entities up through the date of entry of this agreement arising from
13 any actual or alleged failure to provide clear and reasonable warnings pursuant to Proposition 65 of
14 exposure to Mercury from consumption of Fish. Hereinafter, compliance by the Settling Entities with
15 this Consent Judgment constitutes compliance with Proposition 65 as to consumer exposures to
16 Mercury resulting from the sale of any Fish or sea food which may be subject to the warning
17 requirements of Proposition 65 within the State of California by any of the Settling Entities.

18 11. Confidentiality of Data

19 11.1 For settlement purposes only, the Settling Entities submitted to the Attorney
20 General proprietary and trade secret Fish sales data with the express understanding that such data
21 would be held confidentially by the Attorney General for settlement purposes in this case only and
22 would not be released to any other persons or entities outside of the office of the Attorney General,
23 including other Settling Entities. The People and the Attorney General shall not disclose any such
24 Fish sales data to any other persons or entities outside of the Office of the Attorney General, including
25 other Settling Entities, unless otherwise ordered by a court of competent jurisdiction. In addition, said
26 Fish sales data is privileged and confidential to the extent provided by Rule 408 of the Federal Rules
27 of Evidence and California Evidence Code sections 1040 and 1152.

1 12. Entire Agreement

2 12.1 This Consent Judgment contains the sole and entire agreement and
3 understanding of the Parties with respect to the entire subject matter hereof, and any and all prior
4 discussions, negotiations, commitments and understandings related hereto. No representations, oral or
5 otherwise, express or implied, other than those contained herein have been made by any party hereto.
6 No other agreements not specifically referred to herein, oral or otherwise, shall be deemed to exist or
7 to bind any of the parties.

8 13. Authority to Stipulate to Consent Judgment

9 13.1 Each signatory to this Consent Judgment certifies that he or she is fully
10 authorized by the party he or she represents to enter into this Consent Judgment on behalf of the party
11 represented and legally to bind that party.

12 14. Modification

13 14.1 This Consent Judgment may be modified from time to time by express written
14 agreement of the Parties, with the approval of the Court, or by an order of this Court in accordance
15 with law. Grounds for considering modification shall include any that are permitted by law, including,
16 but not limited to, the grounds set forth below.

17 14.2 If the Attorney General subsequently agrees in a settlement or judicially entered
18 injunction or consent judgment that Fish do not require a warning under Proposition 65, or that a
19 modified warning for Fish is appropriate that differs from that imposed in this Consent Judgment; or a
20 court of competent jurisdiction renders a final judgment in a case brought by the Attorney General that
21 eliminates the warning requirement for Fish or that modifies the warning requirement for Fish that
22 differs from that imposed under this Consent Judgment, then any one or more of the Settling Entities
23 may seek to modify this Consent Judgment to eliminate or modify the warning set forth in section 2,
24 consistent with the Attorney General's agreement or with the court judgment as described herein.

25 14.3 Any Settling Entity(ies) seeking such modification shall provide written notice
26 to the People that they intend to seek modification of the Consent Judgment pursuant to the provisions
27 of paragraph 14.1 above. If the People agree that any modification or elimination of the warning is
28 justified pursuant to the provisions of section 14.1 above, the People and such Settling Entity(ies) shall

1 jointly move the Court to modify the Consent Judgment to eliminate or modify the warning
2 requirement.

3 14.4 If the People do not agree that the elimination or modification of the warning
4 requirement of this Consent Judgment is justified pursuant to the provisions of section 14.1 above, the
5 Settling Entity(ies) may file a motion with the Court, seeking to eliminate or modify the warning
6 requirement based on the provisions of section 14.1 above. The People may oppose any such motion.
7 In any motion by one or more Settling Entities under this section, the burden of proving that the
8 warning should be eliminated or modified based on the provisions of section 14.1 above, shall be upon
9 such Settling Entity(ies).

10 14.5 Nothing in this section shall apply to Sections 3, 4, or 5 of this Consent
11 Judgment.

12 15. Execution in Counterparts

13 15.1 This Consent Judgment may be executed in counterparts, which taken together
14 shall be deemed to constitute one and the same document.

15 16. Entry of Stipulation for Entry of Consent Judgment Required

16 16.1 This Stipulation for Entry of Consent Judgment shall be null and void, and be
17 without any force or effect, unless entered by the Court in this matter. If the Consent Judgment is not
18 entered by the Court, the execution of this Consent Judgment by any Settling Entity or the People
19 shall not be construed as an admission by such Settling Entity or the People of any fact, issue of law or
20 violation of law.

21 17. Retention of Jurisdiction

22 17.1 This Court shall retain jurisdiction of this matter to implement the Consent
23 Judgment.
