**FINAL JUDGMENT AND
 INJUNCTION PURSUANT
 TO STIPULATION**

ORDER [PROPOSED]

22 **IT IS HEREBY STIPULATED BY AND BETWEEN THE PARTIES THAT:**

23 Plaintiff, the People of the State of California ("Plaintiff"), appearing through its attorneys
 24 Kamala D. Harris, Attorney General of the State of California, by Brett J. Morris, Deputy
 25 Attorney General and Defendants, Phillips 66 Company and ConocoPhillips Company (hereafter
 26 collectively "Defendants" and individually "Defendant"), appearing through their attorneys
 27 Glynn & Finley, LLP, by Andrew T. Mortl; and Plaintiff and Defendants having stipulated and
 28 consented to the entry of this Final Judgment and Injunction Pursuant to Stipulation ("Final

1 Judgment”) and without trial or adjudication of any fact or law herein; and the Court having
2 considered the pleadings and such arguments as may be had, and good cause appearing:

3 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** as follows:

4 **JURISDICTION**

5 1. This action is brought under California law and this Court has jurisdiction over the
6 subject matter and over Plaintiff and Defendants (collectively “the Parties”).

7 **APPLICABILITY**

8 2. Plaintiff alleges that Defendants have committed violations of requirements imposed by
9 the California Health and Safety Code and related implementing regulations that govern (a) the
10 operation and maintenance of underground storage tanks (“USTs”) and UST systems, (b) the
11 handling of hazardous wastes and hazardous substances generated by operation of USTs, UST
12 systems, and motor vehicle maintenance, (c) the reporting of business and area plans relating to
13 the handling of hazardous materials and required responses to a release or threatened release of
14 hazardous materials present at Defendants’ facilities in the State of California, and (d) the
15 California Business and Professions Code prohibitions against unfair business practices relating
16 to the Defendants’ ownership and operation of their gasoline station facilities in the State of
17 California. Defendants have answered Plaintiff’s Complaint, denying the allegations. This Final
18 Judgment is not an admission by Defendants regarding any issue of law or fact in the above-
19 captioned action or any violation of law, but Defendants agree to be bound by the terms set forth
20 in this Final Judgment. The People and Defendants now agree to enter into this Final Judgment.

21 3. The provisions of this Final Judgment are applicable to Defendants Phillips 66 Company,
22 a Delaware Corporation and ConocoPhillips Company, a Delaware Corporation; and to each of
23 their respective officers, directors, representatives, successors, assigns, and all persons,
24 partnerships, corporations, and other entities acting under, by, through, on behalf of, or in concert
25 with Defendants with actual or constructive notice or knowledge of this Final Judgment.

26 4. For purposes of this Final Judgment, unless otherwise specified, the definitions set forth in
27 California Health and Safety Code sections 25281 and 25281.5, and Title 23 of the California
28 Code of Regulations, sections 2610 and 2611, as they exist on the date of entry of this Final

1 Judgment, shall apply to the terms used herein. Nothing in this Final Judgment shall excuse
2 Defendants, collectively or individually, from meeting more stringent requirements which may be
3 imposed hereafter by changes in applicable and legally binding legislation, regulations,
4 ordinances or permitting requirements.

5 **INJUNCTION**

6 **Compliance with Statutes, Regulations, and Permits**

7 5. The retail gasoline station facilities that are or were owned or operated by Defendants in
8 the State of California as of October 26, 2006, and the date Defendants sold or divested these
9 facilities are listed on Exhibit A. The facilities listed on Exhibit A are the "Released Facilities."

10 6. Pursuant to California Health and Safety Code sections 25299.01, 25299.04, 25189(c) and
11 25181, and the Unfair Competition Law as set forth in California Business and Professions Code
12 section 17203, Defendants are each enjoined and restrained from failing to comply with any of the
13 following legal requirements at any retail gasoline facility located in the State of California that
14 Defendants may currently own or operate, or in the future may own or operate:

15 (a) The provisions of Chapter 6.5 of Division 20 of the California Health and Safety
16 Code, and its implementing regulations and local regulations under the jurisdiction of the
17 applicable Certified Unified Program Agency (hereafter, "CUPA"), that are applicable to
18 generators of hazardous waste.

19 (b) The provisions of Chapter 6.7 of Division 20 of the California Health and Safety
20 Code, and its implementing regulations and local regulations under the jurisdiction of the
21 applicable CUPA related to the installation, operation, modification, repair or closure of UST
22 systems.

23 (c) The provisions of Chapter 6.95 of Division 20 of the California Health and Safety
24 Code, and its implementing regulations and local regulations under the jurisdiction of the
25 applicable CUPA related to hazardous materials.

26 (d) All related regulations and county ordinances and all county and State of
27 California permits and orders based on those statutes and regulations in addition to those set forth
28 above.

CIVIL PENALTIES

7. Phillips 66 Company, by April 15, 2015, shall pay **NINE MILLION DOLLARS (\$9,000,000.00)** to Plaintiff as civil penalties and the Payment Administrator will distribute it as follows:

(a) **THREE MILLION DOLLARS (\$3,000,000.00)** as civil penalties to the California Attorney General pursuant to section 17203 of the California Business and Professions Code for alleged violations of the Unfair Competition Law, made payable to “The California Department of Justice – Litigation Deposit Fund.” These funds shall be administered by the California Department of Justice, and shall be used by the Environment Section of the Public Rights Division of the Attorney General’s Office. The payment, and any interest derived therefrom, shall solely and exclusively augment the budget of the Attorney General’s Office as it pertains to the Environment Section of the Public Rights Division and in no manner shall supplant or cause any reduction of any portion of the Attorney General’s budget.

(b) **SIX MILLION DOLLARS (\$6,000,000.00)** as civil penalties to the District Attorneys and regulatory agencies as set forth in Exhibits B and C hereto and in the amounts set forth therein, for alleged violations of California statutes and regulations, payable as set forth in Paragraphs 7(b)(i) and (ii) below, made payable to “The California Department of Justice – Attorney General’s Office” as Payment Administrator. Upon receipt of all payments, the Payment Administrator shall promptly disburse those funds to the appropriate offices of the District Attorneys and regulatory agencies in accordance with the schedule of disbursement of payments set forth in Exhibits B and C attached hereto and made part of this Final Judgment by this reference.

(i) **Distribution to Prosecuting Agencies:** Consistent with the provisions of California Business and Professions Code section 17206, the civil penalties assessed in this matter shall be distributed to the agencies identified in Exhibit B in accordance with the disbursement schedule and terms therein. Each disbursement shall be made by the Payment Administrator by separate check made payable to the office of the District Attorney for each County designated for each separate payment as identified in Exhibit B.

1 (ii) **Distribution to Regulatory Agencies:** Consistent with the provisions of
2 California Health and Safety Code section 25299, subdivision (h), the civil penalties assessed in
3 this matter shall be distributed to the agencies identified in Exhibit C in accordance with the
4 disbursement schedule and terms therein. Any funds distributed to an agency identified in
5 Exhibit C shall be contingent upon that agency first identifying a special account and submitting
6 to the Payment Administrator, as identified in Paragraph 10 of this Final Judgment, a declaration
7 by an authorized representative of that agency stating that the funds deposited into that identified
8 special account pursuant to this Final Judgment shall be expended only to fund the administrative
9 activities of that agency in enforcing Chapter 6.7 of the California Health and Safety Code within
10 the agency's administrative jurisdiction pursuant to Chapter 6.11 of the California Health and
11 Safety Code. Each agency receiving civil penalties pursuant to this paragraph shall be served by
12 Plaintiff with a copy of the Final Judgment after it is entered by the Court. In the event an agency
13 identified in Exhibit C does not submit the declaration required by this paragraph within ninety
14 (90) calendar days of the service of the Final Judgment on that agency by Plaintiff, that agency's
15 share of the civil penalties shall be distributed by the Payment Administrator to the State Water
16 Pollution Cleanup and Abatement Account in the State Water Quality Control Fund.

17 **ATTORNEYS' FEES, AND COSTS**

18 8. Phillips 66 Company, by April 15, 2015, shall pay **ONE MILLION, FIVE HUNDRED**
19 **THOUSAND DOLLARS (\$1,500,000.00)** to Plaintiff as costs, attorneys' fees, reimbursements,
20 and restitution and the Payment Administrator will distribute it as follows:

21 (a) **FOUR HUNDRED AND FIFTY THOUSAND DOLLARS (\$450,000.00),**
22 payable to "The California Department of Justice – Attorney General's Office" as reimbursement
23 for partial recovery of investigative costs and attorneys' fees in this matter. This payment of costs
24 and fees shall be used by the California Attorney General's Office until all funds are exhausted,
25 for any of the following purposes: (1) implementation of the Attorney General's authority to
26 protect the environment and natural resources of the State pursuant to Government Code section
27 12600 *et seq.* and as Chief Law Officer of the State of California pursuant to Article V, section 13
28 of the California Constitution; (2) enforcement of laws related to the preservation and protection

1 of public health and the environment from releases of stored hazardous substances including, but
2 not limited to, Chapter 6.7 of Division 20 of the California Health and Safety Code; (3)
3 enforcement of the Unfair Competition Law, Business and Professions Code section 17200, *et*
4 *seq.*, as it relates to protection of the environment and natural resources of the State; and (4) other
5 environmental enforcement actions which benefit the State of California and its citizens as
6 determined by the Attorney General. Such funding may be used for the costs of the Attorney
7 General's investigation, filing fees and other court costs, payment to expert witnesses and
8 technical consultants, purchase of equipment, laboratory analyses, personnel costs, travel costs,
9 and other costs necessary to pursue the investigation, prosecution, or enforcement of
10 environmental actions investigated or initiated by the Attorney General for the benefit of the State
11 of California and its citizens.

12 (b) **FOUR HUNDRED THOUSAND DOLLARS (\$400,000.00)**, payable to
13 "Alameda County District Attorney's Office," as reimbursement for partial recovery of its costs
14 of investigation, of which One Hundred Thousand Dollars (\$100,000.00) shall be used to
15 reimburse the Craig Thompson Environmental Protection Prosecution Fund.

16 (c) **TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000.00)**,
17 payable to "San Bernardino County District Attorney's Office," as reimbursement for partial
18 recovery of its costs of investigation.

19 (d) **ONE HUNDRED AND FIFTY THOUSAND DOLLARS (\$150,000.00)**,
20 payable to "Placer County District Attorney's Office," as reimbursement for partial recovery of
21 its costs of investigation.

22 (e) **TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000.00)**,
23 payable to the "California District Attorneys Association Multi-jurisdiction Circuit Prosecution
24 Program" as reimbursement for partial recovery of its costs of investigation.

25 **SUPPLEMENTAL ENVIRONMENTAL PROJECTS**

26 9. Phillips 66 Company, by April 15, 2015, shall pay **ONE MILLION DOLLARS**
27 **(\$1,000,000.00)** to Plaintiff as restitution and supplemental environmental projects and the
28 Payment Administrator will distribute it as follows:

1 (a) **FOUR HUNDRED AND FIFTY THOUSAND DOLLARS (\$450,000.00)**,
2 payable to the “California District Attorneys Association” to fund: (i) the Environmental Training
3 Project for the purposes of providing training consistent with the objectives of the Environmental
4 Project; (ii) the Rural County Circuit Prosecutor Project for the purpose of providing training,
5 education and assistance to rural California counties consistent with the objectives of the project;
6 and (iii) the California District Attorneys Association Environmental Circuit Prosecutor Project
7 for the purposes consistent with the objectives of the Environmental Circuit Prosecutor Project.

8 (b) **TWO HUNDRED THOUSAND DOLLARS (\$200,000.00)**, payable to the
9 “Craig Thompson Environmental Protection Prosecution Trust Fund” (“EPPF Trust”) to be used
10 for purposes consistent with the mission of the EPPF Trust.

11 (c) **TWO HUNDRED THOUSAND DOLLARS (\$200,000.00)**, payable to the
12 “CUPA Forum Training Fund” to be used to fund scholarships for attendance and participation at
13 the annual CUPA Training Conference. Each of these scholarships shall cover conference
14 registration, transportation, meals and hotel at the training conference rate. Travel and per diem
15 expenses will be reimbursed in accordance with the reimbursement policies of the “California
16 CUPA Forum Board Training Conference Expense Reimbursement Policies” and any subsequent
17 modifications thereto.

18 (d) **ONE HUNDRED THOUSAND DOLLARS (\$100,000.00)**, payable to the
19 “California Hazardous Materials Investigators Association” (“CHMIA”) to be used by CHMIA to
20 fund partial scholarships for attendance and participation at the annual training conference
21 presented by CHMIA.

22 (e) **TWENTY THOUSAND DOLLARS (\$20,000.00)**, payable to “San Bernardino
23 County Fire, Hazardous Materials Division,” to be used once accepted for purchase and
24 distribution of mobile cellular telephones with a camera feature to be available for CUPA
25 inspection staff for the purpose of documenting violation data when conducting hazardous
26 materials field verification and complaint investigations. If the payment is accepted by the
27 designated entity, it shall provide annual letter reports, starting July 1, 2016, until the exhaustion
28 of the funds describing the specific use of the funds and the number of mobile cellular telephones

1 distributed. These funds shall only be used for the purchasing of equipment and not for any
2 monthly or ongoing expenses for such equipment. The reports shall be submitted to the Plaintiff's
3 representatives at the Office of the Attorney General and the District Attorney's Office of San
4 Bernardino County.

5 (f) **TEN THOUSAND DOLLARS (\$10,000.00)**, payable to "California CUPA
6 Forum," to be deposited into the San Bernardino County Restricted Employee account as
7 managed by the California CUPA Forum, to be used once accepted for training San Bernardino
8 County CUPA inspection staff. If the payment is accepted by the designated entity, it shall
9 provide annual letter reports, starting July 1, 2016, until the exhaustion of the funds describing the
10 specific use of the funds. The reports shall be submitted to the Plaintiff's representatives at the
11 Office of the Attorney General and the District Attorney's Office of San Bernardino County.

12 (g) **TWENTY THOUSAND DOLLARS (\$20,000.00)**, payable to "San Bernardino
13 County Fire, Hazardous Materials Division," to be used once accepted for purchase and
14 distribution to San Bernardino County residents of approved portable fuel containers for the safe
15 transportation of household hazardous materials. This program will be run by the Household
16 Hazardous Waste Program operating within the San Bernardino County Fire Department,
17 Hazardous Materials Division. If the payment is accepted by the designated entity, it shall
18 provide annual letter reports, starting July 1, 2016, until the exhaustion of the funds describing the
19 specific use of the funds and the number of portable fuel containers distributed. The reports shall
20 be submitted to the Plaintiff's representatives at the Office of the Attorney General and the
21 District Attorney's Office of San Bernardino County.

22 **PAYMENT ADMINISTRATOR**

23 10. The disbursement of the payment made by Phillips 66 Company to the Plaintiff pursuant
24 to this Final Judgment shall be the responsibility of the Office of the California Attorney General
25 as Payment Administrator.

26 All of the payments imposed upon Phillips 66 Company pursuant to this Final Judgment
27 shall be made by wire transfer and such transfer shall be electronically transmitted to an account

1 and routing number as directed in writing by Plaintiff to Defendants to comply with the terms of
2 the Final Judgment.

3 The Payment Administrator shall be responsible for disbursing the penalties and funds in
4 accordance with the terms of this Final Judgment, and to the entities identified in Paragraphs 7, 8
5 and 9 above and as specified in Exhibits B and C. Phillips 66 Company shall provide copies of
6 all payments made, either by mail or personal delivery, to:

12 **AUTHORITY TO ENTER STIPULATION**

13 11. Each signatory to this Final Judgment certifies that he or she is fully authorized by the
14 party he or she represents to enter into this Final Judgment, to execute it on behalf of the party
15 represented, and to legally bind that party. This Final Judgment may be executed by the Parties in
16 counterparts, and when a copy is signed by an authorized representative of each party, the
17 stipulation shall be effective as if a single document were signed by all Parties.

18 **INTEGRATION**

19 12. This Final Judgment constitutes the entire agreement between the Parties as to the matters
20 addressed herein and shall not be amended or supplemented except upon written order of this
21 Court.

22 **COSTS AND FEES**

23 13. Except where specifically provided in Paragraph 8 above, each party agrees that it shall
24 bear its respective costs, expenses and fees, including attorneys' fees, in connection with this
25 Final Judgment and any related actions.

17 15. Any party may change the individual or the address for purpose of notices to that party by
18 a written notice specifying a new individual or address, but no such change is effective until the
19 written notice is actually received by the party sought to be charged with its contents. All notices
20 or other communications required or permitted under this Final Judgment that are addressed as
21 provided in this Paragraph are effective upon delivery if delivered personally or by overnight
22 mail, or if delivered by certified mail are effective five (5) calendar days following deposit with
23 the United States Postal Service. However, nothing in this Final Judgment shall be interpreted or
24 applied to relieve Defendants of their existing obligations to provide documentation to a local
25 agency or CUPA as required by statute, regulation, or requirement.

26 **NO WAIVER OF RIGHT TO ENFORCE**

27 16. The failure of Plaintiff to enforce any provision of this Final Judgment shall in no way be
28 deemed a waiver of such provision, or in any way affect the validity of this Final Judgment. The
failure of Plaintiff to enforce any such provision shall not preclude Plaintiff from later enforcing
the same or any other provision of this Final Judgment during the period that provision of the
Final Judgment remains in effect. No oral advice, guidance, suggestions or comments by

1 employees or officials of any party regarding matters covered in this Final Judgment shall be
2 construed to relieve any party of its obligations required by this Final Judgment.

3 **CONTINUING JURISDICTION**

4 17. The Court shall retain continuing jurisdiction to enforce the terms of this Final Judgment
5 and to address any other matters arising out of or regarding this Final Judgment. The Parties shall
6 meet and confer at least ten (10) calendar days prior to the filing of any application or motion
7 relating to this Final Judgment, and shall negotiate in good faith in an effort to resolve any dispute
8 without judicial intervention. This “meet and confer” procedure shall not apply to any emergency
9 relief that Plaintiff may seek, in its sole discretion, or to any separate enforcement action, and
10 nothing in this Final Judgment shall limit any rights of the Plaintiff to seek any other relief or
11 remedies provided by law, or the rights of Defendants to defend against any request of Plaintiff
12 for such other relief or remedies. If the Parties are unable to resolve any dispute after meet and
13 confer discussions, either party may move this Court to seek resolution of any such dispute by the
14 Court.

15 **MATTERS RESOLVED BY THIS FINAL JUDGMENT**

16 18. This Final Judgment is a final and binding resolution and settlement as to the Covered
17 Parties and the Covered Matters as defined below. Except for the obligations of Defendants that
18 are expressly set forth in this Final Judgment, Plaintiff hereby covenants not to sue or pursue any
19 further civil claims against the Covered Parties for the Covered Matters. Any claim, violation, or
20 cause of action that is not a Covered Matter is a “Reserved Claim.” Reserved Claims include,
21 without limitation, any violation that occurs after the effective date of this Final Judgment,
22 including any claim, violation, or cause of action directly against Defendants’ independent
23 contractors or subcontractors. Plaintiff reserves the right to pursue any Reserved Claim and
24 Defendants reserve the right to assert any defenses against any Reserved Claim; provided,
25 however, that in any subsequent action that may be brought by Plaintiff to enforce any Reserved
26 Claims, Defendants, collectively or individually, shall not assert, plead or raise against Plaintiff in
27 any fashion any defense or avoidance based on splitting of claims.

28 / / /

1 19. As used herein, "Covered Parties" means Defendants, collectively and individually, and
2 the other persons or entities to whom this Final Judgment is applicable pursuant to Paragraph 3
3 above.

4 20. As used herein, "Covered Matters" means any and all claims, violations or causes of
5 action asserted by Plaintiff based on the allegations that are the subject of the Complaint in this
6 action under Chapters 6.5, 6.7 and 6.95 of Division 20 of the California Health & Safety Code
7 and related regulations (except as provided below) for civil liability against any Defendant as an
8 owner or operator of the Released Facilities for acts, omissions, or events on or pertaining to the
9 Released Facilities during periods of ownership or operation by any Defendant up to the effective
10 date of the Final Judgment entered in this action, including, but not limited to, the installation,
11 operation, modification, repair or removal of a UST or the management of hazardous wastes or
12 materials; and any civil claims under the California Business and Professions Code that are
13 derived from the foregoing up to the Effective Date of the Final Judgment entered in this action.
14 Furthermore, as used herein, "Covered Matters" shall not preclude, on or after the Effective Date
15 of the Final Judgment entered in this action, the issuance of any requirement or order that
16 Defendants shall investigate and/or remediate a release, spill, leak, disposal or discharge, or
17 investigate and remediate a suspected release, spill, leak, disposal or discharge at or from any of
18 the Released Facilities pursuant to the requirements of Chapter 6.7 of the Health and Safety Code;
19 and the Final Judgment entered in this action shall not constrain claims, causes of action,
20 enforcement or corrective action orders that have been or may be filed or issued concerning the
21 investigation and/or remediation of a release, spill, leak, disposal or discharge or suspected
22 release, spill, leak, disposal or discharge of hazardous waste, hazardous material, hazardous
23 substance and/or pollutant or designated contaminant at or from any of the Released Facilities.
24 Furthermore, neither the allegations in Plaintiff's Complaint in this action, nor this Final
25 Judgment, shall constitute notice or discovery by any governmental entity of any release, spill,
26 leak, disposal or discharge or suspected release of any contaminant at any of the Released
27 Facilities, for purposes of statute of limitations claims.
