### FINAL STATEMENT OF REASONS FOR PROPOSED ADOPTION OF THE CALIFORNIA PAWN AND SECONDHAND DEALER SYSTEM (CAPSS) REGULATIONS

### UPDATE OF THE INITIAL STATEMENT OF REASONS

SECTION 2000. The proposed regulation as originally noticed to the public would have defined "Business day" and "Working day." However, in response to a comment from a member of the directly affected public, the Department removed subdivisions (b) and (q), the proposed definitions for "Business day" and "Working day," from section 2000 of the proposed regulations.

SECTION 2002. The proposed regulation as originally noticed to the public would have specified that access to CAPSS would be denied as a result of delinquent renewal fees. However, in response to a comment from a member of the directly affected public, the Department revised this section to stipulate that a 60 calendar day period from a license expiration date would apply prior to CAPSS access being denied in order to allow sufficient time to correct.

SECTION 2006. The proposed regulation as originally noticed to the public would have required that a person advise an intended seller or pledger that the use of the intended seller or pledger's electronic signature and fingerprint on the Property Transaction Report constitutes specified certification. However, in response to a comment from a member of the directly affected public, the Department revised this section to clarify that the requirement is for the secondhand dealer to provide notification to an intended seller or pledger, in order to ensure that the statutory duty to collect the required certification is met.

### LOCAL MANDATE DETERMINATION

The proposed regulations do not impose any mandate on local agencies or school districts.

## SUMMARY AND RESPONSE TO COMMENTS RECEIVED DURING THE INITIAL NOTICE PERIOD OF SEPTEMBER 21, 2018, THROUGH NOVEMBER 9, 2018.
