

California Department of Justice Proposition 69 DNA Data Bank Program Report for Third Quarter 2019

The California Department of Justice (DOJ), Division of Law Enforcement (DLE), Bureau of Forensic Services (BFS) provides DNA typing support to law enforcement agencies throughout the state for the DNA Data Bank. All of the BFS Crime Laboratories and DNA Programs, including the California DNA Data Bank Program (CAL-DNA), are accredited by the ANSI National Accreditation Board (ANAB). Seventeen local crime laboratories and seven BFS Laboratories or sections are participants in the CAL-DNA and the National DNA Index System (NDIS) as part of the Combined DNA Index System (CODIS).

In accordance with the requirements of Penal Code section 295(h)(4), the following statistics have been prepared based on the last quarter for which complete information exists.
