Report of Sales Demonstration Activity INSTRUCTIONS

REQUIREMENTS:

The permit or license holder (permittee) authorized to demonstrate and sell dangerous weapons must maintain records of dangerous weapon sales demonstration activities in California pursuant to California Code of Regulations, title 11, section 4130, subdivision (b). Current records must be maintained on form BOF 025, or a computer generated printout using the same format. (Cal. Code Regs., tit.11, § 4130, subd. (b)(1).) The permittee must make these records available to any peace officer or other persons designated by the Attorney General upon request. (Cal. Code Regs., tit.11, § 4130, subd. (h).)

Permittees authorized to demonstrate and sell dangerous weapons must submit to the Department of Justice (DOJ) an annual report of all sales demonstrations performed with every annual license/permit renewal application submission. The annual report shall be submitted on form BOF 025 or a computer generated printout using the same format as form BOF 025. (Cal. Code Regs., tit.11, § 4130, subd. (b)(2).) The annual report shall be continuous from the prior year's renewal application annual report. The annual report shall include the entry number, date, time, contact name(s) and official rank(s) (e.g. sheriff, chief, captain, lieutenant), agency(ies) name(s), and location. Records shall also include a description of the dangerous weapons(s) demonstrated. The annual report must be submitted to DOJ with the Annual Dangerous Weapons License/Permit(s) Renewal Application, form BOF 031. Or, upon termination of the permit, a final report detailing all remaining unreported activities must be submitted to DOJ.
