#### FEES:

The BOF's initial dangerous weapons license/permit fee (minus the \$32 state and \$17 federal fingerprint fees already paid to obtain electronic fingerprints at an approved Live Scan station), is \$321 for the first license or permit, plus \$22 for each additional license or permit.

While dangerous license permit inspection fees pursuant to Penal Code sections 18910, 31110, 32670, and 33320 do not apply to the initial application, please remain mindful inspection fees are charged with each renewal application at the following rates: 0 to 4 inventory, \$165; 5 to 25 inventory, \$750; 26 or more inventory, \$1500; out-of-state permit holders with no California based location, \$100.


