RE: New Gaming Activity Option

This letter is to announce a new option that will enable gambling establishments to readily change the name of their approved gaming activities without submitting a modification request to the Bureau of Gambling Control (Bureau). Each gaming activity is now assigned a unique reference number that will allow Bureau staff to verify that the activity has been approved for play. The name of the gaming activity can be changed as long as the assigned number is included in any and all promotional materials.

This letter is also intended to resolve any discrepancy in the information provided in your most recent bi-annual report submitted and the Bureau's records regarding games and gaming activities offered for play at your gambling establishment.

**Changing the Name of Gaming Activities:**

Each approval letter will now contain a BGC ID number (GEGA-#####) located above the subject line. Each advertisement must include this number for each gaming activity shown on the advertisement. A footnote will suffice, as long as the number is legible. (See enclosed sample.) The name on the advertisement may differ from the actual approval; however, the play of the gaming activity must comply with all Bureau approved rules for that gaming activity. Any changes to the gaming activity, other than the name, still require that a modification request be submitted.

The BGC ID must also be included in materials sent to the Bureau that refer to the gaming activity, such as bi-annual reports, modification requests, and correspondence.

**Gaming Activities Spreadsheet:**

Enclosed is a spreadsheet that includes a listing of each game or gaming activity approved for play in your gambling establishment and the corresponding BGC ID number. If your spreadsheet includes any games/gaming activities highlighted in red, the Bureau has no record of an approval. It is critical that we reconcile these discrepancies and ensure that the Bureau has all approvals on file.

**To assist us in reconciling these discrepancies, please contact your games analyst by September 10, 2008.**
