**ATTEMPT TO IDENTIFY**

**STALKING/INDECENT EXPOSURE**

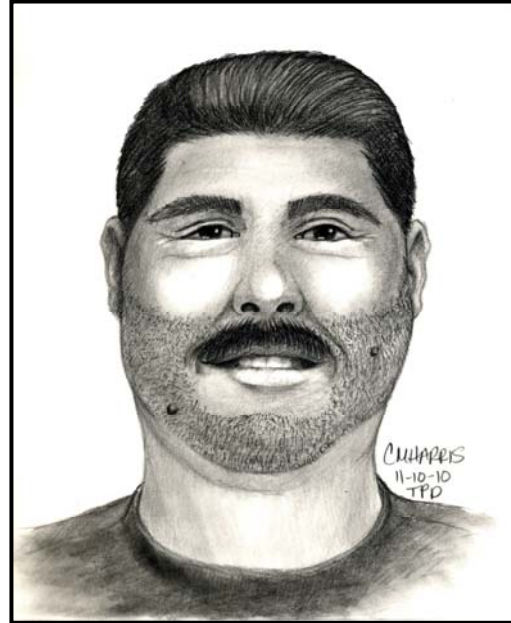
**SUSPECT:** Unknown

**PHYSICAL:** Male, Hispanic, 5'9"/large build "fat belly and double chin", thick straight dark brown/black hair "grown out buzz style," mustache, dark complexion, unshaven, face "gets bigger at bottom," fidgeting and shaking a lot when talking to victim.

**VEHICLE:** Older model 4-door silver/gray sedan

**OUTSTANDING FEATURES:** Two red bumps on either side of face.

**INFORMATION:** Redondo Beach Police Department is requesting information leading to the identification of this suspect. Throughout the day, the suspect has stalked and exposed himself to female juveniles.



**MODUS OPERANDI SUMMARY:** On November 1, 2010, a 14 year-old female (Victim #1) observed the suspect sitting in a vehicle smiling at her as she walked home from school. Victim #1 observed the suspect several times at different locations while she continued to walk home. While walking home from school on November 3, 2010, Victim #1 saw the same suspect sitting in the same vehicle in an alley across from the victim's apartment complex. The suspect asked the victim for directions to the 405 freeway. On November 4, 2010, while returning from school, Victim #1 saw the suspect in the alley behind her apartment building. The suspect asked if the victim knew how to get to the 405 freeway. Victim #1 said no and continued walking away. The suspect then exited his vehicle. The suspect's pants were unzipped, and he was rubbing his exposed penis. The suspect followed Victim #1 through a rear gate into her apartment complex. The suspect entered a laundry room. While still rubbing his penis, the suspect asked the victim to come into the laundry room with him. Victim #1 went to a neighbor's house and the suspect fled the area.

On November 10, 2010, an 11 year-old female (Victim #2) and her mother observed the suspect driving slowly back and forth outside their residence while they stood on the sidewalk. The suspect never parked his vehicle. On November 11, 2010, the same suspect, in the same vehicle was seen by Victim #2 while the victim stood outside her residence. The suspect stopped his vehicle and rolled down the driver's side window. Victim #2 fled. The suspect may have begun to exit the vehicle.

Based on the MO, vehicle, and driver description, the suspect might be the same man.
