

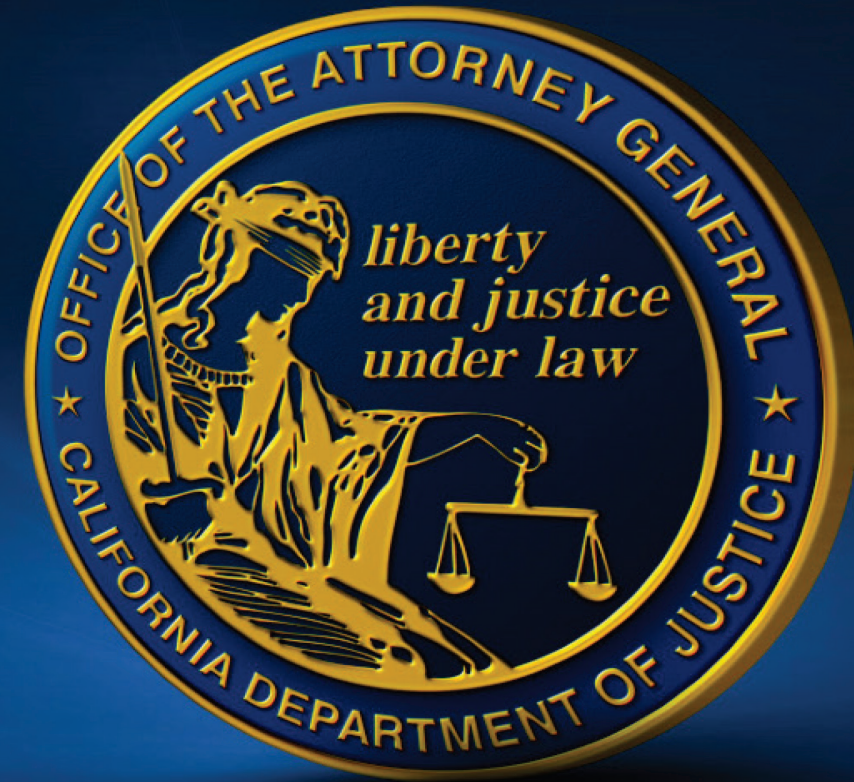

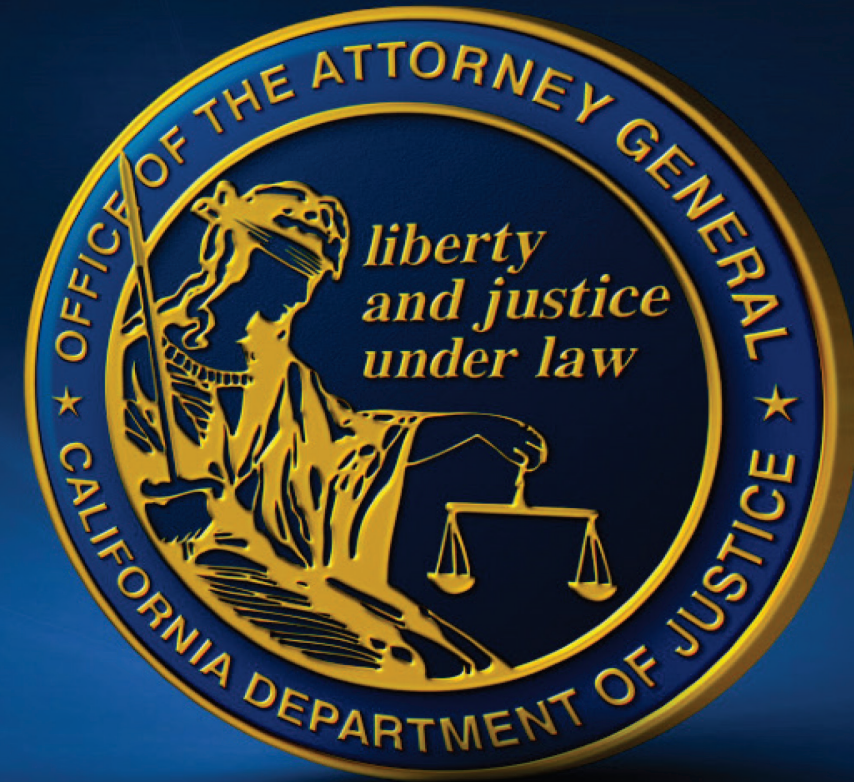
# Senate Bill (SB) 54 – California Values Act

## Senate Bill 54 Summary:

Existing law provides that when there is reason to believe that a person arrested for specified violations may not be a citizen of the United States, the arresting agency shall notify the appropriate agency of the United States having charge of deportation matters.

This bill repealed those provisions.

This bill would, among other things and subject to exceptions, prohibit state and local law enforcement agencies from using money or personnel to investigate, interrogate, detain, detect, or arrest persons for immigration enforcement purposes, as specified, and would, subject to exceptions, proscribe other activities or conduct in connection with immigration enforcement by law enforcement agencies





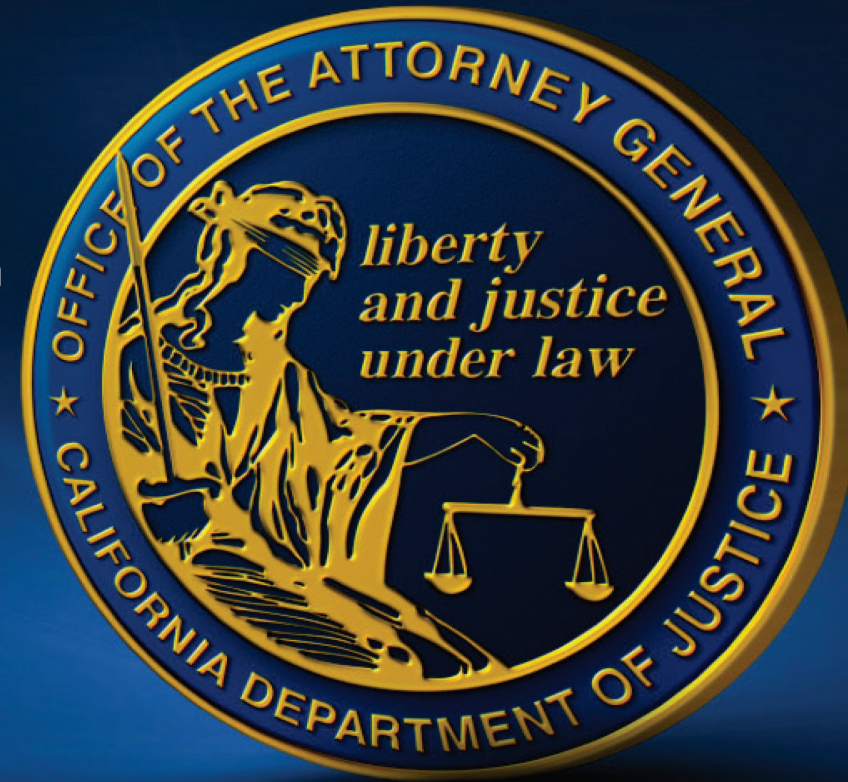
# Senate Bill (SB) 54 – California Values Act

## Required Documentation for CLETS Subscriber Agencies:

1. CLETS Subscriber Agreement (2/19) (HDC 0001)
2. CLETS Policies, Practices, and Procedures Acknowledgement Form

## Overview of changes to the Policies, Practices, and Procedures:

- ▶ 1.6.1.D and 1.6.1.E.2.f – Database restrictions which prohibit law enforcement agencies from using system for immigration enforcement purposes.
- ▶ 1.9.5 and 1.10.1.A – Recommendation language for Misuse Statements as it relates to prohibited usage of CLETS and example added to list of prohibited/unauthorized use of CLETS.

# Senate Bill (SB) 54 – California Values Act

## **CLETS Administrative Section action on SB 54:**

1. February 2019 an email, administrative message, and a bulletin on CLEW were sent listing information and required action on SB 54 for CLETS Subscribing Agencies

## **Statistics of Required Documentation Submission:**

1. 99% of CLETS Subscribing Agencies have submitted the required documentation.
2. 8 Agencies have not submitted documents as of this date. (6/24)

## **Potential Discontinuation of CLETS Service:**

- ▶ Per the communication sent on April 12, 2019 any agency that has not submitted the required documentation by End of Business on July 31, 2019 will have their access to CLETS Terminated.
