WALK WARRANT

The Undersigned, being sworn says, on Information and belief, that CONCEPCION GIRON did, in the County of Alameda, State of California, on or about August 10, 2008, commit a Felony, to wit: KIDNAPPING TO COMMIT ANOTHER CRIME, a violation of section 209(b)(1) of the PENAL CODE of California, in that said defendant did unlawfully kidnap and carry away Carnell Williams, an 85 year old woman with dementia, to commit elder financial abuse, i.e. to take her pension and social security checks,

VIOLENT CRIME ON THE VULNERABLE CLAUSE AS TO DEFENDANT PINCO GIRON

It is further alleged as to count one, that the defendant CONCEPCION CONNIE PINCO GIRON, is in violation of Penal Code section 667.9(a) in that the victim in the above offense, CARNELL WILLIAMS, was an 85 year old woman with Alzheimer's dementia and said disability and condition was known and reasonably should have been known to the defendant.

OFFENSES IN 2 JURISDICTIONS CLAUSE AS TO DEFENDANT GIRON

It is further alleged pursuant to Penal Code Section 781 that the above offense was committed in part in the County of Alameda and in part in Contra Costa County

SECOND COUNT

The Undersigned further deposes and says on Information and belief, that said CONCEPCION GIRON did, in the County of Alameda, State of California, between September 10, 2008 and August 31, 2009, commit a Felony, to wit: FALSE IMPRISONMENT - ELDER, DEPENDENT ADULT, a violation of section 368(f) of the PENAL CODE of California, in that said defendant did commit false imprisonment of CARNELL WILLIAMS, an elder and dependent adult, by use of violence, menace, fraud and deceit.

OFFENSES/ACTS/EFFECTS IN 2 JURISDICTIONS CLAUSE AS TO DEFENDANT GIRON

It is further alleged pursuant to Penal Code Section 781 that the above offense was committed in part in the County of Alameda and in part in Contra Costa County and that acts and effects thereof constituting and requisite to the consummation of the said offense occurred in those counties.

FIFTH COUNT

The Undersigned further deposes and says on Information and belief, that said CONCEPCION GIRON did, in the County of Alameda, State of California, between August 8, 2008 and May 1, 2009, commit a Felony, to wit: THEFT FROM ELDER OR DEPENDENT ADULT BY A CARETAKER, a violation of section 368(e) of the PENAL CODE of California, in that said defendant being a caretaker, committed theft and embezzlement with respect to the property of an elder and dependent adult, said property having a value exceeding \$950.00, and knew and reasonably should have known that said person, Lottie McDonald, born in 1911, was an elder and dependent adult.


EIGHTH COUNT





DECLARATION IN SUPPORT OF PROBABLE CAUSE

THE UNDERSIGNED HEREBY DECLARES:

1. That he is a PEACE OFFICER of the California Department of Justice, Pleasanton, California.
2. That the contents of this declaration provides probable cause to believe the above-named defendant committed the following offenses:
 - a.) One count of Penal code § 209(b)(1)
 - b.) One Count of Penal code § 368(f)
 - c.) Six counts of Penal code § 368(e)


3. I declare under information and belief that the following is true and correct:
Defendant Concepcion Giron was the Assistant Administrator at Elmwood Nursing and Rehabilitation Center in Berkeley, California. In 2008 she opened bank accounts for several patients thru Citibank. She also ordered ATM/debit cards for the accounts. Over the next year she transferred money from the accounts into her own bank account, wrote checks to herself from the elders accounts, used the ATM cards, and wrote checks to petty cash from the elders accounts which she then cashed and took the proceeds. Defendant also took money from the patients' trust accounts maintained by the Center.

Defendant also convinced the son of a Victim Polk, a 77 year-old woman needing full-time nursing care, that he needed to make monthly payments of approximately \$600 cash to keep his mother in the care facility. Defendant, over a one and one-half year period, pocketed the cash payments.

In September 2008, Defendant took an 85 year-old woman with Alzheimer's dementia out of the facility and moved her into the defendant's own home. The victim, Carnell Williams, was supposed to have been taken to a licensed Board and Care. Defendant lied to friends and employees about taking Ms Williams. Defendant then used the victim's monthly pension and social security checks to pay her own bills. A friend of the victim finally moved the victim into a licensed facility.

The total loss for all of the above exceeds \$50,000.

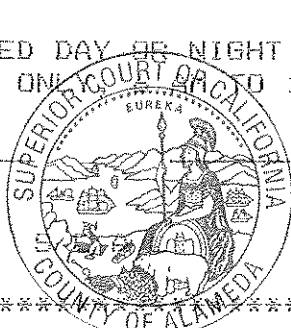
