**SECOND NOTICE OF MODIFICATIONS TO TEXT OF PROPOSED REGULATIONS**

Notice published December 5, 2025

Pursuant to the requirements of Government Code section 11346.8, subdivision (c), and section 44 of Title 1 of the California Code of Regulations, the Department of Justice (Department) is providing notice of changes made to proposed regulations sections 999.300–999.314 of Title 11, Division 1, Chapter 20 of the California Code of Regulations (formerly numbered as section 941 through 954 of Title 11, Division 1, Chapter 11). These proposed regulations were the subject of a Notice of Proposed Rulemaking published in the California Register (Register 2025, No. 4 Z) on January 24, 2025, as Notice File Number Z-2025-0114-02 and the subject of public hearings on March 12 and March 14, 2025. The Department reviewed all comments received during the 45-day public comment period. In response to the public comments, and to clarify the regulations as originally proposed, on June 23, 2025, the Department posted on its website notice of modifications to the regulations. Public comments on the first set of modified regulations were accepted until July 9, 2025.

These recent modifications are in response to comments received during the first 15-day notice period regarding the proposed regulations, as well as comments received from the Office of Administrative Law, and for clarification purposes. A copy of the proposed changes are attached to this notice.

Changes made after the 45-day comment period are illustrated by double underline red font for proposed additions and ~~double strikethrough light green font~~ for proposed deletions. Changes made after the first 15-day comment period are illustrated by bold underline purple font for additions and ~~bold strikethrough orange font~~ for proposed deletions.

If you have any comments regarding the proposed changes, the Department will accept written comments between December 5, 2025, and December 22, 2025. All written comments must be submitted to the Department no later than 5:00 p.m. on December 22, 2025, and addressed to:
