Ace's Cracked Promotion

Bureau Advertisement Requirements

The Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID listed in the approval letter shall be referenced on all advertisements relating to the Aces Cracked Jackpot.

Furthermore, all rules and procedures for this jackpot, including but not limited to the following, shall be displayed conspicuously and prominently in the Casino at all times the gaming activity is being offered:

Controlled Game

The Aces Cracked Jackpot shall be attached to the following approved games offered at the Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

Texas Hold'em (GEGA-002127)

Rules of Play

The Aces Cracked Jackpot features a fixed jackpot element attached to the game of Texas Hold'em. A prize is awarded to players participating in a jackpot game when a hand containing a pocket pair of Aces is beaten by a better hand at the showdown.

Prize

A player that receives the qualifying losing hand will receive a fixed cash amount ranging from \$25 to \$1,000. Patrons shall be given ample notice of the prize amount.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- There is no minimum or maximum number of players required to be dealt in during a
 qualifying game in order for players to be eligible and the table to qualify for the
 jackpot.
- When a qualifying hand is announced, a floor person will verify that both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- In order to qualify for the jackpot, the player dealt the qualifying losing hand must use both hole cards.
- In order to qualify for the Aces Cracked Jackpot the pot must contain at least a minimum of \$20.
- In order to qualify for the jackpot, the player must complete play on all four rounds of the hand, which includes the pre-flop, the flop, the turn, and the river, and not fold their hand.

Ace's Cracked Promotion

- In order to qualify for the jackpot, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.

All fee collections and table limits are for the designated base games and are Bureau approved, pre-determined and posted at each table.

Administrative Fees

The Casino shall not retain an administrative fee other than what is already collected for the Mega Poker Progressive Jackpot (GEGA-003987).

No Purchase Necessary Table Requirement

The Aces Cracked Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the jackpot without paying a table fee or placing a live wager.

When a player presents a AG coupon to play a particular hand in a Pure 21.5 Blackjack, Pai Gow Tiles and Double Hand Poker game, and they win that particular hand, they will be awarded that amount of money (in casino chips). The coupons will be offered to all patrons that wish to come into the Casino and use them to play. The coupons will be advertised in magazines, websites, and mailing advertisements that go out to our customers, etc. When a patron receives a coupon they may use it in any of the controlled games listed above. Each coupon will state the specific qualifying game(s) that the coupon may be used on.

The AG coupon will be offered in the following two different ways:

LUCKY BUCK

A player will have a pre-printed coupon with a dollar amount assigned to it ranging from \$5 to \$1,000. The player will simply place this coupon on an Asian games table and that will represent the amount that they are wagering on that particular hand. If a player has more than one AG coupon they can only use one per wager.

EXAMPLE: A person receives a Lucky Buck coupon with a value of \$5.00 that specifically states it may be used to place a wager on the Pure 21.5 Blackjack table. The player would place the coupon on the gaming table and pay the posted collection for a single hand of play. If the player wins the hand, he/she will receive \$5.00 just as if they had placed a \$5.00 bet and the player/dealer will collect the coupon. The Player/Dealer must then have a floor person sign the coupon verifying that it has been won. All winning verified and signed coupons may then be taken to the cage and cashed out for the value listed on the coupon. All losing coupons will not have the option. If the player loses, the coupon is forfeited; the money part of the wager is collected by the player/dealer, and the coupon will be collected by the casino dealer. If the player pushes (receives no action), the coupon may be played again until the player wins or loses a hand.

MATCH PLAY

A player will have a pre-printed coupon with a dollar amount assigned to it ranging from \$5 to \$1,000. The player must wager a matching amount to what is listed on the AG coupon. If a player has more than one AG coupon they can only use one per wager. For example, if a player has an AG coupon with a \$10 amount printed on it they would place that on an Asian games table with a \$10 casino chip for a total bet of \$20. If a player wins that hand, the AG coupon will be taken and they will be awarded \$20 in casino chips.

EXAMPLE: A person receives a match play coupon with a value of \$5.00 that specifically states it may be used to place a wager on the Pure 21.5 Blackjack table. The person would place the coupon on the gaming table with a \$5.00 casino chip for a total bet of \$10, and pay the posted collection for a single hand of play. If the player wins the hand, he/she will receive \$10.00 just as if they had placed a \$10.00 bet and the player/dealer will collect the coupon. The player/dealer must then have a floor person sign the coupon verifying that it has been won. All winning verified and signed coupons may then be taken to the cage and cashed out for the value listed on the coupon. All losing coupons will not have the option. If the player loses, the coupon is forfeited; the money part of the wager is collected by the player/dealer, and the coupon will be collected by the casino dealer. If the player pushes (receives no action), the coupon may be played again until the player wins or loses a hand.

SUMMARY

Based on customer demand and industry trends, Banker's Casino (BC) proposes to add a bad-beat jackpot gaming activity for Texas Hold'em, Omaha, Seven Card Stud, Lowball and Draw Poker games. The promotion will be a bad-beat progressive jackpot.

PRIZE

The prize will be a progressive cash amount, with the minimum amount of \$1,000.00. Since this is a player funded jackpot, BC will initially seed the jackpot fund and reserve. Once the amount has reached \$10,000.00, BC will be reimbursed for th initial seed monies. The prize pool will be awarded if a specific qualifying hand is beaten by a better hand.

QUALIFYING HAND(S)

The minimum qualifying hand to be beaten is a pre-determined Full House. Both hole cards must play for the losing and winning hands.

FUNDING

This promotion will be funded by players participating in the listed poker games. A \$.50 or \$1.00 collection will be taken from the poker pot during the play of a designated poker game at BC. The collection will be dropped into a locked box that is separate from the casino collection box. The jackpot collection box will be segregated at all times from the casino collection and will be accounted separately.

NO PURCHASE NECESSARY

Any person who wishes to participate in this promotion for free, on a "no purchase necessary" (NPN) basis may do so by being at the NPN poker table at the specified time as in the live game. The NPN player must adhere to all rules as the live player.

Object and Summary

- The player occupying the player-dealer position for each round is not eligible to place the optional jackpot fee of \$1 or win a prize.

In all instances, patrons shall be provided with ample advance notice of the amount of time that a player must play in order to be eligible for the "Player's Menu." Furthermore, the time requirements and "Player's Menu" shall be displayed prominently within the BC at all times this gaming activity is being offered for play.

PRIZE

The prize will be allowing a player to eat a menu item for free/or at a substantially discounted rate from a selected "Player's Menu." The menu will consist of item(s) selected by the gambling establishment and cannot be changed or altered. The offering may include non-alcoholic drinks as well. For players that complete the time requirement, items on the "Player's Menu" with a value of \$1 - \$25 will be for free and items on the menu with a value of \$5 - \$50 will be offered at a discounted price.

FUNDING

- 1. To begin each round, players must make their regular base game wager. They may place any bonus bets along with the optional jackpot fee of \$1. A minimum of two players are required for the progressive jackpot or a fixed prize payout.

Each day a portion of the jackpot collection between \$25 and \$500 will be added to the reserve jackpot prize pool, not the progressive jackpot prize pool. Whenever the Casino is required to seed the jackpot or cover a shortfall due to inadequate funds, the Casino shall be repaid from the reserve account once the reserve is sufficient and funds become available. The jackpot collection fees shall be kept in separate drop boxes apart from the regular table collection fees.

Administrative Fees

The Banker's Casino shall retain an administrative fee of \$3 to \$10 per hour as explained in the Bad Beat Jackpot (GEGA-002139). The administrative fee shall be used for marketing and operation costs in the administration of the poker jackpot.

No Purchase Necessary

The Mini Poker Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Mini Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Player Rewards Program

Bureau Requirements

Advertising

The Bankers Casino may advertise various names for this gaming activity. Should the Bankers Casino advertise a different name, the BGC ID (GEGA-004550) shall be referenced on all advertisements relating to the Player Rewards Program gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in The Bankers Casino at all times the gaming activity is being offered:

- Corresponding time played and Player Rewards Points amount.
- The date(s) and time(s) the gaming activity shall be offered.
- How the number of points earned corresponds to the amount in prize value.
- The possible prize(s) offered for meeting the requirements of the gaming activity.
- The possible bonus rates offered on play during off-peak hours or in specific games.
- The redemption period will be displayed in the Bankers Casino to give players ample notice.
- Any other applicable restrictions.

Eligible Controlled Games

The Player Rewards Program gaming activity shall be attached to all Bureau approved California and Poker controlled games offered at The Bankers Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Player Rewards Program features a promotional element attached to all poker games offered at the Bankers Casino. This gaming activity is a loyalty reward program open to all Bankers Casino patrons. This promotion will reward players with points based on time of play at eligible games during pre-determined and eligible periods.

How Player Points are Earned Based on Time Played

Points shall be earned based on the amount of time played. Each player that plays a Bureau approved game shall have their Player's Club Card scanned and their hours played shall be tracked. The player will receive points that will gain them eligibility to win a pre-determined and designated prize(s). Players shall earn a pre-determined and posted amount of Player Rewards points ranging between 1 and 100 points for each hour of play. Prior to the promotional period a sign(s) will state how many points will be earned per hour and any other details and/or restrictions. The Bankers Casino may offer bonus rates, for example double points, on play during off-peak hours or in specific games as long as its within the specified range. Patrons will be given ample notice of how many points will be awarded as well as the amount of time or number of hands required to earn points for each eligible controlled game.

How Player Points are Redeemed

Players may either redeem their Player Rewards Points at any time during the promotion or at the end of the promotional period. All prizes shall have a pre-determined and designated value. One to twenty points earned on a Player's Club Card shall be worth a prize value of \$1.

Player Rewards Program

- After a player has accumulated a pre-determined and specific amount of points, based on time of play, a player may redeem the accrued points for a pre-determined and designated prize.

The Player's Club Card shall include the player's name, bar-code, and player number unique to each player.

- The card shall be non-transferable, and revocable at management's discretion.
- Player's can sign up for a Player's Club Card free of charge. Lost or damaged cards shall also be replaced free of charge.
- At the end of the posted promotional period, Player's rewards points will reset back to zero.
- Player's time played is tracked by having the dealer scan their Player's Club Card at the table. They will receive a player's card once they sign up for the Player Rewards Program at the cashier. A TableCaptain tablet is installed at each poker table, with a bar code reader, where the dealer will scan the player's card. Once the card has been scanned, the player's information will show up on the tablet screen and the player's playing session will start. If the scanner is down, the player will be manually entered into the TableCaptain system by the dealer at the table. If the computer system is temporarily down, player's time shall be manually tracked on a log sheet by a casino floor person. Once the system is working, a Bankers Casino Manager will enter the player's hours into the TableCaptain system.
- Player's will be put in "Sit Out" mode, by the dealer, when they receive a Missed Blind button due to being away from the table. Once the player has returned, posted all applicable blinds to resume play, his time will resume being tracked.
- At least once every thirty minutes, a Bankers Casino dealer will verify that all players who wish to participate in the Rewards Program are logged into the table and being tracked via the TableCaptain tablet.
- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management.
- Only the network administrator(s) has access to the back-end systems where the
 data is stored. Access to the data is by user level with multiple levels based on what
 the user will be doing. Managers can edit time (i.e. if the player forgot to have their
 card swiped and need time added), floor persons can log players into the system if
 the player forgot their card.
- All data is backed up on a hard drive located at the gambling establishment.

Player Rewards Program

 A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available anytime at their request.

Eligibility Requirements

This gaming activity shall be open to all players 21 years of age and older with valid I.D. who sign up for Player Reward Points and participate in an eligible game for a designated period of time to earn points. When the player chooses to exchange their accrued points, they shall win a corresponding prize.

- Players must be seated and playing at a designated table in order to qualify for the promotion.
- In order for the table to qualify for the promotion, there must be one or more players, in addition to the player-dealer, for all California games and two or more players for all Poker games.

All fee collections and table limits are for the designated base game and are Bureau approved, pre-determined and posted at each table

Administrative Fees

The Casino shall not retain an administration fee for this gaming activity.

No Purchase Necessary

The Player Rewards Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this promotion.

The Banker's Casino may advertise various names for this gaming activity. Should the Banker's Casino advertise a different name, the BGC ID listed above shall be referenced on all advertisements relating to the Poker Tournaments.

Furthermore, all rules and procedures for Poker Tournaments, including but not limited to the following, shall be prominently displayed in the Banker's Casino at all times that a Poker Tournament is offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Banker's Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- Any other restrictions that apply to the Poker Tournament.
- \$5 shall be withheld from the buy-ins to fund for free roll tournaments.

Controlled Games

The tournament games that may be played during Poker Tournaments at the Banker's Casino shall only be those as listed below.

- Texas Hold'em
- Seven Card Stud
- Omaha
- Draw Poker
- Lowball

All controlled game rules shall be played as previously approved by the Bureau.

Gaming Activities Offered During Tournament Play

Bounties

- If player X knocks an advertised bounty player out of the tournament, then player X shall receive the posted bounty prize amount.
- The bounty prize amount will be \$0 \$10,000.
- Bounties shall either be deducted from the total of the buy-ins, rebuys, and addons, or be house funded.
- The method of funding shall be displayed prior to the start of the tournament.
- The bounty prize shall either be paid during the tournament, or as soon as tournament play ends.

Players participating in pre-designated games may request a "punch card" (or other suitable recording form) and play for the prize displayed on that card. When a player

with a punch card attains any of the gaming occurrences listed on the card, their card is "punched". When all punches are completed, the player wins the displayed prize (see example A).

The Banker's Casino will list the hand qualifications for each game, as well as the prize for each punch card, before commencement of the promotion.

The punch card has no expiration date, but is subject to the cancellation of the promotion at any time.

The punch card will be non-transferable, and a player will need to show proper identification before being assigned a card. The punch card will have the first and last name of the player displayed on it.

There are no restrictions on the number of players required to be playing in a Poker and/or California game in order for players to be eligible to participate.

Players must claim their prize within 24 hours from completion of their punch card. If a player does not claim their prize within 24 hours of the completion of their punch card, the punch card shall expire and the player shall not be able to redeem their punch card for the corresponding prize.



Rules of Play

Players that receive the qualifying hand of a Royal Flush, during a pre-determined and posted time period, will win a pre-determined and posted prize ranging in value of \$1 to \$50,000.

Qualifying Hands

The qualifying hand will be a Royal Flush with both hole cards used in the five-card hand.

Prize

The Royal Flush Bonus prize is progressive with a minimum value of \$1 and a maximum amount of \$50,000 for each suit. The Royal Flush bonus shall be paid in the form of casino chips. The bonus casino chips for each suit will be on display in a locked, clear, plastic box that is visible on the gaming floor.

Royal Flush Bonus Promotion

Eligibility

The gaming activity shall be open to all players who are seated and playing at any poker table during the pre-determined and specified hours designated for this gaming activity.

- Players must be seated and playing at a designated table in order to qualify for the promotion.
- Players must be present to win a prize.
- Players have up to 5 minutes to present a valid ID and claim their prize.
- A minimum of four players must be dealt into the hand in order for the hand to qualify for the Royal Flush bonus and a jackpot dollar to be dropped.
- A minimum of ten (\$10) dollars must be in the pot in order for the hand to qualify for the Royal Flush bonus and a Bad Beat jackpot fee (GEGA-002139) to be dropped.

The actual progressive bonus amount shall depend on the amount the bonus was originally seeded at, as well as how many days have transpired in order for the posted bonus to increase progressively each day by a range of \$20 to \$100. When the Royal Flush of one suit is hit, the amount in the box will be paid out and the box will be replenished with a minimum of \$50. The Casino will cover any shortfall when applicable.

The Casino will provide no purchase necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Bankers Casino at all times the gaming activity is being offered for play:

- Eligible time periods.
- Qualifying hands.
- Eligible games.
- · Amounts and/or prizes that may be won.
- Availability of No Purchase Necessary.
- Funding from the Mega Poker Progressive Jackpot (GEGA-003987) reserve fund.
- Any other restrictions that apply to this gaming activity.

Eliqible Controlled Games

The Spin for a Win gaming activity shall be attached to the following Bureau approved controlled games offered at Bankers Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-002127)
- Mexican Poker (GEGA-003513)
- Omaha (GEGA-002128)

Object and Summary

The Spin for a Win Promotion gaming activity awards players who make a specified qualifying hand in an eligible controlled game or are selected via a random drawing with a chance to spin the wheel and win a prize. Players who are seated and playing any of the controlled games listed above are eligible for this gaming activity.

- The wheel is separated into 38 separate sections with each depicting a specific prize.
- Between each section is a metal peg. A ping-pong ball is secured behind a clear surface affixed to the wheel, which rests between two pegs at any given time. When the wheel is spun, the ball bounces until it settles between two pegs. This indicates which prize is to be awarded.
- The wheel must complete one full rotation and come to a complete stop before a determination is made as to the prize. The ping-pong ball must rest between two pegs before the prize can be determined. If the ball lands between two sections, the patron must spin again until a valid spin is achieved.
- In all instances, patrons shall be provided ample notice of opportunities to spin the wheel, possible prize amounts, and the predetermined promotional period.
- All procedures, eligible times, qualifying hands, multipliers, and prize amounts will be prominently posted in the Casino via flyers, digital display, and other advertisements at all times.

Qualifying Hands

- Option 1 Be an active player at a table of an above listed controlled game and have the player's seat selected via random drawing at a predetermined selection time. During predetermined times of the promotional period, a casino employee will announce the commencement of the drawing. The drawing to determine the lucky seat uses cards, balls, or lamers, which are pre-printed, equally sized and colored. For the lucky table drawing, a card, ball, or lamer that represents each active table will be mixed with a non-electronic randomizer. A casino employee will then select one card, ball, or lamer to determine the winning table. Once the eligible table is determined, the lucky seat will be determined by placing cards, balls, or lamers into the randomizer and selecting one. The number of seats at the winning table determines the amount of cards, balls, or lamers that will be placed into the randomizer. If an unoccupied seat is selected, another card, ball, or lamer will be drawn until a winner is chosen.
- Option 2 Make and win with the minimum qualifying hand in any of the controlled games listed below.

Full house*	Full house	4 of a Kind

^{*}Both of the player's hole cards must be used to make the hand. Mexican Poker and Omaha have no hole card requirement.

• Option 3 – Make and lose with any of the minimum qualifying hands in any of the controlled games listed below. In the event two players qualify with a losing hand, both will be given the opportunity to spin the wheel and win a prize individually.

^{*}Both of the player's hole cards must be used to make the hand. Mexican Poker and Omaha have no hole card requirement.

Only one option listed above may be offered at any one time. Patrons will be given ample notice of the specific option that is being offered, and it will be displayed prominently via printed flyers, digital display, or any other form of advertisements.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- The wheel must spin a minimum of one full rotation in order for a spin to be valid. If the
 wheel does not complete one full rotation, the player will be asked to spin again.
- Once the spin begins, no one shall interfere with the rotation of the wheel. Any
 interference with the rotation of the wheel shall invalidate the spin and the player will be
 asked to spin again.
- A minimum of four players must be playing at an eligible table in order for the hand to qualify.
- To qualify for an opportunity to spin the wheel in Option 2, the player is required to win the hand.

Spin for a Win

- There is no limit on the number of times patrons are eligible to spin for and receive a prize in any given promotional period.
- Tournament games do not qualify for this gaming activity.
- Casino employees are eligible to participate when off duty and out of uniform.

Prize

If there is not enough funding in the reserve account, the casino will cover any shortfall. In the event the Casino is required to cover any shortfall, they will be reimbursed from the reserve fund once there are sufficient funds.

Administrative Fees

Bankers Casino shall not retain any administrative fee for the Spin for a Win Promotion gaming activity.

No Purchase Necessary

The Spin for a Win Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Spin for a Win Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

Equipment

The Spin for a Win Promotion gaming activity features a wheel separated into 38 separate sections with each section depicting a specific prize. Between each section is a metal peg. A ping-pong ball is secured behind a clear surface affixed to the wheel, which rests between two pegs at any given time. When the wheel is spun, the ball bounces until it settles between two pegs. This indicates which prize is to be awarded.

Splash the Pot

Advertising Requirements:

Banker's may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (**GEGA-004201**) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Banker's at all times that the gaming activity is being offered for play:

- Eligible games.
- Eligible time period(s).
- Availability of No Purchase Necessary.
- Procedures for "Splashing the Pot"
- Amount to be added to the pot (prize amount).
- Any other restrictions that apply to this gaming activity.

Controlled Game:

The Splash the Pot promotion shall be attached to all limits and versions of all currently approved Poker games offered at Banker's.

All base game rules shall be played as previously approved by the Bureau of Gambling Control.

Rules of Play:

The Splash the Pot gaming activity features a promotional element which shall be attached to the approved poker games at the Casino. During pre-determined times and intervals of the promotional period, a casino employee shall "Splash the Pot" by adding a pre-determined and posted prize to the pot at the start of the next hand. Betting procedures and play shall proceed as a normal round of play would. The player with the winning hand shall win the pot, including the added prize amount. In the event of a tie, the winning players shall split the pot evenly.

The method for determining which table will receive the posted "Splash the Pot" prize involves a set of ping pong balls that have designated table numbers. During pre-determined times and intervals of the promotional period, a casino employee shall announce the commencement of the drawing. The casino employee shall then select an eligible table by randomly choosing a ping pong ball from a bowl. Each ball shall depict a number that corresponds to each eligible poker table. The balls, which are equally sized and colored, shall be mixed, then one shall be selected. Once the table number is determined, the employee shall place the pre-determined and posted prize into the pot on the table, at the start of the next hand. Betting procedures and play shall proceed as a normal round of play would. The player with the winning hand shall win the pot, including the added prize amount. In the event of a tie, the winning players shall split the pot evenly.

Prize Amount:

When a table is selected, the prize amount shall be added to the pot of that table. The prize shall be a fixed amount ranging from \$10 to \$1,000 in the form of casino chips or merchandise equaling the same amount such as gift cards, electronics, tournament entries and clothing. The prize will be awarded to the player winning the hand immediately following the funds being delivered to the table. The qualifying times will be pre-determined posted times throughout the day. All prizes for this promotion shall be pre-determined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

Splash the Pot

Eligibility:

The promotion shall be open to all players who are seated and playing at a poker table during the pre-determined and specified times designated for this promotion.

- A player is eligible to win this promotion by winning the round of poker at the table number that is designated by the drawing.
- The round of play will continue until a winner is determined.
- In the event that two or more players tie a winning hand, the pot shall be evenly distributed between each tying player and if the prize is a non-cash prize, it will be doubled, and each player shall receive a prize of equal value.
- There is no minimum or maximum number of players required to be playing in for the table to be eligible other than the same as required to participate in the base game.
- Casino employees are eligible to participate in the promotion while off duty and out of uniform.
- A player returning to the table from a break is eligible for the promotion.
- Players and tables receiving this promotion shall still be eligible for other promotions.
- Tournament games do not qualify for the splash the pot promotion.
- All procedures, times and prize amounts shall be displayed prominently on the gaming floor and via any form of advertisement that the Casino wishes to use, including but not limited to printed flyers, digital display, the Casino's website, or any other form of advertisement.
- No new players may sit at the table after the table # has been selected for the pot to be splashed.

Funding:

The Splash the Pot gaming activity shall be funded from the reserve account of a previously approved player-funded jackpot. The Activity will be funded out of the reserve account of the Mega Poker Progressive Jackpot (GEGA-003987).

Administrative Fees:

There will be no administrative fees attached to the Splash the Pot promotion.

No Purchase Necessary:

All persons wishing to participate on a No Purchase Necessary (NPN) basis will be accommodated by asking a Casino Floor Manager for a NPN table to be set up. This will be accomplished within a reasonable period of time and the participant will be dealt hands as if it is in a live game. All opportunities to win the promotion will be provided to a person participating at an NPN table in the same procedure and manner as that of a live game. No cash, collection, or Casino gaming chips will be used at the NPN table. The Casino dealer or floor manager will play the hands of the unoccupied seats to simulate a full game.

Bonus Chip Promotion

Bureau Requirements

Advertising

The Banker's Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001334) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Banker's Casino at all times the gaming activity is being offered for play:

- Eligible games
- Time period when Bonus Chips may be obtained
- Time period when Bonus Chips may be used
- Buy-in amount for Bonus Chips
- Amount of Bonus Chips to be awarded
- Procedures to redeem Bonus Chips
- Any other applicable restrictions and/or information

Eligible Controlled Games

The Bonus Chip Promotion shall be attached to all Bureau approved California games offered at Banker's Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Bonus Chip Promotion will be open to all players who buy-in to a pre-determined and posted game, for a pre-determined and posted amount ranging from \$10 and \$100,000. Those players will receive standard live casino chips in the amount of their buy-in and will also receive a pre-determined and posted amount of Bonus Chips ranging from \$10 and \$10,000, which are to be used to place wagers on pre-determined and posted games.

The Bonus Chips are of a different style and design from the live casino chips. The Bonus Chips cannot be exchanged for cash and must be played on a gaming table for a predetermined game. Once the Bonus Chip(s) has been placed as a wager, the following applies:

- If the player wins, the player will receive live casino chip(s) for their bet from the playerdealer.
 - The player retains the Bonus Chip(s) to be used again on another wager.
- If the player pushes, they will retain the Bonus Chip(s) to be used again on another wager.
- If the player loses, the Bonus Chip(s) are given to the player-dealer.
 - The losing Bonus Chip(s) are verified by a casino representative and redeemed at the cage by the casino cage staff members for the player-dealer.
 - A casino representative will exchange the Bonus Chips with live casino chips and give them to the player-dealer.
- Players may wager the Bonus Chips on Bonus Bets.
- Bonus Chips shall not be used to pay collection or jackpot fees.
- Bonus Chips will be counted as part of the base game wager in terms of Total Table Action for collection rates.

Bonus Chip Promotion

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours posted for the gaming activity.

- The Bonus Chip Promotion will be open to players who buy in to a pre-determined game at an amount between \$10 and \$100,000.
- Bonus Chips can only be used within pre-determined and posted time periods.
- There is no limit to the amount of Bonus Chips that may be used per player or per wager (provided the wager is within table limits).
- There is no limit to the amount of times a player may buy-in to the Bonus Chip Promotion.
- A player shall pay all posted collection fees (if applicable) when placing a wager with Bonus Chip(s).
- Bonus Chips may be used to wager on base game wagers as well as bonus bets.
- Players cannot exchange Bonus Chips for live casino chips.
- Bonus Chips are non-transferable between players.
- Bonus Chips must be used on the same day that they were obtained.
- Bonus Chips have no cash value and cannot be redeemed for cash at any time.
- There is minimum of two players, a player and a player-dealer, required in the controlled game for this promotion.
- Bonus Chips will only be redeemed for the player-dealer after having been verified by a casino representative.
 - When the player-dealer position is held by a Third-Party Providers of Proposition Player Services (TPPPS) all Bonus Chips will be redeemed at the end of their shift.
 - When the player-dealer is a patron, the Bonus Chips will be redeemed at the end of the hand or round of play.
- Casino employees off duty and out of uniform are eligible for the promotion.
- The player-dealer position is not eligible to use Bonus Chips to settle wagers.
- Tournament games are not eligible to participate in this promotion.
- Players shall not use Bonus Chips to place Backline wagers.
- Bonus Chips cannot be used in combination with live casino chips.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to use Bonus Chips.

Prize

The prize will be a fixed amount ranging between \$10 and \$100,000 in the form of Bonus Chips.

Funding

The Bonus Chip Promotion will be fully funded by Banker's Casino. There will no additional fees or collections taken for this gaming activity.

Administrative Fees

The Casino shall not retain any administrative fee, as this promotion is house funded.

No Purchase Necessary

The Bonus Chip Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Match Play/Free Play Promotion

Bureau Requirements

Advertising

Banker's Casino may advertise various names for this gaming activity. Should Banker's Casino advertise a different name, the BGC ID (GEAR-001355) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Banker's Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Match Play/Free Play Coupon/Chip values
- Procedures to redeem Match Play/Free Play Coupons
- Expiration date
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Match Play/Free Play Promotion shall be attached to all Bureau approved California games offered at Banker's Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

Patrons are awarded Match Play and Free Play Coupons/Chips via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, or through the Player's Club Promotion (GEAR-001257). Players who receive a Match Play/Free Play coupon must redeem the coupon at the cage or with a casino representative for a chip with the corresponding value of the coupon. Players with the Match Play/Free Play Chips/Coupons will be eligible to win the specific amount printed on the chip/coupon if they place a wager on an eligible game equal to the amount listed on the Match Play Coupon/Coupon; Free Play is a standalone wager. Players will be paid accordingly to the amount listed on the Free Play Chip/Coupon without placing a wager with live chips.

Match Play Coupon

- Banker's Casino will offer Match Play Coupons having a face value of \$5 to \$500 per coupon/chip. The amount will be clearly stated on the coupon/chip.
- The player must redeem the Match Play Coupon for a Match Play Chip at the cage or with a casino representative in order to use the Match Play Coupon.
- The player must place the Match Play Coupon on the table as well as a wager equal to or more than the amount of the Match Play Coupon.
- Match Play Coupons can only be used on California Games.
- When the coupon is used by players not taking the player-dealer position, the coupons will be reconciled at time of play. The player-dealer will have all coupons reconciled at the end of their gaming day.

Match Play/Free Play Promotion

- When the player uses a Match Play Coupon/Chip and the hand wins, the player will be paid for the total wager (live chip(s) plus the Match Play Coupon/Chip value) and the used Match Play coupon is voided by the house dealer and given to the TPPPS or patron in the player-dealer position. At the end of the player-dealer's gaming session, the player-dealer will take any used Match Play Chips to the cage to be logged and exchanged for the value listed on the coupon. The exchanged value, in live casino chips, is given to the player-dealer as reimbursement for the coupon.
- When the player uses a Match Play Coupon and the hand loses, the player will only lose their original wager. The used Match Play Coupon is collected by the house dealer and is voided.

The player would place their coupon/chip on the gaming table; place a bet that matches the amount on the coupon/chip, and pay the posted collection (if applicable) for a single hand of play. The collection fee is based only on the wager and not the coupon/chip. If the player wins the hand, they will receive \$10 just as if they had placed a \$10 bet and the player-dealer will collect the coupon/chip. The coupon/chip is taken to the cage by the player-dealer at the end of their gaming session to be exchanged for its listed value.

Free Play Coupon/Chip

- Banker's Casino will offer Free Play Coupons/Chips having a face value of \$5 to \$500 per coupon. The amount will be clearly stated on the coupon/chip.
- The player must place the Free Play Coupon/Chip on the table. An additional wager is not necessary.
- Players can use Free Play chips in conjunction with live casino chips.
- Free Play chips can only be used on any California Game.
- When the coupon is used by players not taking the player-dealer position, the coupons will be reconciled at time of play. The player-dealer will have all coupons reconciled at the end of their gaming day.
- When the player uses a Free Play coupon/chip and the hand wins, the player will be paid for the total wager in live casino chips. The player will retain the Free Play coupon/chip to be used again.
- When the player uses a Free Play coupon/chip and the hand loses, the player will lose their original wager. The used Free Play Coupon/Chip is collected and voided. The coupons/chips are given to the player-dealer to be redeemed by a casino representative.
- If the player pushes (receives no action), the coupon/chip may be played again until the player wins or loses a hand.
- Free Play Coupon/Chips play until the wager loses.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

• A minimum of two players, a player and a player-dealer, are required to be playing in any of the games, as listed above, in order for the game to qualify.

Match Play/Free Play Promotion

- Each coupon will state the specific qualifying game(s) for which coupon may be used.
- All Match Play/Free Play Chips/Coupons may only be used in California games.
- Match Play/Free Play Coupons/Chips may be used on bonus bets. They may not be used for collection fees or jackpot fees.
- There is no limit to the amount of Free Play/Match Play coupons/chips that can be used at a table at a time. For example, all players at a table can play using Free Play/Match Play coupons/chips until their one-time coupon/chip wins or loses (Free Play coupons/chips can be used until the player loses).
- Players shall not exchange the coupons/chips for live casino chips or give them to another player.
- The coupons shall only be redeemed for live casino chips and given to the player-dealer after having been played and then verified by a casino representative.
- Coupons shall only be used in the player position and not in the player-dealer position.
- Backline bettors are eligible to participate in this gaming activity.
- Coupons shall have an expiration date on them. After that date has passed, the coupons will be void and unusable.
- A player may only participate in the Match Play/Free Play Promotion once per day. For example, if players use a coupon/chip in a game and the hand pushes, they may use it again. Otherwise the coupon/chip can only be used once until the player either loses or wins a hand. - Eligible games and time periods
- · Qualifying hands and corresponding prize amounts
- Administrative fees
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Match the Dealer Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Bankers Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

Pure Spanish 21.5 Blackjack 6 to 5 (GEGR-000750)

Object and Summary

Players are betting that both of their first two cards will match the player-dealer's up card in rank. A player that achieves one of the qualifying hands listed below for the Match the Dealer Progressive Jackpot is eligible to win a fixed or progressive prize.

- 1. To begin each round, players must make their regular base game wager. Players may optionally place any bonus bets and optional \$1 Match the Dealer Progressive Jackpot fee. "Hockey Puck: discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor.
- 2. Once all players place their bets and/or jackpot fee, the chips should be left in the designated spot on the layout. The house dealer then counts the number of bets for that round, inputs the total number of bets, and then presses "Check Bets" on the Table Control. The sensors will then light up, indicating participation in the progressive jackpot. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
- The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
- 4. When a player has achieved a winning hand, a casino representative will be responsible for verifying the winning hand. If the winning hand wins a percentage-based progressive meter payout, the casino representative will press the appropriate buttons on the **Table Control** to log the win. If the winning hand wins a fixed progressive payout the casino representative will pay the winner in live casino chips after the proper paperwork has been filled out. The payouts will not be made from the player-dealer's tray.

- Only seated players, who are dealt a designated hand and who have placed the optional \$1 jackpot fee are eligible for payouts.
- Backline bettors are not eligible to participate in this gaming activity.
- A minimum of two players, a player and the player-dealer, are required for this gaming activity.
- A minimum of three decks must be used in the base game in order for the game to qualify for the promotion.
