Bureau Requirements

Advertising

Bay 101 may advertise various names for this gaming activity. Should Bay 101 advertise a different name, the BGC ID (GEAR-001277) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Bay 101 at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Requirements for qualifying hands
- Qualifying hands and corresponding jackpot prize amounts
- Availability of No Purchase Necessary
- · Any other restrictions that apply to this jackpot

Eligible Controlled Games

The Poker Bonus Hand Progressive Jackpot shall be attached to all Bureau approved poker games offered at Bay 101 at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Poker Bonus Hand Progressive Jackpot features three progressive jackpot prizes. The Poker Bonus Hand Progressive Jackpot considers the best hand dealt to any player playing in any participating game during the predetermined and posted promotional period.

- 1. To determine qualifying hands, the following procedures will be followed for each attached poker game type:
 - a. Draw Poker style games:
 - i. For the base game, the players are each dealt five cards.
 - ii. Each player will use the five-card hand dealt for the base game as their five-card hand for the purpose of this gaming activity.
 - b. 7-Card Stud, 7-Card Stud High-Low style games:
 - i. For the base game, the players are each dealt three hole cards face-down and four cards face-up.
 - ii. Each player will use two hole cards and three up cards to complete their five-card hand for the purpose of this gaming activity.
 - iii. In the case of Four of a Kind (Quads), the hole cards used must be a pocket pair.
 - c. Flop games, e.g., Texas Hold'em, Omaha, Pineapple:

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Players must be seated and playing at a designated table in order to qualify for this gaming activity.
- Players must be present to win a prize.
- Players have up to fifteen (15) minutes to present a valid ID and claim the prize. If the player cannot present their ID within the fifteen (15) minutes, the player has thirty (30) days to return and claim the prize. If the player does not claim the prize within the thirty (30) days, the prize will be returned to the prize fund.
- In order to qualify for this gaming activity, the player must use two hole cards in flop or stud game, or five cards in draw style games.
- There is a minimum of five players required to be seated and actively playing in an above mentioned game for the table to qualify for the jackpot.
- A minimum of \$20 must be in the pot of the attached controlled game in order for the table to qualify for this jackpot.

Prize

The actual progressive jackpot prize pool amount will depend on the amount that the jackpot was originally seeded at, as well as how many days have transpired in order for the posted jackpot prize to increase progressively each day. Any additional jackpot fees collected each day shall be added to the jackpot reserve fund after the jackpot prize pools have been increased. In addition, once the cap is reached, any jackpot fees collected shall be added to the jackpot reserve fund. The jackpot reserve fund shall reseed the jackpot at an amount ranging from \$10 to \$598 after the jackpot is hit.

Funding

The Poker Bonus Hand Progressive Jackpot utilizes three progressive jackpot prize pools which will be player funded by a \$1 jackpot collection fee. During play of the attached controlled games, a \$1 jackpot collection fee will be collected from the poker pot during the play of attached controlled games, which is in addition to the regular house collection fee.

Each jackpot prize pool will be increased by \$1 to \$50 based on how many jackpot fees are collected that day with any additional collected jackpot fees going into the jackpot reserve fund in an amount between \$100 and \$5,000. The jackpot reserve fund shall be used to reseed the jackpot prize pools and pay administrative fees. If the Casino is required to reseed the jackpot or cover any shortfall due to inadequate funds, the Casino shall be reimbursed from the reserve fund once there are sufficient funds available.

Administrative Fees

The Casino will take an administrative fee of \$5 to \$20 per table per hour from the reserve fund. The administrative fee shall be utilized to cover expenses incurred by the gambling establishment for administering the Poker Bonus Hand Progressive Jackpot.

No Purchase Necessary

The Poker Bonus Hand Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Poker Bonus Hand Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Bureau Requirements

Advertising

Bay 101 may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001322) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Bay 101 at all times the gaming activity is being offered for play:

- Eligible dates and time period(s) to purchase Dead Chips
- Eligible dates and time period(s) to use Dead Chips
- How to purchase the Dead Chip
- Necessary amount to buy Dead Chips, and the amount of additional chips that will be received
- How to wager and redeem the Dead Chip
- Eligible games and tables
- The maximum number of Dead Chip buy-ins available to purchase (if a limit is in place)
- · Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Dead Chip Promotion shall be attached to all Bureau approved California games offered at Bay 101 at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Dead Chip promotion will award players who play during the pre-determined and specifically posted hours with an opportunity to purchase Dead Chips at a discount to the face value of the chip from the cashier cage. The Dead Chips can only be wagered with during pre-determined dates and times. Dead Chips

Dead Chips will look significantly different from the live casino chips and they will be marked as a promotional dead chip and shall state "no cash value". There will be a designated cage window for the purchase of Dead Chips. The dates, times and cage window number will be available in advance by the Casino. When a player buys-in to the Dead Chip Promotion, the cashier shall record the patron's name, date and time of buy-in, buy-in amount, amount of Dead Chips issued/awarded to the player, and name of cashier processing the transaction.

When the player wagers a Dead Chip and the hand loses, the Dead Chip will be
collected by the player-dealer. A casino representative will collect the Dead Chip from
the player-dealer and will then redeem the Dead Chips for live casino chips at the cage
for full value and bring the live casino chips back to the player-dealer.

Dead Chip Promotion

- If the hand wins, the player will retain the Dead Chip(s) and any winning amount will be paid in live casino chips by the player-dealer. Dead Chips may be wagered on bonus bets.
- If the hand pushes, the chip(s) may be wagered again.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Players cannot exchange Dead Chips for live casino chips or money. They can only be used to place a wager.

- Since Dead Chips have no cash value, unused chips are non-refundable.
- Dead Chips expire at the end of the promotional period. Expired Dead Chips cannot be used to wager or be exchanged for cash.
- Dead Chips are non-transferable between players.

- Match Play Coupon(s) and Free Play Chip(s) amounts
- Match Play Coupon(s) expiration date(s)
- Redemption Fee
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Match Play Promotion will be attached to all Bureau approved California games offered at Bay 101 Casino at all times the gaming activity is being offered for play. All controlled game rules will be played as approved by the Bureau.

Object and Summary

Patrons are awarded Match Play Coupons, Free Play Vouchers or Bonus Play Vouchers via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament. Players who receive a Match Play or Free/Bonus Play coupons will be eligible to win the specific amount on the coupon or chip. Players will not exchange the Match Play Coupons or Free Play Chips for live casino chips. All applicable collection fees will be paid when using a Free Play Chip or Match Play Coupon. Free Play Chips and Match Play Coupons may not be used to pay collection fees or jackpot fees and may be subject to a redemption fee.

Match Play Coupon

The Casino will offer Match Play Coupons having a face value ranging from \$5 to \$500 per coupon. The following will be clearly stated on the coupon: amount, qualifying attached controlled game(s), promotional period and any redemption fee.

A player will take a Match Play Coupon to an eligible game and place a wager that equals the amount on the coupon.

Free Play Chip(s)

The Casino will offer Free Play Chip(s) having a value ranging from \$5 to \$500. The Free Play Chip(s) are used in live games exactly like regular live casino chips, the difference being they cannot be exchanged for cash. Free Play Chips will initially be in the form of a voucher, which will be offered to all patrons that wish to come to the Casino and use them to play. The following will be clearly stated on the voucher: amount, eligible controlled game(s), promotional period and any redemption fee. When a patron receives a Free Play voucher they will present the voucher to a casino representative to be verified, logged, and redeemed for Free Play Chip(s) to be used in a live game. Free Play Chips will be used as the player's wager on the betting circle. Free Play Chips will not be taken into the house dealer's tray, nor will they be paid from the house dealer's tray.

- Free Play Chip(s) may be used only on the base game wager of the eligible controlled game listed on the voucher.

- If the player pushes (receives no action) the hand, the Bonus Play Chips may be played again until the player wins or loses the hand.

Example: A player receives a Bonus Play voucher with a stated value of \$10 to play on any California game, promotional period current and unexpired with a \$1 redemption fee. The player redeems the voucher for \$10 Bonus Play Chip(s). The player places the \$10 Bonus Play Chip(s) on the gaming table as a base game wager. The player also posts a \$1 redemption fee. If the player wins the hand, the player will win \$10 in live casino chips for their base game wager and retain the Bonus Play Chip(s) to be played again. If the player loses the hand, the player-dealer will collect the verified Bonus Play Chip(s) and present them to a casino representative. The casino representative will log the Bonus Play Chip(s) and exchange it for \$10 in live casino chips.

Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum of two players, a player and a player-dealer, are required in order for the table to qualify for this promotion.
- Backline bettors are eligible to participate and win in this promotion.
- There is no limit to the number of times Free Play Chips or Match Play Coupons that can be used.

The Bonus Hand Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Bay 101 Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Three Card Poker 6 Card Bonus (GEGA-004086)
- Ultimate Texas Hold'em Bad Beat Bonus (GEGA-004177)
- Crazy 4 Poker (GEGA-004555)

All controlled game rules will be played as previously approved by the Bureau.

Object and Summary

The Bonus Hand Progressive Jackpot features a progressive jackpot prize amounts. The Bonus Hand Progressive Jackpot considers the best hand possible among each individual player's cards.

- 1. To begin each round, players must place their regular base game wager. Players may optionally place any bonus bet wagers along with the optional \$1 jackpot fee.
- 2. Players must place the optional jackpot fee in a designated jackpot space prior to the deal to indicate their participation in the progressive jackpot.
 - a. When "hockey puck" discs are used, they will be attached to the table in front of each betting position. A sensor in the disc will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
 - b. When two designated jackpot spaces are used in one betting position, one is designated for the player's hand and the other is designated for the player-dealer's hand.

 - ii. After all players and the player-dealer have received their hands, one additional hand of three cards will be placed to the side of the house dealer.
 - iii. One card will be burned, removed from play and discarded.
 - iv. The two remaining cards are combined with the player or player-dealer's three-card hand to complete their five-card hand for the purpose of the progressive jackpot.
 - b. Ultimate Texas Hold'em:
 - i. For the base game, the players and the player-dealer are each dealt two cards. Five community cards are dealt in the center of the table.
 - ii. Each player or player-dealer will use their two cards combined with the three-card flop (first three community cards) as their five-card hand for the purpose of the progressive jackpot.
 - c. Crazy 4 Poker:
 - i. For the base game, the players and the player-dealer are each dealt five cards.
 - ii. Each player or player-dealer will use the five-card hand dealt for the base game as their five-card hand for the purpose of the progressive jackpot.
- 6. Progressive Winners:
 - a. Qualifying bonus hands with a progressive meter payout will be paid from the progressive jackpot prize pool in the amount shown on the progressive meter.
 - b. If the player-dealer hand qualifies for a progressive prize, the amount of the progressive jackpot prize will be divided among all players who placed a fee for the player-dealer's hand.

7. Fixed Prizes:

Eligibility Requirements

Funding

Object and Summary

Patrons shall be provided with ample advance notice of which prize payout structure option is being offered for play. Once the Casino designates a prize payout structure option, the payout structure shall not be adjusted or changed until the jackpot has been hit and awarded.

- Players who obtain a qualifying Losing Hand shall win the corresponding percentage of the prize pool, depending on the selected prize payout structure option.
 - If multiple players obtain a qualifying Losing Hand, only the highest ranked Losing Hand will win the Losing Hand share of the prize pool.
 - If multiple players obtain the same qualifying Losing Hand, all eligible players will win and evenly split the Losing Hand share of the prize pool.
 - If there is an odd number of chips the casino will make up the short fall and will be reimbursed from the reserve fund once there are sufficient funds.
 - Players who obtain and win the qualifying Losing Hand will not be eligible for the Table Share.
- Players who obtain a qualifying Winning Hand shall win the corresponding percentage of the prize pool, depending on the selected prize payout structure option.

 - If there is an odd number of chips the casino will make up the short fall and will be reimbursed from the reserve fund once there are sufficient funds.
 - Players who obtain and win the qualifying Winning Hand will not be eligible for the Table Share.
- Active players who are at the same table where the qualifying losing and winning hands are obtained, will evenly split the Table Share percentage of the prize pool, depending on the selected prize payout structure option.
 - o If there is an odd number of chips the casino will make up the short fall and will be reimbursed from the reserve fund once there are sufficient funds.

Funding

The Limit Bad Beat Jackpot consists of a player-funded fixed prize pool. During all eligible games, when five or more players are dealt in on a hand, a \$1 jackpot fee is taken from the pot and then placed in a separate and locked jackpot fee box, which will be apart from the regular house collection fees. Proceeds from the jackpot fee will be deposited into the Limit Bad Beat Jackpot Reserve Fund.

The casino shall initially seed the jackpot with an amount ranging between \$1,000 and \$75,000. When the jackpot prize has been awarded, the jackpot prize pool will be re-seeded at an amount between \$1,000 and \$150,000, from the reserve fund. If there are not sufficient funds in the reserve fund, the casino will make up the short fall.

Additionally, whenever the Casino is required to seed the jackpot prize pool or cover a shortfall due to inadequate funds in the reserve fund, the Casino shall be reimbursed from the reserve fund once sufficient funds become available.

All fee collections and table limits for the designated controlled game are Bureau approved, predetermined and posted at each table.

Administrative Fees

The Casino shall retain an administrative fee of \$5 to \$20 per table per hour. The administrative fee shall be taken from the reserve fund. This fee shall cover the costs associated with prizes, administering and accounting for the jackpot.

No Purchase Necessary

The Limit Bad Beat Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Limit Bad Beat Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

Bureau Requirements

Advertising

Bay 101 Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GETR-000056) shall be referenced on all advertisements relating to the gaming activity.

Furthermore, all rules and procedures for the Poker Tournament and associated gaming activities, including but not limited to the following, shall be prominently displayed in Bay 101 Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament
- The game(s) offered during the play of the tournament
- The fees charged for entering the tournament, including a description for each fee charged and whether it shall be retained by Bay 101 Casino, added directly into the tournament prize pool, or any other method of retention or distribution
- The amount of tournament chips that will be awarded to each player upon entry into the tournament
- The tournament prize structure offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid
- Any other restrictions that apply to the Poker Tournament

Gaming Activities Played with Tournaments

- Advertising for bounties will be prominently posted with the prize amount and how the bounties will be funded
- The bounties will be paid during the tournament or as soon as their tournament play ends
- In the event of a tie, the bounty will be split among the players with the highest hands

Gaming Activities Offered During Tournament Play

Bounties

Bounty targets are tournament players designated at the discretion of the Tournament Director. If a bounty target loses all of their tournament chips during a hand of play and is eliminated from the tournament, the winner of that hand shall collect a bounty. If the bounty target is not eliminated, then they shall collect their own bounty.

- Bounties may be offered to tournament patrons who pay the buy-in and entry fee.
- If Player X knocks out a bounty target by ending their play in the tournament, then Player X will be awarded a bounty prize.
- The bounty prize will be paid to Player X during the tournament or as soon as their tournament play ends. The Casino will determine which method to use.

- Bounties are funded by the tournament prize pool. The bounty prize amount(s) will be deducted from the total number of buy-ins, rebuy(s) and add-on(s)

- If the group of remaining players decide to split the prize pool among themselves, the remaining bounty prizes will become part of the total split.
- There is no minimum or maximum number of players required for this gaming activity.

Tournament Entry

- Tournament entry is open to all customers.

Tournament Prize Amounts & Source of Funds

The prizes will be cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The cardroom may provide prizes or add funds to the prize pool for special events.

- When the prize amount is guaranteed, the payouts will be a cash value ranging from \$5-\$1,000,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, Bay 101 Casino will fund the difference.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons (free roll), Bay

- This structure will allow the distribution of a specific prize, or group of prizes, of fixed values. The maximum number of items is distributed with any remaining prize monies equally to those players who won the items.

These organizations shall be reputable and federally recognized as non-profit or charity organizations. These organizations will not be involved in running the tournament; however, their name may be used in conjunction with the advertising and promoting of the event. Bay 101 may donate prizes such as entries into Bay 101 Casino's tournament is no cost to the charity. Charity tournaments may be structured where all or part of the buy-in, re-buy and add-on monies may be designated to go to a specified charity, in lieu of being paid out to winners. This shall be pre-determined and clearly posted on any and all advertisements.

No Purchase Necessary

The gaming activities attached to the Poker Tournaments shall be offered for free, on a general and indiscriminant basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Casino shall provide No Purchase Necessary tables for patrons who request to participate in the gaming activities attached to the Poker Tournaments without paying any entry into the tournament. The NPN player must adhere to all rules as the tournament player. All advertisements shall state "No Purchase Necessary" when referencing the gaming activities offered during the Poker Tournaments.

Object and Summary

The object of the Bonus Hand Progressive Jackpot v1.1 (jackpot) is for a player to form a five-card qualifying hand, as mentioned below, in order to win a corresponding progressive or fixed prize.

- 1. To begin each round, players must make their regular base game wager. The players may optionally place any bonus bets along with the optional jackpot fee of \$1.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor.
- 3. Once all players have placed their bets and optional jackpot fee(s), the house dealer shall press "Start Game" on the keypad. The sensors shall then light up, indicating participation in the jackpot. The house dealer shall then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
 - a. If a sensor fails to light up, the house dealer will utilize a button to indicate participation in the jackpot.

4. The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.

Qualifying Hands

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options listed below. Crazy 4 Poker – Dealing procedures for the game of Crazy 4 Poker state that each player will be dealt five cards. The Bonus Hand Progressive Jackpot v1.1 qualifying hands for this game consider the five cards dealt to the player.

Three Card Poker 6 Card Bonus – Dealing procedures for the game of Three Card Poker 6 Card Bonus state that each player, including the player-dealer, will be dealt three cards face down. Immediately after the cards are dealt to the player-dealer, the house dealer will flip one of those cards face up. The Bonus Hand Progressive Jackpot v1.1 qualifying hands for this game consider the three cards dealt to the player and the two cards of the player-dealer that remain face down.

Ultimate Texas Hold'em Bad Beat Bonus – Dealing procedures for the game of Ultimate Texas Hold'em Bad Beat Bonus state that each player will be dealt two cards, knowns as hole cards, followed by five cards dealt to the center of the table, known as community cards. The Bonus Hand Progressive Jackpot v1.1 qualifying hands for this game consider the players two hole cards and the first three community cards dealt to the center of the table, known as the flop.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A minimum of two players, a player and a player dealer, must be dealt into an eligible game in order for the table to qualify for this promotion.
- There is no minimum amount of time a player must play in order to be eligible for this gaming activity.
- Only seated players, who have paid the optional \$1 jackpot fee and are dealt a qualifying hand, are eligible for payouts.
- Backline bettors are eligible to place a jackpot fee and win a prize only if backline betting is allowed in the base game.
 - Backline bets will be placed in the same betting disk as the seated player.

- If a player's hand qualifies for more than one prize, the player will only be awarded the prize with the higher value.
- If a player with a qualifying hand folds prior to the final betting round, they will still be eligible to win a prize.
- There is no limit to how many times a player may win a progressive or fixed prize within a promotional period.
- Players who are playing multiple hands are eligible to place a jackpot fee and win on each hand.
- Casino employees are eligible for this gaming activity when off-duty.
- Tournament games are not eligible for this gaming activity.
- Third-Party Provider of Proposition Player Services (TPPPS) are not eligible to place a
 jackpot collection fee and become eligible for the Bonus Hand Progressive Jackpot v1.1
 when in either the player-dealer or player capacity.
- The player-dealer position is not eligible for this promotion.

Prize

The Bonus Hand Progressive Jackpot v1.1 features both progressive and fixed prizes. All prizes will be paid by a casino representative. Once all proper paperwork has been filled out, the casino representative will pay the winners in the form of cash, check, or live casino chips. The payouts will not be made from the house dealer's tray. All monies collected and paid out shall be tracked both electronically and on a hand written log to be maintained by the casino for examination by regulatory and law enforcement personnel.

Progressive Prize

The Bonus Hand Progressive Jackpot v1.1 prize pool (prize pool) amount will be between \$1,000 and \$250,000. The actual amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day. All progressive prizes will be deducted from the prize pool.

The Casino may choose to make additional increases to the prize pool amount, as long as the prize pool stays within the minimum and maximum prize pool amount limits listed above.

- The increase must be predetermined and posted.
- The increase will come from the reserve fund.
 - o The increase will only be offered if there are enough funds in the reserve fund.
- Under no circumstances shall the prize pool be decreased once posted.

 - o If option B is selected 100% of the prize pool will be awarded to players who achieve a Royal Flush or a King High Straight Flush.
 - o If option C is selected 100% of the prize pool will be awarded to players who achieve a Royal Flush, a King High Straight Flush, or a Queen High Straight Flush.

- 10% of the prize pool will be awarded to players who achieve a qualifying hand, according to the selected Bonus Hand Progressive Jackpot v1.1 Qualifying Hand Chart Option.
 - If option A is selected 10% of the prize pool will be awarded to players who achieve a Straight Flush.
 - o If option B is selected 10% of the prize pool will be awarded to players who achieve a Straight Flush with the exception of a King High Straight Flush and a Royal Flush.
 - o If option C is selected 10% of the prize pool will be awarded to players who achieve Straight Flush with the exception of a Queen High Straight, a King High Straight Flush, and a Royal Flush.
- In the event that multiple players achieve a hand that qualifies them for 100% of the prize pool, the prize will be equally split among the winners.
 - o In the event that there are an odd number of chips, the Casino will make up the shortfall and will be reimbursed from the reserve fund once there are sufficient monies.
- In the event that multiple players achieve a hand that qualifies them for 10% of the prize pool, the prize will be equally split among the winners.
 - o In the event that there are an odd number of chips, the Casino will make up the shortfall and will be reimbursed from the reserve fund once there are sufficient monies.
- In the event that both a qualifying hand for 100% of the prize pool and a qualifying hand for 10% of the prize pool are hit at the same time the player with the qualifying hand for 10% of the prize pool will be awarded their 10% of the prize pool amount first. After the qualifying hand for 10% of the prize pool has been settled the remaining prize pool amount will be awarded to the player with the qualifying hand for 100% of the prize pool.
 - In the event that multiple players obtain either a qualifying hand for 100% of the prize pool or a qualifying hand for 10% of the prize pool, the qualifying hands for 10% of the prize pool will be settled first followed by the qualifying hands for 100% of the
 - All players who achieved a qualifying hand for 10% of the prize pool will split 10% of the prize pool amount equally.
 - All players who achieved a qualifying hand for 100% of the prize pool will split the remaining prize pool amount equally.

This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.
