NOTICE OF MODIFICATIONS TO TEXT OF PROPOSED REGULATIONS

Notice published January 23, 2026

Pursuant to the requirements of Government Code section 11346.8, subdivision (c), and section 44 of Title 1 of the California Code of Regulations, the Department of Justice (DOJ) is providing notice of changes made to proposed regulation regarding the California Volunteer and Employee Criminal History Service (CalVECHS) Program – Title 11, Division 1, Chapter 4.5. This proposed regulation was the subject of a Notice of Proposed Rulemaking published in the California Register (Register 2025, No. 10-Z) on March 7, 2025. These changes are in response to comments received regarding the proposed regulation and for clarification purposes.

Newly proposed changes to the CCR are illustrated in **red bold double underline** for proposed additions and **black bold double strikethrough** for proposed deletions.
