The Correctional Law Section (CLS) of the Office of the Attorney General is currently accepting applications from law students for the Attorney General Summer Internship Program. CLS Deputy Attorneys General defend employees of the California Department of Corrections and Rehabilitation in civil suits filed by incarcerated or paroled individuals. A typical CLS case involves claims for violation of the First, Eighth, or Fourteenth Amendments, although cases may also involve claims arising under California law or federal statutes. CLS cases often involve cutting edge issues in constitutional litigation, including claims pertaining to gender identity, the provision of medical and mental health care, and religion.

The summer internship program provides exciting and rewarding opportunities for candidates interested in pursuing a career in public service and civil litigation. Interns will assist Deputies to prepare briefing that will be filed in state or federal courts, including motions to dismiss or motions for summary judgment. Past interns have also assisted with discovery matters and pre-trial motions. In addition to the opportunity to prepare substantive legal pleadings, interns will gain significant experience with constitutional law and federal civil procedure through research projects and trainings. Interns may also have the opportunity to assist and/or observe deputies during depositions, mediations, and trials. Finally, interns may have the opportunity to tour a correctional institution, Los Angeles County facilities, and to meet with state and federal judges.

Applicants for an internship in CLS must have excellent writing, research, and analytical skills. *A successful applicant will have a demonstrable interest in public service, constitutional litigation, or the state corrections system.* Prior experience with constitutional law and pre-trial advocacy is beneficial.

Although in-person attendance will be expected during the summer internship, interns may be permitted to work remotely. The start date of the internship may be negotiable, but interns are expected to work full-time for eight to ten weeks.

Applications will be accepted from rising 2L and 3L students until **March 31, 2026**. Applicants are encouraged to apply promptly, since candidates will be considered on a rolling basis and the available positions may be filled prior to the application closing date.
