Advertisement Requirements

The Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID listed shall be referenced on all advertisements relating to the Aces Cracked gaming activity.

Furthermore, all rules and procedures for this jackpot, including but not limited to the following, shall be displayed conspicuously and prominently in the Casino at all times the gaming activity is being offered:

Controlled Game

Prize

A player that receives the qualifying losing hand will receive a fixed cash amount ranging from \$25 to \$100. Patrons shall be given ample notice of the prize amount. Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- There is no minimum or maximum number of players required to be dealt in during a

Specific Information (Applies to all Bad-beat Jackpots)

One jackpot per hand

Players may win only one type of jackpot per jackpot hand.

All jackpots are no purchase necessary promotions (NPN).

All bad-beat jackpots are no purchase necessary promotions. (See attached "NPN" information)

No "Counterfeit" Bad-Beat Hold-em Jackpots

If there are two hands that otherwise meet all requirements for a jackpot it will be a valid jackpot even if there are better hands that use only one hole card. Any player using only one hole card in a jackpot situation will receive a player's share. If more than two hands qualify using both hole cards, the best qualifying hand and the second best qualifying hand will win the jackpot and the other hands will receive a player's share.

Eligibility Requirements

The promotion shall be open to all players who are seated and playing in an eligible game during the pre-determined and specified hours designated for this gaming activity.

When a Bad Beat Jackpot hand is announced, the floor person will verify that both hands qualify Any deviation from a standard deck will nullify the jackpot.

The qualifying hand will be the highest hand beaten each hour, with the time frame beginning at the top of each hour (1:00 a.m. to 1:59 a.m. or 9:00 p.m. to 9:59 p.m., for example), which also meets all other jackpot qualifications.

In all instances, patrons will be provided with ample advance notice of the percentage division of the posted Jackpot Prize for the game in which they are playing

To be eligible for a player's share, a player must have been dealt in at the table for at least one hand and not have missed his/her blinds.

From time to time, with prior notification to the players, the Casino reserves the right to modify the terms of the award of a Jackpot Prize such that a player with a Qualifying Hand will receive a Jackpot Prize which may consist of the award of a tournament qualification or other promotional item.

Advertising

The Diamond Jim's Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004534) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Diamond Jim's Casino at all times that the gaming activity is being offered for play:

- Eligible games.
- Eligible time period(s).
- Availability of No Purchase Necessary.
- Amount to be added to the pot (prize amount).
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Live Action Tournaments promotion shall be attached to all Bureau approved poker controlled games offered at Diamond Jim's Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Live Action Tournaments gaming activity features a promotional element which shall be attached to the approved poker games at the Casino. At the start of the promotion, Casino employees will determine and post the prize and the eligible tables. Eligible tables are based on specific games and limits that are predetermined a week before the promotion is offered. Each eligible table will start out with the same amount of "Live Action Tournament" chips, at a minimum of 10 and a maximum of 60 chips. All dealers at all designated and eligible tables then place one "Live Action Tournament" chip into the pot after the flop of each hand. Betting procedures and play shall proceed as a normal round of play would. The player with the winning hand shall win the pot, including the added "Live Action Tournament" chip. In the event of a tie, the pot is split the winning player closest to the right of the dealer button, if not the dealer button itself, shall win the "Live Action Tournament" chip. When all the "Live Action Tournament" chips have been distributed, the Live Action Tournament is over and the player who has the most "Live Action Tournament" chips among all the tables wins. If more than one player has the highest amount of "Live Action Tournament" chips, the prize shall be split equally between the players.

Eligibility Requirements

The promotion shall be open to all players who are seated and playing at any of the poker tables during the pre-determined and specified times designated for this promotion.

- There is a minimum of two and a maximum of ten players that must be seated and playing at a table in order for the table to be eligible for the "Live Action Tournament.
- "Live Action Tournament" chips are non-transferrable between players.

- Tournament games do not qualify for the Live Action Tournaments promotion.

Prize

The prize shall be a fixed prize ranging in value from \$20 to \$1,000, per tournament table, in the form of casino chips.

Funding

The Live Action Tournaments gaming activity shall be funded by the reserve account for the currently approved player funded Poker Jackpot Fund (GEGA-001960). Per Diamond Jim's representative, Elijah Zuniga, this jackpot fund has a reserve fund that was not noted in the original approval.

There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

Administrative Fees

There will be no administrative fees attached to the Live Action Tournaments promotion.

No Purchase Necessary

The Live Action Tournament Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Match Play Promotion

Advertisement Requirements

Diamond Jim's Casino may advertise various names for this gaming activity. Should the Diamond Jim's Casino advertise a different name, the BGC ID listed below shall be referenced on all advertisements relating to the Match Play Promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Diamond Jim's Casino at all times the promotion is being offered:

- Eligible games and time periods.
- Coupon and/or free play chip value(s).
- Procedures to redeem coupons or free play chips.
- Any other applicable restrictions.

Controlled Game

The Match Play Coupon Promotion may be attached to all limits and versions of the currently Bureau approved California games offered at the Diamond Jim's Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

Rules of Play

Patrons are awarded match play or free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Players who receive a match play or free play coupon will be eligible to win the specific amount printed on the coupon if he/she places a wager on an eligible game equal to the amount listed on the match play coupon.

Prize

The match play coupons and/or free play chips shall have a value ranging from \$5 to \$500 for each coupon or free play chip. Players shall not exchange match play coupons or free play chips for live chips. Additionally, players shall not give match play coupons or free play chips to another player. The coupons and chips shall only be redeemed after having been played and verified by a key employee.

Match Play Coupon

The Casino will offer match play coupons having a face value from \$5 to \$500 per coupon. The amount will be clearly stated on the coupon. Each coupon will state the specific qualifying game(s) that the voucher may be used on. The wager must be equal to the amount of the match play coupon and a player's winning hand will be paid his/her wager as well as the listed amount on the match play coupon. When the player uses a match play coupon and the hand loses, the player will only lose his/her original wager and the match play coupon is collected and voided. The player-dealer will then have a key employee sign the voucher verifying that it has been won. All winning vouchers are

Match Play Promotion

verified and signed by a key employee. Winning vouchers are taken to the cage by the key employee, logged, and exchanged for the value listed on the coupon(s). If a player loses, the money part of the wager is collected by the player-dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

EXAMPLE: A person receives a match play voucher with a value of \$5.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. The collection fee is based only on the wager and not the coupon. If the player wins the hand, he/she will receive \$10.00 just as if they had placed a \$10.00 bet and the player-dealer will collect the voucher.

Free Play Chip

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The free play chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips shall initially be in the form of a coupon which shall be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Each coupon shall state the specific qualifying game(s) that the free play chip(s) may be used on.

Promotional chips shall be used as the player's bet and placed on the betting circle. Promotional chips shall not be taken into the dealer's tray, nor shall they be paid from the dealer's tray. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player-dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

EXAMPLE: A person receives a free play chip coupon for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place

the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play.

Eligibility

The promotion will be open to all players who are seated and playing at the above listed games during the pre-determined and specified hours designated for the promotion.

- A minimum of two (2) players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- Each coupon will state the specific qualifying game(s) that a player may use the coupon at.
- Players shall not exchange the coupons for live chips or give them to another player.
- The coupons and chips shall only be redeemed after having been played and verified by a key employee.
- All procedures, times, qualifying hands, and prize amounts must be displayed prominently via any form of advertising that the Diamond Jim's Casino wishes to use, including but not limited to printed flyers, digital display, the Casino's website, etc.
- Casino Employees, on and off duty and in and out of uniform, are not eligible for the promotion
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible for the promotion.

Funding

The Match Play Coupon Promotion shall be fully funded by the Diamond Jim's Casino. There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

No Purchase Necessary

The Match Play Coupon Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

We will give out two-part numbered tickets to all persons in the casino, restaurant, and bar whether or not they are playing casino games. Tickets will be handed out a few minutes before the scheduled drawing times. Diamond Jim's Casino will make every effort to make sure that everyone has a ticket except working employees, by announcing several times on the loud speaker that if anyone needs a ticket for the drawing, please come to the podium to receive a ticket for the free drawing. The part that we keep goes into a locked ticket drum. A sign will be posted giving all the pertinent information to all patrons about the drawings as to the times, etc., and that 'you must be present to win' and 'no purchase is necessary' and 'reserves the right to cancel at anytime'.

The Money Wheel will be spun at 3,5,8 and 11:00 P.M. The Money Wheel has to make at least two complete revolutions. Any number that the paddle lands on will be multiplied times \$5.00 for the 3:00, 5:00 and the 11:00 P.M. At the 8:00 P.M. drawing, the number the paddle lands on will be multiplied times \$10.00. There is one Joker and Flag category on the wheel that will pay \$150.00 if the paddle lands on it at the 3, 5 and 11:00 P.M. spin. At the 8:00 P.M. spin, if the Joker or Flag category is hit, these will pay \$400. The patron will receive cash.

All winning tickets will be put back into the locked drum, and the patrons are asked to keep their portions of their tickets for a Friday Night extra drawing at 9:00 P.M. This drawing will be for prizes such as televisions, VCR's, DVD's, or other household items that have an estimated value of \$250.00.

PLAYER TRACKING SYSTEM PRIZE REWARDS DIAMOND JIM'S CASINO

Diamond Jim's Casino proposes to implement a system of prizes and cash rewards for patrons that voluntarily participate in a system that tracks the number of hands played. By enrolling in this tracking system and offering their personal tracking card when entering a game, customers would receive points for playing in all our offered games with higher limit games receiving more points per hand and lower limit games receiving fewer points per hand. Management would designate and post the amount of points that can be earned per game and will offer bonus points for play at certain times. Player points would be a no purchase necessary promotion and governed by our "NPN" rules. (Attached)

The prizes to be offered would be grouped according to the value. The list of offered rewards would be designated and posted throughout the casino. Items could change from time-to-time, discounted "on sale" for reduced points and seasonal gift rewards would be offered. The designated point value of a prize would be based in part on the retail value of the item and/or our estimate of that retail value. Points necessary for an item could be adjusted up or down but at all times the number of points required to win each available item would be designated and clearly posted.

Pocket Pair Beat Promotion General Rules

The gaming activity involves no other entity other than the house. There is no copyright, patent, or license involved with this activity.

Standard poker tables will be utilized for this activity. A standard 52 card poker deck will also be utilized as well as licensed, professional dealers. Our tables are equipped with Shuffle Master in table shuffling machines.

This bonus, jackpot, is paid to a player in a Texas Hold'em poker game if that player;

- Receives two aces as his/her first two cards that are dealt face down.
- Completes play on all four rounds of the hand, pre-flop, flop, turn and river, and does not fold the hand.
- Completes the applicable bets on each round. If the player goes "all-in" this is considered to have completed all bets.
- Loses the hand on the "showdown", after the final round of betting.

The cash prize for the bonus jackpot will be:

Ace – Ace (Same Color)
Ace – Ace (Any Color)

King – King (Any Color)

Queen – Queen (Any Color)

Range between \$25 to \$100

The jackpot amounts will be pre-determined and posted by the casino.

The player holding "pocket aces", "pocket kings," or "pocket queens" can make no sign or gesture, whether verbal, visual, or otherwise to any other player that he/she holds the qualifying hand. Any signs or gestures will invalidate that hand for the jackpot. There will be no extra collection taken for this bonus, jackpot, other than the \$1.00 which is already being collected for the Hold'em Monster Bad Beat Jackpot GEGA-001965. The jackpot will re-seed after it has been awarded.

If more than one seat receives a qualifying hand on the same round of play, each qualifying hand will receive the full amount of the jackpot. The jackpot will not be valid during tournament play and is only valid during "live" game play. Casino Employees are always eligible to participate in the gaming activity.

No Purchase Necessary: The Pocket Pair Beat Promotion will be offered for free, on a general and indiscriminate basis, with no restrictions to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Diamond Jim's Casino may advertise various names for this gaming activity. Should the Card Room advertise a different name, the BGC ID (GEGA-004462) shall be referenced on all advertisements relating to the Poker Morning Bonus Promotion.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in The Diamond Jim's Casino at all times that the gaming activity is being offered for play:

- The required amount a player must buy-in for and the corresponding amount of bonus chips he/she shall earn.
- The time required to play in order to earn the bonus chips.
- The number of participants that the promotion is limited to.
- The number of times per day a player may participate.
- The dates(s) and time(s) the promotion shall be offered.
- The games eligible for the promotion.
- The log that tracks the players during the promotion.
- Any other applicable restrictions.

Controlled Games

The Poker Morning Bonus Promotion shall be attached to all limits and versions of the following controlled games, as shown below, offered at Diamond Jim's Casino at all times that this gaming activity is being offered for play. Rules of Play

Based on customer demand and industry trends, the Diamond Jim's Casino proposes to add the Poker Morning Bonus promotion. This promotion will award a cash prize, in casino chips, and/or a complimentary food item to specified Texas Hold'em and Omaha players that buy-in for a specified amount and play for a predetermined amount of time. A floor person will be responsible for logging in each player and monitoring their play time in order to qualify for this promotion. The log will include the player's name, the game, the table number, what time the player started playing, and how much the player is awarded. Once the player has reached the posted required time limit, they will receive the posted amount of casino chips and/or menu items.

Prize

The Poker Morning Bonus Promotion awards a fixed prize element ranging in value from \$10 to \$500 in the form of casino chips, as pre-determined and designated by the Diamond Jim's Casino. Players may also receive food as their prize. The food and money elements can be combined.

Example: For the month of March, the first 9 players who buy-in for \$25 at an Omaha Poker game (with a jackpot element attached) will receive a \$5.99 breakfast and \$10 in chips.

Poker Morning Bonus

Eligibility Requirements

- The amount of required time that a player must play in order to receive the bonus casino chips shall be 30 minutes to three hours of play.

The Diamond Jim's Casino shall not retain an administrative fee for this gaming activity.

No Purchase Necessary

The Poker Morning Bonus Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Diamond Jim's Casino "Poker Pot Splashin"

Promotion

SUMMARY

Based on customer demand and industry trends, Diamond Jim's Casino (DJC) proposes to add a gaming activity to all currently approved poker games. During designated times of the day, there will be a series of "pot splashes" whereby the casino will pick a table at random and inject a designated amount of chips into the live pot on that table. The player that wins that hand will win the pot plus the amount added. Once the table is announced, the next hand will have a predetermined amount added to the pot. Patrons will be given ample advanced notice of those designated times.

RULES OF PLAY

The Poker Pot Splashin' features a promotional element which shall be attached to all poker games currently approved at Casino. The Poker Pot Splashin involves a drawing where a bin, basket, lottery ball machine, or other non-electronic randomizer shall be used. During predetermined times and intervals of the promotional period, a casino employee shall announce the commencement of the drawing. The casino employee shall then select an eligible table by randomly choosing a card, ball, or other lamer from the randomizer. A card, ball, or lamer shall depict a number that corresponds to each eligible poker table. The cards, balls, or lamers, which are pre-printed, equally sized and colored, shall be mixed within the randomizer. Then, one shall be selected. Once that table number is determined, the employee shall place the predetermined and posted prize into the pot on the table, at the start of the next hand. New players may enter the game in between these hands. Betting procedures and play shall proceed as a normal round of play would. The player with the winning hand shall win the pot, including the added prize amount. In the event of a tie, the winning players shall split the pot evenly.

PRIZE

When a table is selected, the bonus amount shall be added to the pot of that table. The prize shall be a fixed amount ranging from \$50 to \$2,000 in the form of casino chips. All prizes for this promotion shall be pre-determined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

ELIGIBILITY

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in Diamond Jim's Casino at all times the promotion is being offered:

- Prize amount or item.
- Eligible controlled games and time periods.
- Schedule of when prizes shall be awarded including if a sporting event goes beyond its normal stopping point.
- Any No Purchase Necessary opportunity.
- Any other applicable restrictions.

Eligible Controlled Game

The Sport's Squares shall be attached to all Bureau approved Poker games offered at Diamond Jim's Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- 2. Three Card Poker progressive considers the best hand possible among each individual player's cards.

Object and Summary

- 1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the jackpot fee of \$1.00. A minimum of two players are required to play for the progressive jackpot; a player and a player-dealer.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- 3. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.

The house dealer then follows standard approved procedures for dealing the base game. The jackpot considers the best hand possible among the player's cards. A

Eligibility Requirements

- Only seated players, who are dealt a designated hand, are eligible for payouts.
- Back-line bettors are not eligible to place a jackpot collection fee or receive the prize amount for a qualifying hand.
- Casino employees are eligible for the Ultimate Texas Hold'em prize when offduty only.

Object and Summary

The Wheel Promotion features a fixed promotional prize attached to all the above listed games played at Diamond Jim's Casino. A player will be given the opportunity to enter into the drawing and be awarded a prize, by spinning the wheel, when a player obtains a designated qualifying hand, as listed below. When a qualifying hand is announced, a casino employee shall verify that the hand qualifies. If a player makes a qualifying hand, he/she will be given a drawing ticket, where the player will write their name and their Player's Card Number. If a player does not have a Player's Card, then they must include the last four of their Social Security Number or Driver's License Number. If the information is not legible, the ticket will be deemed void. The ticket will then be placed into the drawing bin located on the casino floor in front of the Security area that shall be used to select the winner. Eligibility Requirements

The promotion shall be open to all players who are seated and playing in an eligible game during the pre-determined and specified hours designated for this gaming activity.
