## STOP THE HATE GRANT PROGRAM

\$14 million from FY 2021-22 awarded to 80 organizations for a 1-year grant term from April 15, 2022 through June 30, 2023

5 Regional Leads (RLs) - Subgrant funds to Program Service Providers

75 Program Service Providers (PSPs) - Deliver Direct, Prevention, and/or Intervention services to their communities

### TRANSFORMATIVE GRANT PROGRAM

\$30 million from Fiscal Years (FY) 2021-22 & 2022-23 awarded to 12 organizations for a 3-year grant term from August 1, 2022 through July 31, 2025
