Bureau Requirements

Advertising

The Empire Sportsmen's Association may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001095) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Empire Sportsmen's Association at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying winning and losing hands.
- Prize amount.
- Funding source.
 - Bad-Beat Jackpot reserve fund (GEGA-004341)
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Aces Cracked Promotion shall be attached to the following Bureau approved controlled game offered at Empire Sportsmen's Association, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-001847)

Object and Summary

The Aces Cracked Promotion features a fixed prize element attached to the eligible controlled game listed above. The prize is awarded to player(s) participating in a game when he/she receives two aces as his/her first two hole cards that are dealt face-down and is then beaten by a better hand at the showdown.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is a minimum of three players required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the promotional prize.
- When a qualifying hand is announced, a floor person will verify that the hand qualifies. Any deviation from a standard deck will nullify the promotion.
- In order to qualify for the promotion, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.
- In order to qualify for the promotion, the player must lose the hand at the showdown, after the final round of betting.
- In the event that during a round of play, two or more players have qualifying losing hands, each player will split the posted prize amount.
- The promotion shall not be valid during tournament play and is only valid during live game play.

Aces Cracked Promotion

- The player holding pocket aces can make no sign or gesture, whether verbal, visual, or otherwise to any other player that he/she holds the qualifying hand. Any signs or gestures will invalidate that hand for the Aces Cracked promotion.

Prize

Funding

Administrative Fees

The Empire Sportsmen's Association shall not retain any additional administrative fees.

The Aces Cracked Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Aces Cracked Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Object and Summary

The Bad Beat Jackpot features three progressive jackpot prizes, which are awarded to players participating in an eligible controlled game when a designated second hand is beaten by a better qualifying hand at the showdown. When the winning and losing hands are confirmed, those players with the qualifying jackpot hands shall receive the posted percentage of the progressive jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all other players at the qualifying table who have participated in the designated game, as shown below. Also, a posted percentage of the jackpot prize, known as the room share (if applicable), shall be evenly distributed amongst all players at any other Texas Hold'em table that were actively playing when the qualifying Bad Beat hand was "hit".

Qualifying Hands

Players that make the following advertised qualifying hands shall be eligible to win their share of the Bad Beat Jackpot prize amount, as shown below. Only winning and losing hands that have been Bureau approved, predetermined, and designated by Empire Sportsmen's Association are eligible. In order to qualify for the jackpots, both the winning and losing hands must use two hole cards and three board cards. All three jackpots shall be eligible to be won, but only the highest one will be awarded if more than one is qualified for. Only one of these qualifying hand options shall be offered at any one time that the Bad Beat Jackpot is being offered for play. No combination of the qualifying hand options shall be offered together at any time that this gaming activity is being offered.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- Players with qualifying winning and losing hands must play through the final betting round in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round, the table will be ineligible for the jackpot.
- When a qualifying hand is announced, a casino representative shall verify that both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- A minimum of three players are required to be dealt in during a Texas Hold'em game in order for players at that table to qualify for the Bad Beat Jackpot prize amount or room share percentage, as well as for a jackpot collection fee to be dropped.
- On and off duty casino employees are eligible to participate in this gaming activity.
- Both the winning and losing hands must use their two hole cards.
- In the result of copy hand, all players who tied for the winning and/or losing hand shall split the prize amount equally.
- Tournament games do not qualify for this promotion.

Prize

The jackpot prize is progressive with a minimum value of \$1,000. There is a different cap for each jackpot prize which is as follows: Ultra - \$100,000, Mega - \$50,000, and Mini - \$5,000. The Bad Beat Jackpot will be seeded by the Casino at a minimum of \$1,000 to a maximum of \$20,000 and increase each day in the amount of \$25 - \$500. Once a jackpot prize has reached its cap, no additional funds will be added to it, and shall instead be directed at the other jackpot prizes or the reserve fund. When the jackpot has been hit, the payouts will be paid according to one of the charts listed below. The jackpot prize shall be paid in the form of cash unless it is over \$10,000, in which case it shall be paid the following day via check from the gambling establishment. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how many days have transpired in order for the posted jackpot prize to increase progressively each day by the number of jackpot collection fees dropped the previous day.

Bad Beat Jackpot

Prize Payout Structure

Players that make the advertised qualifying hands shall be eligible to win their share of the posted Bad Beat Jackpot progressive prize amount, according to the payout option, as shown below. Only one of these prize payout structures shall be offered at any one time that the Bad Beat Progressive Jackpot is being offered for play. No combination of the prize payout structures shall be offered together at any time that this gaming activity is being offered.

For the **Option A** prize payout structure, 40% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying losing hand, 20% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying winning hand, 30% of the posted progressive jackpot prize amount shall be evenly divided and distributed amongst all players who played in the round, known as the table share, and 10% of the posted progressive jackpot prize amount shall be evenly divided and distributed amongst all players who were playing at any Texas Hold'em table when the Bad Beat was hit, known as the room share. If there was only one table in operation, the 10% room share amount will be added to the table share.

For the **Option B** prize payout structure, 40% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying losing hand, 20% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying winning hand, 25% of the posted progressive jackpot prize amount shall be evenly divided and distributed amongst all players who played in the round, known as the table share, and 15% of the posted progressive jackpot prize amount shall be evenly divided and distributed amongst all players who were playing at any Texas Hold'em table when the Bad Beat was hit, known as the room share. If there was only one table in operation, the 15% room share amount will be added to the table share.

For the **Option C** prize payout structure, 40% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying losing hand, 20% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying winning hand, and 40% of the posted progressive jackpot prize amount shall be evenly divided and distributed amongst all players who played in the round, known as the table share.

Bad Beat Jackpot

Funding

The Bad Beat Jackpot utilizes a progressive jackpot prize pool that is player funded.

- Within this prize pool, there will be three jackpot prizes - the Ultra, Mega, and Mini.
- There will be a \$1 jackpot collection fee taken from each pot when there is a "flop".
- The jackpot fees from the previous day will be counted, each jackpot will increase separately by \$25 - \$500 each day and the remaining money will go to the reserve fund.
- The progressive jackpot prize pool shall be initially seeded in an amount ranging from \$1,000 - \$20,000 by the Casino.
- The Casino will be reimbursed the initial seed amount from the reserve fund once sufficient monies are available.
- Once the jackpot is hit, the progressive jackpot prize pool will be reseeded in the amount of \$1,000 - \$20,000 from the reserve fund. If there are not sufficient monies in the reserve fund, the Casino will re-seed the jackpot and shall be reimbursed from the reserve fund once sufficient monies become available.
- The jackpot collection fee shall be kept in separate drop boxes apart from the regular table collection.
- The Casino will cover any shortfall and will be reimbursed once sufficient monies are available in the reserve fund.

Administrative Fees

Empire Sportsmen's Association will take an administrative fee ranging from \$6 - \$10 per table per hour. This fee will be taken from the reserve fund.

The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. - Eligible games and time periods.
- Qualifying hands and the restrictions for those hands.
- Prize payout structure.
- Jackpot prize amount.
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Big O Bad-Beat Jackpot shall be attached to the following Bureau approved controlled games offered at Empire Sportsmen's Association, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Big O (GEGR-001972)
- Big O High/Low Split (GEGR-001975)

Object and Summary

The Big O Bad-Beat Jackpot features a progressive jackpot prize, which is awarded to players participating in an eligible controlled game when a designated second hand is beaten by a better qualifying hand at the showdown. There will be a \$1 jackpot collection fee taken from the pot when there is a "flop". When the winning and losing hands are confirmed, those players with the qualifying jackpot hands shall receive the posted percentage of the progressive jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all other players at the qualifying table who have participated in the designated game, as shown below. As part of one of the options below, a posted percentage of the jackpot prize, known as the room share, shall be evenly distributed amongst all players at any other Big O or Big O High/Low table that were actively playing when the Big O Bad-Beat Jackpot hand was "hit". Players with qualifying winning and losing hands must play through the final betting round, which is after "the river," in order to qualify for the jackpot. The table will be ineligible for the jackpot if a player with one of the qualifying hands folds prior to the final betting round.

Qualifying Hands

Players that make the following advertised qualifying hands shall be eligible to win their share of one of the Big O Bad-Beat Jackpot prize amounts, as shown below. All qualifying hands within the chart must be offered together at all times. Only winning and losing hands that have been Bureau approved, pre-determined, and designated by the Empire Sportsmen's Association are eligible. In order to qualify for the jackpots, both the winning and losing hands must use two of their five hole cards. Only the highest qualifying hands will be paid. Both jackpots shall be eligible to be won, but only the highest one will be awarded if more than one is qualified for.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum of three (3) players at each table will be required in order for the table to be eligible for the promotion.
- Players must use a combination of two of their five hole cards to make their best hand possible in order to be eligible for the jackpot.
- Players with qualifying winning and losing hands must play through the final betting round, which is after "the river," in order to qualify for the jackpot.
- There is no limit as to how many times a player may win the jackpot during the promotional period.
- On duty and off duty employees of the gambling establishment are eligible to participate in this gaming activity, in or out of uniform.
- Tournament games are not eligible for this gaming activity.

Prize

The jackpot prize is progressive with a minimum value of \$500. There is no cap to of the Mega or Huge jackpots. Each jackpot will be seeded by the Casino at a minimum of \$500 to a maximum of \$15,000 and each will increase every week in the amount of \$50 to \$500 by the decision of casino management based on the previous week's take. When either jackpot has been hit, the payouts will be paid according to one of the charts listed below. There will be a board on the wall that prominently displays both jackpot amounts. Only the highest qualifying hands will be paid. The jackpot prize shall be paid in the form of cash to the player from the cage. Any prize amount over \$10,000 will be paid the following day via a check from the gambling establishment after all appropriate paperwork is completed.

Prize Payout Structure

When a player makes a posted qualifying hand in a controlled game, a casino floor person will verify the hand and determines if all policy and procedures were followed. Players that make the advertised qualifying hands shall be eligible to win their share of one of the posted Big O Bad-Beat Jackpot progressive prize amounts, according to the payout option, as shown below. Only one of these prize payout structures shall be offered at any one time that the Big O Bad-Beat Jackpot is being offered for play. No combination of the prize payout structures shall be offered together at any time that this gaming activity is being offered. Only one option may be offered at a time

Funding

The Big O Bad-Beat Jackpot utilizes a progressive jackpot prize pool that is player funded. There is no cap to the jackpot prize pool.

- Within this prize pool, there will be two jackpot prizes, the Mega and Huge jackpots.
- There will be a \$1 jackpot collection fee taken from the pot when there is a “flop” per round. The jackpot fee will be split evenly between the two jackpot prizes.
- Each jackpot will increase separately by \$50-\$500 weekly and the remaining money will go to the reserve fund.
- The Casino shall initially seed the progressive jackpot prize pool in an amount ranging from \$500 to \$15,000.
- The Casino will be reimbursed only for the initial seed amount from the reserve fund once it is collected.
- Once the jackpot is hit, the progressive jackpot prize pool will be reseeded in the amount of \$500 to \$15,000 from the reserve fund.
- The jackpot collection fee shall be kept in separate drop boxes apart from the regular table collection.
- The Casino will cover any shortfall and will not be reimbursed.

Administrative Fees

The administrative fee will range from \$6 - \$10 per hour per table that was in operation and participating in the jackpot gaming activity. This will be taken from the reserve fund. The administrative fee will cover the cost of administering the jackpot equipment such as drop box, digital display boards, pulling of drop boxes.

SUMMARY

Based on customer demand and industry trends, Empire Sportsmen's Association (ESA) proposes to modify a gaming activity that is currently approved to all Texas Hold'em games. The promotion will award players who make a qualifying hand with an instant cash prize.

PRIZE

The prize will be a fixed cash amount (paid in gaming chips) ranging from \$20.00 to \$100.00, as shown below. The prize will be awarded to a player who is playing in any Texas Hold'em poker game.

FUNDING

This promotion will be fully funded by the ESA. There will be no extra collection or fees of any kind assessed to the poker players.

NO PURCHASE NECESSARY

Any person wishing to qualify for the Bonus Poker Jackpot may do so by participating at a “No Purchase Necessary” (NPN) table. An ESA card dealer will deal cards to the NPN participant and to the empty seats. The card dealer will play the hands they have dealt to the empty seats and the NPN shall play his/her hand as they wish. This will allow the NPN player to have the same chance to win by making a qualifying hand as that of a player at a live game.

ELIGIBILITY

The promotion will be open to all players who play in a Texas Hold'em poker game. ESA may offer the jackpot during specific days and times. All such offerings will be prominently posted in the poker section of the establishment.

Object and Summary

The California Games Jackpot features a fixed prize element. Players who obtain one of the following qualifying hands during the promotion will receive a ticket to be entered into a drawing to be held at a later time. During predetermined and posted times and intervals during the promotion, a casino representative will announce the commencement of the drawing and collect all tickets from players who have earned them. Those tickets will be placed in a bin and thoroughly mixed. A casino representative will randomly draw one ticket at a time from the bin. The player who has their ticket drawn will be awarded the posted prize. If the winner of the drawing is not present, their ticket will be placed back into the bin and another will be drawn. Eligibility Requirements

The prize will be a fixed amount ranging from \$25.00 to \$500.00 in casino chips for the player who has made a high hand and had the hand documented on a white board that will be located near the poker area of the cardroom. Such documentation will be recorded by a floorperson.

FUNDING

This promotion will be solely funded by ESA. There will be no extra collection or fees of any kind assessed to the poker players.

NO PURCHASE NECESSARY

A person who wishes to participate in this promotion for free, on a “no purchase necessary” (NPN) basis may do so by being at the NPN poker table at the specified time as in the live game. The NPN player must adhere to all rules as the live player, which they must stay and play for the entire time period.

An ESA card dealer will deal the cards to the NPN player(s) and to all empty spots simulating a full game. All hands will be monitored and played by the dealer to simulate a live game. No collection, fees, or wagers will be made at this table.

ELIGIBILITY TO WIN

The promotion will have two times during the day where the high hand, beginning with a minimum of a full house, will be recorded. The first session will run from 10:00 AM to 6:00 PM. The second will be from 6:00 PM until closing.

The winning player will have 24 hours to claim their prize. Please note that the player does not have to continually play during this time period. A standard poker game of at least three (3) players must be involved in the game.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Empire Sportsmen's Association at all times the promotion is being offered:

- Eligible games and time periods.
- Coupon and/or free play chip value(s).
- Procedures to redeem coupons or free play chips.
- Any other applicable restrictions.

Controlled Game

The Match Play Coupon Promotion may be attached to all limits and versions of the currently Bureau approved California games offered at the Empire Sportsmen's Association. All base game rules will be played as previously approved by the Bureau of Gambling Control.

Rules of Play

Patrons are awarded match play or free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Players who receive a match play or free play coupon will be eligible to win the specific amount printed on the coupon if he/she places a wager on an eligible game equal to the amount listed on the match play coupon.

Prize

The match play coupons and/or free play chips shall have a value ranging from \$5 to \$500 for each coupon or free play chip. Players shall not exchange match play coupons or free play chips for live chips. Additionally, players shall not give match play coupons or free play chips to another player. The coupons and chips shall only be redeemed after having been played and verified by a key employee.

Match Play Coupon

The Casino will offer match play coupons having a face value from \$5 to \$500 per coupon. The amount will be clearly stated on the coupon. Each coupon will state the specific qualifying game(s) that the voucher may be used on. The wager must be equal to the amount of the match play coupon and a player's winning hand will be paid his/her wager as well as the listed amount on the match play coupon. Match Play Promotion

EXAMPLE: *A person receives a match play voucher with a value of \$5.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. The collection fee is based only on the wager and not the coupon. If the player wins the hand, he/she will receive \$10.00 just as if they had placed a \$10.00 bet and the player-dealer will collect the voucher.*

Free Play Chip

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The free play chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips shall initially be in the form of a coupon which shall be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Each coupon shall state the specific qualifying game(s) that the free play chip(s) may be used on.

Promotional chips shall be used as the player's bet and placed on the betting circle. Promotional chips shall not be taken into the dealer's tray, nor shall they be paid from the dealer's tray. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player-dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

Object and Summary

The Tahoe Pineapple Jackpot features a progressive jackpot prize, which is awarded to players participating in an eligible controlled game when a designated second hand is beaten by a better qualifying hand at the showdown. There will be a \$1 jackpot collection fee taken from the pot when there is a "flop". When the winning and losing hands are confirmed, those players with the qualifying jackpot hands will receive the posted percentage of the progressive jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the table share, will be evenly distributed amongst all other players at the qualifying table who have participated in the designated game, as shown below. As part of one of the options below, a posted percentage of the jackpot prize, known as the room share, will be evenly distributed amongst all players at any other eligible tables that are actively playing when the Tahoe Pineapple Jackpot hand was "hit".

Qualifying Hands

Players that make the following advertised qualifying hands will be eligible to win their share of one of the Tahoe Pineapple Jackpot prize amounts, as shown below. All qualifying hands within the chart must be offered together at all times. Only winning and losing hands that have been Bureau approved, pre-determined, and designated by the Empire Sportsmen's Association are eligible. Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum of three players are required to be dealt in during an eligible game in order for players to be eligible and the tables to qualify for the Tahoe Pineapple Jackpot prize amount and room share percentage, as well as for a jackpot collection fee to be dropped.
- Players with qualifying winning and losing hands must play through the final betting round in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round, the table will be ineligible for the jackpot.

***If there was only one table in operation, the room share amount will be added to the table share.

Funding

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity. The eligibility requirements are as follows:

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. Once the casino verifies the progressive win, the supervisor will press the confirm button. To complete the action, a casino representative's card swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
2. Once the house dealer reconciles all action, the house dealer presses "End Game." This resets the system to begin the next hand.
3. Once the casino representative's card is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.

Free Play Promotion

Bureau Requirements

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Empire Sportsmen's Association at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Free Play or Match play Coupon values
- Procedures to redeem Free Play or Match play Coupons
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Free Play Promotion shall be attached to all Bureau approved California games offered at Empire Sportsmen's Association at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

Patrons are awarded Free Play or Match Play Coupons via advertisements in magazines, websites, mailing advertisements, handed out at various events or locations, while playing a controlled game within Empire Sportsmen's Association or at the cashier window, winning a Bureau approved promotion, or signing up for a Bureau approved tournament, etc. Players with the Match Play/Free Play Coupons will be eligible to win the specific amount printed on the chip/coupon if they place a wager on an eligible game equal to the amount listed on the Match Play Coupon/Coupon; Free Play is a standalone wager. Players will be paid accordingly to the amount listed on the Free Play Chip/Coupon without placing a wager with live chips.

Free Play or Match Play Coupon

The free play coupon may have various forms, such as a paper coupon, a specially designed and designated chip with the words "free play" or "match play" printed on them and distinctly different from Empire Sportsmen's Association's live chips, postcards, etc. All coupons will have the name of the promotion and the BGC ID designator on them along with other required disclaimers such as the problem gambling message.

The player may use the free play coupon by itself or in combination with live chips as well. The free play or match play coupon may be used to place a bet on a bonus bet when a base game wager is made as well in the same hand of play.

Match Play Coupon

- Empire Sportsmen's Association will offer Match Play Coupons having a face value of \$5 to \$500 per coupon. The amount will be clearly stated on the coupon.
- The match play coupons are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.
- The player must place the Match Play Coupon on the table as well as a wager equal to or more than the amount of the Match Play Coupon.

Free Play Promotion

- When the player uses a Match Play Coupon and the hand wins, the player will be paid for the total wager in live chip(s) plus the Match Play Coupon value. The used Match Play coupon is given to the TPPPS or patron in the player-dealer position and cannot be used again. The player-dealer will take any used Match Play Coupons to the cage to be exchanged for live casino chips for the value listed on the coupon.
- When the player uses a Match Play Coupon and the hand loses, the player will only lose their original wager. The used Match Play coupon is given to the TPPPS or patron in the player-dealer position and cannot be used again. The player-dealer will take any used Match Play Coupons to the cage to be exchanged for live casino chips for the value listed on the coupon.
- If the player pushes (receives no action), the coupon may be played again until the player wins or loses a hand.

EXAMPLE: *A player receives a match play voucher with a value of \$5 that specifically states it may be used to place a wager on a Pai Gow Poker table. The player would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. The collection fee is based only on the wager and not the coupon. If the player wins the hand, they shall receive \$10 just as if they had placed a \$10 bet and the player-dealer will collect the voucher.*

Free Play Coupon

- Empire Sportsmen's Association will offer Free Play Coupons having a face value of \$5 to \$500 per coupon. The amount will be clearly stated on the coupon.
- The player must place the Free Play Coupon on the table. An additional wager is not necessary.
- Players can use Free Play chips in conjunction with live casino chips.
- Free Play chips can only be used on any California Game.
- When the coupon is used by players not taking the player-dealer position, the coupons will be reconciled at time of play. The player-dealer will have all coupons reconciled at the end of their gaming day.
- When the player uses a Free Play coupon and the hand wins, the player will be paid for the total wager in live casino chips. The player will retain the Free Play coupon to be used again.
- When the player uses a Free Play coupon and the hand loses, the player will lose their original wager. The used Free Play Coupon is collected and voided. The coupons are given to the player-dealer to be redeemed by a casino representative.
- If the player pushes (receives no action), the coupon may be played again until the player wins or loses a hand.
- Free Play Coupons play until the wager loses.

EXAMPLE: *A person receives a free play chip coupon for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play.*

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

Free Play Promotion

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Empire Sportsmen's Association at all times the gaming activity is being offered for play:

- Eligible games
- Eligible time period(s)
- Drawing dates and times
- Prize that shall be available to win for each drawing
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Ultra Lucky Seat Promotion shall be attached to all Bureau approved California games offered at Empire Sportsmen's Association at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Ultra Lucky Seat Promotion features player-funded fixed prizes. Players participating in an eligible game and whose table has been randomly selected, will have the chance to win the predetermined and posted prize by selecting a card that is higher in rank than the cards selected by all other players at the table.

This promotion is made up of two parts a drawing which selects a table, and a card selection which determines a winner. The procedures are as follows:

Drawing

- The Casino will provide cards, balls or lammers that represents each eligible table on the floor.
 - All cards, balls or lammers will be equal in size, shape and color and will depict a number that corresponds to an eligible table in the casino.
- The cards, balls or lammers will be placed in a bin, basket, or other non-electronic randomizer to be mixed.
- At a predetermined day and time a casino representative will announce the commencement of the drawing and will mix the cards, balls or lammers within the randomizer.
- Once the mixing is complete, the casino representative will draw one card, ball or lammer and read the number out loud.
- The table with the corresponding selected number will be the selected table.
- After the table has been selected the card, ball or lammer will be returned to the randomizer to be used in future drawings.

Ultra Lucky Seat Promotion

Card Selection

- Once the selected table has been established the casino representative will then go to the selected table and will instruct the house dealer to shuffle and fan out a deck of cards face down.
- All players at the table will be allowed to select a card.
 - Card selection will begin with the player left of the house dealer and will continue clockwise until all players have selected a card.
 - Backline bettors will select a card immediately after the seated player they are behind and before the next seated player.
- The rank of each card used, in order of highest to lowest rank, will be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2.
- The rank of each suit, in order of highest to lowest rank, will be: spades, hearts, diamonds, and clubs.

- A minimum of two seated players, the player and the player-dealer, are required to be participating in the controlled game in order for the table to be eligible for the promotion.
- There are no time requirements necessary to qualify for this promotion.
- There is no limit to the number of times a table may be selected during the promotional period.
- There is no limit to the number of times a player may win a prize during the promotional period.
- Players shall be eligible to win regardless of the outcome of the base game.
- Backline bettors are eligible for this promotion.

All advertisement material shall state "No Purchase Necessary" when referencing the Ultra Lucky Seat Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Object and Summary

A player who obtains a predetermined qualifying hand during a predetermined and posted time period and shall be given a drawing ticket that will enter them into a drawing. The ticket shall be filled out with the player's name, and the game which was played when they made the qualifying hand, which will be verified by an Empire Sportsmen's Association representative then placed into a barrel or other non-electronic randomizer and the ticket(s) will be drawn at posted times. - Three Card Poker (GEGR-000907)

Object and Summary

The object of the Three Card Poker Progressive Jackpot is for participating players to achieve a qualifying hand, as shown below, in order to win a fixed or progressive prize.

1. To begin each round, players must make their regular base game wager. Players may optionally place any bonus bets and optional \$1 jackpot fee. Players who do not make a base game wager are not eligible to place a jackpot fee.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a live casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
 - a. Should the sensor malfunction, the chips will be returned to the players and no jackpot will be offered during that time, until the malfunction is fixed.
3. Once all players place their controlled game wagers, any bonus bets, and jackpot fees, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
4. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

Three Card Poker Progressive Jackpot

Qualifying Hands

When a player is dealt an ace, king and queen of spades, hearts, or clubs, based on the Qualifying Hand Payout Chart Option chosen below, the player is paid from the progressive jackpot shown on the progressive meter. When a player is dealt an ace, king and queen of either hearts, diamonds, clubs, or spades, based on the Qualifying Hand Payout Chart Option chosen below, the player is paid 10% of the progressive jackpot shown on the progressive meter. Any straight flush, a hand consisting of three cards of the same suit in consecutive ranking, other than ace, king and queen, receives a fixed prize amount. The fixed prize payout does not get deducted from the amount shown on the meter.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A minimum of two active players, including the player-dealer, are required to qualify for this gaming activity.
- Only seated players, who have placed the optional \$1 jackpot fee and are dealt a designated hand, are eligible for payout.
- Backline bettors are not eligible to place a jackpot fee or receive the prize amount for a qualifying hand.
- Casino employees are eligible for the Three Card Poker Progressive Jackpot only when off duty.
- Third-Party Provider of Proposition Player Services (TPPPS) are not eligible for this gaming activity.
- There is no limit to the number of times a player may win a fixed and/or progressive prize during the promotional period.
- Tournament games do not qualify for this gaming activity.
- A player may qualify to win a prize regardless of the base game outcome.

Three Card Poker Progressive Jackpot

Fixed Prizes

When a player is dealt a straight flush, they are paid a fixed prize amount according to the payout table above.

- If more than one fixed prize winning hand hits at the same time all winning players will be paid the corresponding fixed prize amount.
- All fixed prize payouts will be paid from the Three Card Poker Progressive Jackpot reserve fund.
 - If the reserve fund is depleted the Casino will make up the short fall and will not be reimbursed.

Envy Bonus

When a player hits a hand associated with any envy pay and is awarded the Progressive Prize, players who place a \$1 jackpot fee will qualify for an Envy Bonus payout. The Envy Bonus payout is a fixed prize amount according to the payout table above.

- \$100 will be awarded to players who placed a \$1 jackpot fee and are seated at the same table as a player who wins the Progressive Prize.
- The player who wins the Progressive Prize will not qualify for the envy payout.
- If a player's hand triggers an Envy Bonus payout, the house dealer will leave the hand face-up on the layout; otherwise, the dealer will lock up the cards. The dealer will then move on to the next player.

Three Card Poker Progressive Jackpot

- The house-dealer pays any Envy Bonus payouts at the end of the round.
- All Envy Bonus payouts will be paid from the Three Card Poker Progressive Jackpot reserve fund.
 - If the reserve fund is depleted the Casino will make up the shortfall and will not be reimbursed.
- In the event that multiple players achieve a hand associated with an envy pay then all eligible players will win multiple Envy Bonus payouts.

All monies paid out will be tracked both electronically and on a hand written log to be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

Funding

The Three Card Poker Progressive Jackpot is a player-funded jackpot with both fixed and progressive prizes. The jackpot is funded by an optional \$1 jackpot fee, which is paid by players in order to be eligible for the prizes mentioned above. The \$1 jackpot fee, paid by each player, will be broken down as follows:

- \$0.31 will be immediately posted on the jackpot meter.
- \$0.69 will be tracked in the Three Card Poker Progressive Jackpot reserve fund.

The Casino will initially seed the jackpot meter at the amount of \$1,000. Once there are sufficient monies in the reserve fund, the initial seed will be reimbursed to the Casino from this reserve fund. There is no cap to the Three Card Poker Progressive Jackpot meter.

After the progressive jackpot is hit, the jackpot meter will be re-seeded by the reserve fund at an amount between \$1,000 and \$5,000. In the event that the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the reserve fund, the re-seed amount will be reimbursed to the Casino from the reserve fund.

All increases and decreases to the Three Card Poker Progressive Jackpot reserve fund and jackpot meter shall be documented in the accounting records.

Administrative Fees

The Casino will retain an administrative fee ranging from \$16 to \$28, taken per table per hour. The administrative fee will be taken from the reserve fund. The fee shall be used for the operation costs and the administration of the jackpot.

No Purchase Necessary

The Three Card Poker Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Three Card Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Three Card Poker Progressive Jackpot

Equipment

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. Once the casino verifies the progressive win, the supervisor will press the confirm button. To complete the action, a casino representative's card swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
2. Once the house dealer reconciles all action, the house dealer presses "End Game." This resets the system to begin the next hand.
3. Once the casino representative's card is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.
