BIG MONDAY PROMOTION

- This promotion will be associated with all of our poker games. These games include all limit, no-limit, and pot-limit Texas Hold'em and Omaha games along with our instructional tables, and our no purchase necessary tables.
- 2) Cash prizes are being awarded.
- 3) The base amount of the cash prize will remain fixed. However, additional money can be won during the play of the bonus game.
- 4) This gaming activity is house funded.
- 5) No fee will be collected.
- 6) This is not any form of a jackpot so there is no seeding or re-seeding.
- 7) The prize will be distributed to the winner. However, in one of the bonus games, all of the players at lucky tables will also be winners.
- 8) As stated earlier, this is not a jackpot, thus no re-seeding.
- 9) There is no minimum number of players required. There is no purchase necessary, so there is no need to be playing in a game to win.
- 10) No fees will be retained.
- 11) Yes, anyone can sign up on the basketball grid; there is no purchase necessary. You do not need to be playing at a poker game to win the cash prizes. In addition, all tables including our no purchase necessary and instructional tables are eligible to win the "table prize" described below.
- 12) Drafts of our flyers will be attached.
- 13) No copyright, license, or patent exists to the best of our knowledge.
- 14) Equipment needed for this promotion include a basketball game called "Super Shot" (it consists of an seven-foot basket, four basketballs, protective netting above and to the sides, a ramp that returns the ball to the player, a timer, a sensor that tells if a basket is made, along with an electronic scoreboard), a ten by ten grid exactly like one used for "football pools", and several TV's tuned to ESPN.

A detailed explanation of the promotion follows:

This promotion will be run in conjunction with the "Big Monday" college basketball games show on ESPN that features three basketball games that start at 4pm, 6pm, and 8:59pm on Monday nights starting January 5th at 4pm. Customers will write their names in the blank squares of a "football/basketball" grid before each game starts, just like a football pool. No purchase is necessary, anyone can put their name on the grid, and there are no requirements that need to be met. At the end of each game's first half and at the end of each game, the score of the game will determine the winner of the contest by referring to the grid just like in a football pool. The winner of the pool will win \$50 and will then proceed to the "Super Shot" basketball game with the opportunity to win even more money. At the "Super Shot" game the customer will get 30 seconds to make as many baskets as he/she can. Each basket will be worth an additional \$20 on top of the \$50 already won for having the lucky square. In the event there is no name written in the winning square on the grid the \$50 will be carried over to the next week's corresponding game. For example if there is no winner of the 1st half of the 6pm game then the base prize for the 1st half of next week's 6pm game will be worth an additional \$50 (\$100 total).

As an added bonus, each table will be designated either a home team or a visiting team before the start of each game. The first team, either home or visitor, to make a successful free throw in the first half will be the "first half winners", and the last team to score in the second half will be the "second half winners". A representative from each winning table will be selected at random to play the "Super Shot" game for his or her table. They will have 30 seconds to make as many baskets as they can. Each basket will be worth \$20. The total won will be divided equally among the players at the "shooter's" table. All tables including the instructional and no purchase necessary tables will be assigned a team

The promotion is scheduled for 9 weeks, ending on March 1, 2004.

Blazing Sevens Progressive Jackpot

Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the modified Blazing Sevens Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the modified Blazing Sevens Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play the modified Blazing Sevens Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau=s cease and desist notification.

Bureau Requirements

Advertising

The Lake Elsinore Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004725) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in The Lake Elsinore Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying Hands.
- Prize payout structure.
- The prize amount that shall be awarded.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Blazing Sevens Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at The Lake Elsinore Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

Pure 21.5 Blackjack (GEGA-002884)

Object and Summary

- 1. To begin each round, players must place a base game wager in order to qualify for the jackpot. Along with any bonus bets the player places a wager on, player(s) have the option to place a \$1.00 jackpot fee and become eligible for the jackpot.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- 3. Once all players place their controlled game wagers and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the progressive gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.

4. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

Qualifying Hands

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. Only one of these prize payout options shall be offered at any one time that the Blazing Sevens Progressive Jackpot is being offered for play.

- The Third Party Provider of Proposition Player Services is not eligible for this promotion.
- Casino employees are eligible to participate in this gaming activity when they are off duty and out of uniform.
- There is no amount of players required for the jackpot, other than what is previously approved for the base game.
- A player can qualify for the jackpot element of the game regardless of the outcome of the controlled game.
- Only seated players are eligible for payouts.

Prize

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

- a. Three seven's (7s) of the same color is paid 100% of the progressive jackpot amount shown on the progressive meter.
- b. All other hands are paid a fixed amount from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the casino will make up any shortfall.
- c. In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will share, in equal amounts, the posted progressive prize or the posted fixed amount. In the event the reserve fund is depleted, the casino will make up any shortfall. All hands will be paid the posted prize.
- d. When a player has a progressive winning hand, the dealer shall press the appropriate hand button on the keypad.
- e. The house dealer shall then contact a supervisor.
- f. Once the casino verifies the progressive win, the supervisor will press the confirm button. To complete the action, a Supervisor or Executive card (depending on jackpot level) swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed

- for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
- g. When the dealer reconciles all action, he presses "END GAME." This resets the system to begin the next hand.
- h. Once the Supervisor or Executive card (depending on jackpot level) is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the award will need to be manually backed out using the Game Manager manual adjustment feature.

All fixed payouts will be paid by a Casino floor person. Once the proper paperwork has been filled out, the floor person will pay the winner(s) in casino chips. The payouts will not be made from the Casino dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund.

Funding

The Blazing Sevens Progressive Jackpot is a player funded progressive jackpot. The Casino will initially seed the jackpot at a minimum of \$1,000 and to a maximum of \$50,000. Once there are sufficient monies in the Blazing Sevens Progressive jackpot fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records.

After the progressive jackpot is hit, it will be re-seeded by the reserve fund at an amount between a minimum of \$1,000 and a maximum of \$50,000. In addition this reserve fund will payout all fixed amounts. In the event the reserve fund is depleted, the casino will make up any shortfall. Once there are sufficient monies in the Blazing Sevens Progressive reserve fund, the re-seed amount, up to the amount that the Casino funded, will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the Blazing Sevens Progressive Jackpot fund shall be documented in the accounting records.

Administrative Fees

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- a. \$0.20 will be immediately posted on the meter.
- b. \$0.80 will be tracked in a reserve fund.

The Casino will take an administrative fee ranging from \$10-\$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

No Purchase Necessary

Upon request, a NPN table will be set up where a dealer will deal hands to the player and the dealer will take the role of the player-dealer hand. Tournament chips that have no cash value will be used to simulate betting. The person(s) can play for any duration of time with no restrictions. If the player achieves a qualifying jackpot hand, he/she will be awarded that amount according to the pay table. An entry will then be made on the computer to adjust the meter immediately after the prize has been awarded.

- Any other restrictions that apply to this promotion.

Controlled Game

The Bonus Cash Promotion will be attached to all limits of Texas Hold'em Poker that have been Bureau approved at the Lake Elsinore Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control. Tournament Games are not eligible for the promotion.

Rules of Play

A prize shall be awarded to the player that completes a qualifying hand, as listed below. The qualifying bonus hand that meets all of the eligibility requirements must be verified by Lake Elsinore Casino.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed game during the pre-determined and specified hours designated for the promotion.

- There is no minimum or maximum amount of players required to be playing in a designated game in order for the table to be eligible for the promotion.
- In order to qualify for the promotion, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in the Lake Elsinore Hotel and Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament
- The game(s) that will be offered during the play of the tournament
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it will be retained by the Casino, added directly into the tournament prize pool, or any other method of retention or distribution
- The amount of tournament chips that will be awarded to each player upon entry into the tournament
- The tournament prize structure that will be offered and the number of players that will be paid
- When the patron(s) will be paid and the manner in which they will be paid
- Any other restrictions that apply to the California Games Tournaments

- Amount and reason for any deductions from the total collected prize pool
- Name of gaming activities offered (when applicable)
 - o Funding source
 - o Prize amount
 - Total number of prizes awarded
 - o Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the total amount paid out and amount paid for each place in the tournament

Eligible Controlled Games

The California Games Tournament will be attached to all Bureau approved California controlled games offered at Lake Elsinore Hotel and Casino at all times that the gaming activity is being offered for play. All controlled game rules will be played as approved by the Bureau.

- Tournament entry is open to all customers.
- The specific structure will be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices
 charged, and the amount of tournament chips provided will be equal for the initial buy-in
 and posted for all players.
- Entry may be earned by winning a previous tournament or a Bureau approved gaming activity. All gaming activities and/or promotions will be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The Casino may provide prizes or add funds to the prize pool for special events.

^{**}The service fee will be retained by the Casino and used exclusively to pay tournament staff, make upgrades to equipment, advertisements, etc. that directly benefit the tournament area and/or its presentation. This is an optional fee that tournament entrants may pay in exchange for additional tournament chips. This fee will not be included in the tournament prize pool.

***The staff appreciation fee will be retained by the Casino and used exclusively to pay tournament dealers. This will be an optional fee that tournament entrants may pay in exchange for additional tournament chips. This fee will not be included in the tournament prize pool.

California Games Tournament

- When the prize amount is guaranteed the payouts will be cash ranging from \$1-\$10,000,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, Lake Elsinore Hotel and Casino will fund the difference.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons, Lake Elsinore Hotel and Casino will determine and set the payout structure.
- When the prize is a non-cash item(s), the item(s) value will range from \$1-\$1,000,000.
 The prize(s) cost will either be funded by the Casino or reimbursed from the buy-ins, rebuys, and add-ons. Entities Involved Other Than the House

The Lake Elsinore Hotel and Casino shall not allow other entities to become involved in the play of California Games Tournaments at their gambling establishment.

CARIBBEAN STUD POKER JACKPOT

SUMMARY OF GAME

Lake Elsinore Casino proposes to add a progressive jackpot element to the game of Caribbean Stud Poker. Similar to the Jackpot games attached to Poker and Pai Gow Poker, players will be assessed a fixed fee, per hand and will qualify for a prize when a designated second hand is beaten by a designated first hand. Prizes are paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating players. Players may qualify for the full Caribbean Stud Poker Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

The rules and standards of play for the Caribbean Stud Poker Jackpots are the same as in Pai Gow Poker Jackpot Games currently been offered in Commerce and The Bicycle Casinos. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player-dealer position, collection of table fees, betting limits and how winners are determined and paid will all be consistent with the approved version of Caribbean Stud Poker.

Since the jackpot element will be added to an existing game, the only change to the equipment will be in the addition of a separate collection box, which will be secured to the table and will be designated for the Jackpot Collection and used only for the collection of the jackpot funds. This will insure that Jackpot Collections are kept separate and apart from the table fee collection.

THE PRIZE

A prize ("Jackpot Prize") will be awarded when one player at a game obtains a specified second hand but loses to a player who obtains a better specified first hand ("Qualifying Hand"). As this is a progressive jackpot, the amount of the Jackpot Prize will vary depending on the volume of play and frequency in which players obtain a Qualifying Hand. Lake Elsinore Casino will control the allocation of the Jackpot Collection to Jackpot Prize. The available Jackpot Prize will be posted on either an electronic board or poster centrally located in the California Games section of the casino. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize.

When players obtain the specified hand combination and claim the Jackpot Prize, the qualifying hands will be verified by the dealer and a floorperson. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures. The winning players' identification will be obtained and necessary paper work completed prior to the payout of the Jackpot Prizes. Lake Elsinore Casino will

record all prizes awarded and the names of the winners as part of its Caribbean Stud Poker Jackpot accounting records.

FUNDING

Caribbean Stud Poker Jackpot Prizes will be funded by a separate collection fee paid by players prior to the start of each hand ("Jackpot Collection"). The Jackpot Collection will be either 50 c or \$1.00 per hand depending on the stakes of the game. The amount of the Jackpot Collection will be posted within view of each participating table.

Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. Lake Elsinore Casino will provide the initial seeding of the Jackpot Fund and may from time-to-time provide additional infusions of money to add to the size of the pool and the excitement of the game.

The Jackpot Collection will be posted by the player in the first Player-Dealer position. When there is more than one player participating in the first Player-Dealer position, the player who has the most money in action in the first Player-Dealer position will be responsible for posting the full Jackpot Collection.

JACKPOT COLLECTION & ACCOUNTING PROCEDURES

The Jackpot Collection from all Caribbean Stud Poker will be collected, counted, secured and recorded in the same manner as the table fees paid to Lake Elsinore Casino. The dealer will collect this fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be different from the box used for table fees. The locked Jackpot Collection Boxes will be gathered by casino security staff at designated times and transported to the secure Lake Elsinore Casino count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by Lake Elsinore Casino in collecting its table fees and in other United States gaming jurisdictions. In addition, all count team activity is under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report (AJackpot Collection Report@) that will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating Caribbean Stud Poker gaming table during each shift.

NO PURCHASE NECESSARY PROCEDURES

Caribbean Stud Poker Jackpots will be offered for free, on a "general and indiscriminate" basis, to patrons who wish to participate in a No Purchase Necessary game. Lake Elsinore Casino will provide instructional tables for all patrons who request to participate in Caribbean Stud Poker Jackpots without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary instructional tables will be eligible to win the full-posted Jackpot Prize if they participate in a game where players obtain the designated Jackpot Hands.

A person(s) that comes to play the jackpot at the "no purchase necessary" table will be dealt the maximum of eight hands. The no purchase necessary player will play only one hand and the casino dealer will play the remaining.

If the player wins the jackpot, only the portion of money that his/her hand qualifies for will be paid. The remainder will remain in the jackpot fund.

This will be done in the interest of fairness and in the spirit of the law, and as to give the no purchase necessary player the maximum opportunity to win the a portion of the jackpot prize.

THIRD PARTY PROVIDERS OF PROPOSITION PLAYER SERVICES

Third Party Providers of Proposition Player Services, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("Prop Player"), are not eligible to win any portion of the Jackpot Prize. If a Prop Player receives a Qualifying Hand, its portion of the Jackpot Prize will not be paid and will remain in the Jackpot Fund. If a Prop Player is a participant in a Qualifying Hand with another player(s), the Prop Player will not be eligible to receive its portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other players.

FLAT ADMINISTRATIVE FEE

Lake Elsinore Casino will retain a flat administrative fee from the Jackpot Fund based on the number of table hours that Caribbean Stud Poker Jackpots are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the Jackpot Fund. Lake Elsinore Casino reserves the right to adjust its flat Administrative Fee based on market factors and cost of operating Caribbean Stud Poker Jackpots. Lake Elsinore Casino projects that its Administrative Fee will be in the range of \$3.00 to \$6.00 per table hour. Lake Elsinore Casino will designate the flat Administrative Fee and will provide advance ample notice of its flat fee to all customers in accordance with Regulations adopted by the California Gambling Control Commission and/or the California Division of Gambling Control Regulations.

ELIGIBILITY FOR THE JACKPOT PRIZE

Only patrons participating in the first Player-Dealer position is eligible to win the Jackpot Prize. If there is more than one player with a wager in the first player-dealer position, the Jackpot Prize will be divided pro-rata based on the amounts of their respective wagers between the players. All players in the player position, who have made a wager and have paid the table fee for any betting circle, regardless the amount wagered, are eligible to win and share the Jackpot Prize. Eligible players in the player position will share the Jackpot Prize in equal shares regardless of the amount of their wagers.

QUALIFYING HAND FOR CARIBBEAN STUD POKER

The Qualifying Hands for Caribbean Stud Poker Jackpots are:

1. <u>Bad beat Jackpot</u> Any flush (Second hand) beaten by higher flush or better ("First hand")

After the winning hands in a Bad Beat Jackpot are confirmed, the player who lost with the designated second hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand

 Super Jackpot: A full house ("second hand") beaten by the higher full house or better ("first hand").

After the winning hands in a Super Jackpot are confirmed, the player who lost with the designated second hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

3. **Royal Jackpot**: A Straight or less ("second hand") beaten by a Royal Flush ("first hand").

After the winning hands in a Royal Jackpot are confirmed, the player who lost with the designated hand will receive twenty (20%) percent of the posted Jackpot Prize for that game, the player with the designated best hand will receive sixty (60%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

CA/Asian & Poker Gaming Activity

SUMMARY

Based on customer demand and industry trends, the Lake Elsinore Casino (LEC) proposes to add a gaming activity to the currently approved Three Card Poker, Blackjack, and all Poker games. The promotion will award players who play in the controlled games listed above and make designated qualifying hands.

BASE GAME RULES

All base game rules that have been approved by the Bureau of Gambling Control for all currently approved controlled games will be followed. There are no changes whatsoever.

PRIZE

The prize will be a fixed amount, in the form of cash or casino chips, ranging from \$10.00 to \$250.00. The prize amount will be based on qualifying hands made within a given level of play (see example card for more detail).

FUNDING

This promotion will be funded solely by the Lake Elsinore Casino. There will be no extra collection or fees of any kind assessed to the poker players.

ELIGIBILITY

One hundred percent (100%) of the posted prize amount will be awarded to any player, participating in designated games, that makes the designated qualifying hands and completes a level. Once a patron receives stamps on all qualifying hands for any given level, they may redeem the designated amount of cash for the given prize level.

- There is no minimum number of players to qualify for the prize.
- Players may have multiple cards but stamps are not counted together. Each card will be looked at and counted individually. For instance, if a player has two cards and completes two qualifying hands on one card and two on the other card for the \$10 level, this does not constitute a complete level. All stamps for any given level must be completed on one card to be eligible for the prize amount.
- Players may cash in the only the highest completed level for each game. For instance, if a player has completed the \$10 level and the \$250 level for Three Card Poker, only the \$250 level may be redeemed. If the \$100 level for Blackjack has been completed as well, that level may be redeemed at the same time.
- Once a card has been redeemed for any prize level(s), the card will be considered void and may not be redeemed for any other prize levels.
- Cards must be intact as a whole to be eligible for a prize.
- Stamps are issued only to a player completing a required hand.

NO PURCHASE NECESSARY

The gaming activity will be offered to customers who wish to participate for free, on a general and indiscriminate basis. LEC will offer a No Purchase Necessary table for all customers requesting to participate for the Cash Me In gaming activity without requiring them to pay a table fee, jackpot collection, or any type of consideration. There will be no live wagers at these tables. Participants at the no purchase necessary tables will be eligible to win the posted prize amount for any given level once all qualifying hands for that level have been stamped.

A Casino card dealer will deal the cards to the NPN player(s) and to all empty spots simulating a full game. All hands will be monitored and played by the dealer to simulate a live game. No collection, fees, or wagers will be made at this table. Advertisements and rule sheets will state no purchase necessary and direct patrons to management for details.

Cash Me In; various other names may be used as well.

Should the Casino advertise a name other than "Cash Me In", any advertisements will always have the corresponding ID number, assigned by the Bureau of Gambling Control (Bureau), to assist in identifying the promotion as approved by the Bureau.

2. Name each controlled game that is associated with this gaming activity.

All poker games, Three Card Poker, and all Blackjack games.

3. Describe any jackpot or any other type of prize awarded.

The prize will be a fixed amount, in the form of cash or casino chips, ranging from \$10.00 to \$250.00.

4. If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?

The cash prize is fixed based on the qualifying hands made within a given prize level.

5. Explain if the gaming activity Is house funded or player funded.

The activity is house funded.

Describe any special fee collection involved in this gaming activity. For example: jackpot fee collection.

No extra or special fees are collected.

7. Describe how the jackpot will be seeded and how any prizes will be awarded.

Each prize pool will be initially seeded and reseeded by the house.

The NPN player must adhere to all rules as the live player. All advertisements will state "No Purchase Necessary" for the promotion.

14. Identify any entity or person other than those licensed as the house involved in the gaming activity.

There are no other entities or persons involved in this promotion.

15. Describe the type of table and equipment utilized for the gaming activity.

No equipment other than the equipment utilized in the base game will be used.

FULL HOUSE OR BETTER PROMO

- 1) The promotion will involve all Texas Hold'em and Omaha games.
- There will be a cash prize given away for certain qualifying hands.
- 3) The prize amounts although varying randomly will be of fixed amounts.
- 4) The casino will fund the promotion/activity.
- 5) No special fees or collections will be charged.
- 6) It is not a jackpot, so there is no "seeding" involved. However, as stated above, the casino will be funding the promotion.
- 7) Prizes will be given to players showing down qualifying hands.
- 8) There will be a limited number of envelopes for each day.
- 9) A minimum of four (4) players must be dealt in to qualify for the bonuses.
- 10) Since the promotion is house funded, there will be no fee or administrative fee charged.
- 11) As with all of our existing promotions, players are able to play on our No Purchase Necessary Tables and qualify for the bonuses without playing for real money.

Sealed envelopes containing a single \$10, \$25, or \$100 chip will be awarded for anyone showing down a full house or better in any Hold'em game and nines (9's) full or better in any Omaha game. The envelopes will be randomly selected. There will be a certain number of envelopes allocated for each day of the promotion.

SECTION III - JACKPOTS, CASHPOTS, BONUSES, PROMOTIONS, ETC

- 1. The name of the proposed gaming activity is "The Jackpot Multiplier Wheel".
- 2. All Texas Hold'em games participate in this promotion.
- 3. On selected days and hours, the Texas Hold'em Jackpot will be increased by the amount indicated by a spin of the "Jackpot Multiplier Wheel". In addition to the jackpot increase, the customer randomly selected to spin the wheel will also win a cash prize amount posted along side the increase amount.
- 4. Please see detailed description.
- This activity is funded from the Texas Hold'em Jackpot fund. This fund comes from the players.
- No additional fees, other than the normal jackpot fee collection, are involved with this activity.
- The seeding and awarding of cash prizes is the same as all Texas Hold'em Jackpot games.
- 8. Prize distribution is the same as all Texas Hold'em Jackpot games. (40% for the losing hand, 20% for the winning hand, and 40% split among the remaining players at the table).
- 9. The reseeding of the jackpot will be the same as all Texas Hold'em Jackpot games.
- 10. A minimum of four (4) players must be dealt in to be eligible for the jackpot. No maximum number of players is specified, though generally a full table is nine (9) or sometimes ten (10) players.
- 11. The house retains an administrative fee from the Jackpot fund. No additional fees are collected or retained for the "Jackpot Multiplier Wheel" promotion.

15. A wheel similar to the "Big Six" wheel found in many casinos will be used for this activity. The signage on the wheel will be modified for the purpose of this promotion.

A detailed description follows:

On selected days and hours the Texas Hold'em jackpot will be raised for one hour. The amount the jackpot is raised will be determined by the spin of the "Jackpot Multiplier Wheel". After an hour has passed, the jackpot will revert back to the original amount.

A customer will be selected at random (by table number and seat number) to come up and spin the "Jackpot Multiplier Wheel". Each space on the wheel will contain both a jackpot increase amount (2x, 3x, 4x, 5x, \$10,000 added, \$20,000 added, \$75,000, and \$125,000) and a cash prize amount (\$50, \$75, \$100, \$200, \$750, and \$1250). The cash prize amount will be awarded to the spinner of the wheel. The Jackpot will be increase by the amount indicated by the wheel. For example, if the jackpot is at \$15,000 and the wheel stops at 3x---\$75, the jackpot would by raised to \$45,000 (\$15,000 times 3) for one hour and spinner would get \$75. Or if the jackpot was at \$18,000 and the wheel stopped at \$20,000 added---\$200, the jackpot would be raised to \$38,000 (\$18,000 plus \$20,000) for one hour and the spinner would get \$200. Finally, if the jackpot was at \$22,000 and the wheel landed on 5x---\$100, the jackpot would be raised to \$110,000 (\$22,000 times 5) and the spinner would get \$100.

All live, instructional, and no-purchase necessary tables that are playing Texas Hold'em are eligible to win the jackpot. Additionally, players are any of these tables are eligible to be randomly selected to spin the wheel.

All jackpot rules and regulations remain in effect for this promotion. Both the cash prize amounts and jackpot amounts (if hit) will be awarded out of the jackpot fund, which is player funded.

Jackpot hand, the player with the "bad Beat" (second best) qualifying hand will receive forty (40%) percent of the posted amount. The player who beats the "bad beat" qualifying hand will receive twenty (20%) percent of the posted amount. The remaining forty (40%) is distributed evenly to the other players at the winning table.

An analysis of the California Jackpot game format noted the following:

The house never participates as a player.

2. The house never takes a percentage of the wagers.

3. Players can win without paying a fee.

It is clear that the format of California Jackpot is not one of the listed games nor is it a banking or percentage game, thus the format would be legal under California Penal Code Section 330.

The next question would be if the format of California Jackpot would violate California Penal Code Section 319, specifically the element of "consideration." The fact that the sponsor's business is enhanced does not provide the consideration necessary to make this type of promotion a lottery.

The format of California Jackpot has no banking or percentage issues, and the currently proposed format has eliminated the element of consideration from the lottery section. Thus, the format does not violate California Penal Sections 319 or 330.

There is a free instructional table for the customers to participate in to learn how to play poker. The customers playing in the free instructional table are eligible for the jackpot.

The collection fee paid by the players will be \$1.00 per hand.

The qualifying hand in Hold-em is Aces full of Jacks or better Beaten by 4 of a kind.

The qualifying hand in Omaha is 4 nines or better beaten.

No Purchase Necessary

A designated table will be set-aside for a player to participate in the jackpot at a no purchase necessary to the customer. The player will play at the "Instructional Table" At that time, if the bad beat bonus is won then the player can be eligible to collect his/her designated share of the bad beat. This will be available 24hrs each day.

Prizes are distributed from a prize pool funded through fees paid by participating players. Players can qualify for the full prize without paying a fee, or other consideration, by participating in a free instructional game where there is no live wagering, no jackpot collection, and no table fees.

The jackpot prizes will be funded by a separate collection fee paid by players prior to the start of each hand. The Lake Elsinore Casino will provide the initial seeding of the jackpot fund and may, from time-to-time, provide additional infusions of money to add to the size of the pool, and the excitement of the game. The jackpot fees from all poker games will be collected, counted, secured, and recorded in the same manner as the table fees paid to the Lake Elsinore Casino. The jackpot collection boxes will be different from the box used for table fees. The total dollar volume of the chips taken from each jackpot collection box shall be recorded on a Daily Jackpot Collection Report that will be maintained as an accounting record and shall be available for audit and inspection.

The Lake Elsinore Casino will accumulate the jackpot collections in a secure account until a player achieves a designated prize hand and a prize is paid. The Lake Elsinore Casino will obtain the name and address of each winner and will record this information along with the amount of the prize in it accounting records.

All the money posted by players will go directly to the jackpot fund, minus a <u>flat</u> <u>administrative fee</u> based on market factors and cost of operating California Jackpots. Lake Elsinore Casino projects its administrative fee will be \$2.00 to \$8.00 per table hour, to be taken from the jackpot drop. Lake Elsinore Casino will designate the flat administrative fee and will provide advance notice of its flat fee to all customers in its rulebook, in accordance with regulations adopted by the California Gambling Control Commission and/or The California Division of Gambling Control Regulations. SECTION III - JACKPOTS, CASHPOTS, BONUSES, PROMOTIONS, etc

- 1. The name of the proposed activity is the "Pick the Super Bowl Champion Drawing".

Advertising

Lake Elsinore Hotel and Casino may advertise various names for this gaming activity. <u>Should the Casino advertise a different name, the BGC ID (GEAR-001195) shall be referenced on all advertisements relating to this gaming activity.</u>

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Lake Elsinore Hotel and Casino at all times the gaming activity is being offered for play:

- Eligible games
- Eligible time period(s)
- Prize amount and prize type
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Lucky Table Lucky Seat gaming activity shall be attached to all Bureau approved games offered at Lake Elsinore Hotel and Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Lucky Table Lucky Seat gaming activity features a promotional element where players playing in any of the above games have a chance to win a pre-determined and posted prize.

The Lucky Table Lucky Seat gaming activity involves a drawing where a bin, basket, lottery ball machine, or other non-electronic randomizer will be used. During predetermined times and intervals of the promotional period, a casino representative will announce the commencement of the drawing. The drawing to determine the lucky table and lucky seat uses cards, balls, or lammers, which are pre-printed, equally sized and colored. For the lucky table drawing, a card, ball or lammer that represents each active table will be mixed within the randomizer. A casino employee will then select one to determine the winning table. Once the eligible table is determined, the lucky seat will be determined by placing cards, balls, or lammers into the randomizer and selecting one. The number of seats at the winning table determines the amount of cards, balls, or lammers that will be placed into the randomizer (e.g. if the table has 7 seats, then 7 cards, balls, or lammers would be placed into the randomizer). If no one is sitting at the selected seat, another card, ball, or lamer will be drawn until a winner is chosen. Once the table number and seat number are determined, the player sitting at the selected seat will win the predetermined and posted prize.

Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There are no time requirements necessary to qualify for this promotion.
- There is no limit to the number of times a player may win a prize during the promotional period.

- For California games, a minimum of two seated players (the player and the playerdealer) are required to be participating in the controlled game in order for the table and seat to be eligible to win the prize.
- For poker games, a minimum of two seated players are required to be participating in the controlled game in order for the table and seat to be eligible to win the prize.
- Poker players with chips on the table are eligible to participate in this promotion.
- In California games, players who wagered on the previous hand are eligible for this promotion.
- If a player is playing two hands (for California Games), only the seat the player is actually occupying is eligible for this promotion.
- Casino employees are eligible to participate and win the gaming activity when off duty and out of uniform.
- The player-dealer position is not eligible for the promotion.
 - If the card, ball, or lammer drawn is the seat represented by the player-dealer, another card, ball, or lammer will be drawn until a winner is selected.
- Backline bettors are not eligible for this promotion.
- Tournament games are not eligible for this promotion.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to participate in this promotion on or off duty.
 - If the card, ball, or lammer drawn is the seat represented by the Third-Party Providers of Proposition Player Services (TPPPS), another card, ball, or lammer will be drawn until a winner is selected.
- Once the lucky table and lucky seat have been selected, the corresponding lammers will be placed back in the randomizer and will be eligible to be drawn again during the same promotional period.

Prize

When a table and seat are selected, the prize amount will be awarded to the player sitting in the selected seat. The prize will be a fixed and predetermined amount ranging from \$5 to \$100,000 in the form of cash, live casino chips, clothing, trips, merchandise, vehicles, electronics, special event entry fees, tickets for the Gobble up the Green Cash Drawings Promotion (GEGA-001889), tickets for the New Year's Eve Cash Giveaway (GEGA-000216), points for their Player's Rewards Program (GEGA-03654), entry into the Super Bowl Promotion (GEGA-001886) and/or coupon for the Match Play Promotion (GEGA-003902).

In addition to an above prize, players may also win a ticket or device (such as a car key) that will be used to determine a group of winners that may have a chance to win an additional prize such as a chance to win a vehicle or a chance to draw from a group of envelopes which contain various cash amounts.

Example: On a particular Sunday a Lucky Table Lucky Seat will be selected every hour for a continuous 8 hour period. During the time period a player will be awarded \$100 in casino chips and a key that may open a car on display. When all 8 keys are handed out, the players will all have a chance to use their key to see which one opens the car and be awarded such.

All prizes for this promotion will be pre-determined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

Lucky Table Lucky Seat

Once the proper paperwork has been filled out, the prize will be paid out immediately by a casino representative. Payouts will not be made from the house dealer's tray; live casino chips will come from the cage.

Funding

The Lucky Table Lucky Seat will be fully funded by Lake Elsinore Hotel and Casino. There will be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

Administrative Fees

Lake Elsinore Hotel and Casino will not retain an administrative fees, as this promotion is house funded.

No Purchase Necessary

The Lucky Table Lucky Seat will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material will state "No Purchase Necessary" when referencing the Lucky Table Lucky Seat. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

Match Play Promotion

Advertisement Requirements

Lake Elsinore Casino may advertise various names for this gaming activity. Should the Lake Elsinore Casino advertise a different name, the BGC ID listed below shall be referenced on all advertisements relating to the Match Play Promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Lake Elsinore Casino at all times the promotion is being offered:

- Eligible games and time periods.
- Coupon and/or free play chip value(s).
- Procedures to redeem coupons or free play chips.
- Any other applicable restrictions.

Controlled Game

The Match Play Coupon Promotion may be attached to all limits and versions of the currently Bureau approved California games offered at the Lake Elsinore Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

Rules of Play

Patrons are awarded match play or free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Players who receive a match play or free play coupon will be eligible to win the specific amount printed on the coupon if he/she places a wager on an eligible game equal to the amount listed on the match play coupon.

Prize

The match play coupons and/or free play chips shall have a value ranging from \$5 to \$500 for each coupon or free play chip. Players shall not exchange match play coupons or free play chips for live chips. Additionally, players shall not give match play coupons or free play chips to another player. The coupons and chips shall only be redeemed after having been played and verified by a key employee.

Match Play Coupon

The Casino will offer match play coupons having a face value from \$5 to \$500 per coupon. The amount will be clearly stated on the coupon. Each coupon will state the specific qualifying game(s) that the voucher may be used on. The wager must be equal to the amount of the match play coupon and a player's winning hand will be paid his/her wager as well as the listed amount on the match play coupon. When the player uses a match play coupon and the hand loses, the player will only lose his/her original wager and the match play coupon is collected and voided. The player-dealer will then have a key employee sign the voucher verifying that it has been won. All winning vouchers are

verified and signed by a key employee. Winning vouchers are taken to the cage by the key employee, logged, and exchanged for the value listed on the coupon(s). If a player loses, the money part of the wager is collected by the player-dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

EXAMPLE: A person receives a match play voucher with a value of \$5.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. If the player wins the hand, he/she will receive \$10.00 just as if they had placed a \$10.00 bet and the player-dealer will collect the voucher.

Free Play Chip

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The free play chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips shall initially be in the form of a coupon which shall be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Each coupon shall state the specific qualifying game(s) that the free play chip(s) may be used on.

Promotional chips shall be used as the player's bet and placed on the betting circle. Promotional chips shall not be taken into the dealer's tray, nor shall they be paid from the dealer's tray. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player/dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand

EXAMPLE: A person receives a free play chip coupon for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play.

Match Play Promotion

Eligibility

The promotion will be open to all players who are seated and playing at the above listed games during the pre-determined and specified hours designated for the promotion.

- A minimum of two (2) players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- Each coupon will state the specific qualifying game(s) that a player may use the coupon at.
- Players shall not exchange the coupons for live chips or give them to another player.
- The coupons and chips shall only be redeemed after having been played and verified by a key employee.
- All procedures, times, qualifying hands, and prize amounts must be displayed prominently via any form of advertising that the Lake Elsinore Casino wishes to use, including but not limited to printed flyers, digital display, the Casino's website, etc.
- Casino Employees, on and off duty and in and out of uniform, are not eligible for the promotion
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible for the promotion.

<u>Funding</u>

The Match Play Coupon Promotion shall be fully funded by the Lake Elsinore Casino. There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

No Purchase Necessary

The Match Play Coupon Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Matchmaker Wheel Promotion

Bureau Advertisement Requirements

The Lake Elsinore Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID listed below shall be referenced on all advertisements relating to the Matchmaker Wheel Promotion.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Casino at all times this gaming activity is being offered for play:

- Eligible games and time periods.
- Procedures and requirements for distributing the tickets.
- Procedures and requirements for drawing the ticket(s).
- Procedures and requirements for spinning the wheel.
- The prizes that shall be available to win by spinning the wheel.
- Any other restrictions that apply to this gaming activity.
- Any No Purchase Necessary opportunity.

Controlled Game(s)

The Matchmaker Wheel Promotion shall be attached to the following approved controlled games offered at the Lake Elsinore Casino, as shown below, at all times that this gaming activity is being offered for play. Furthermore, this gaming activity shall be attached to the play of each controlled game listed below while that game is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

All currently approved Poker games.

Rules of Play

During pre-determined and posted times, each player seated and playing at an eligible poker table shall receive one drawing ticket per hour. Each player's individual drawing tickets will enter him/her into a drawing. Once the player receives the ticket, a casino employee shall enter the player's first and last name on the ticket. The tickets shall then be ripped in half. One half of the ticket, labeled "KEEP THIS COUPON" shall be retained by the player as their receipt and the other half of the ticket shall be placed in the drawing bin. Both pieces shall have a specific series number on it which shall correspond to each other. The ticket shall be placed in a drawing bin that shall be used to select a winner. At a pre-determined and posted time, tickets placed in the drawing bin shall be rotated. Once the tickets are thoroughly mixed, a casino employee shall randomly draw one ticket per hour from the bin. The winners shall have their identification verified by a casino employee. If a ticket is drawn and the winner of the drawing is not a seated player playing in an eligible poker game, the ticket shall be reentered into the drawing bin and another ticket will be manually drawn the following promotional period. The player whose ticket was drawn from the bin shall have an opportunity to spin the wheel and win a prize. The wheel is decorated in sections, ranging from 40-60 different sections, with each section depicting a specific prize amount. The wheel shall also contain four "Match Maker" sections. If the wheel lands on one of these sections the Casino shall match the player's wager, as explained below. The round of play of the current game that the player is playing at will continue until it is completed. The amount wagered by the player in the betting round prior to when that player spun the wheel is the amount which would be matched by the Casino in the event that the player lands on the Matchmaker Wheel Spot.

Prize Amounts

A player who has his/her ticket drawn shall be given the opportunity to spin the wheel in order to be awarded a prize. The wheel consists of cash, chips, iPads, TV's and merchandise prizes ranging in value from \$5 to \$20,000. Additionally, there shall be four sections labeled as Match Maker spots. If the wheel lands on one of these spots, the Lake Elsinore Casino shall match the wager that player has in play on the table up to a maximum of \$300.

Eligibility

- The prize shall be awarded to a player when he or she plays a poker game, receives a drawing ticket, has that ticket drawn from the bin, and that player has spun the wheel which landed on a listed prize amount.
- A minimum of 4 players must be dealt into the game in order for the table to qualify for the gaming activity.
- In order to qualify to spin the wheel, the player that has their ticket drawn must be seated and playing an eligible poker game.
- Tournament tables shall not qualify for this gaming activity.
- The wheel must make two complete rotations for the spin to be valid.
- Once the wheel has been spun and is in motion, no one may interfere with the
 rotation of the wheel. Any interference with the rotation of the wheel shall
 invalidate the spin, and the wheel shall be re-spun.
- The wheel must come to a complete stop before a determination is made as to the amount won. For a spin to be valid, the pointer must come to rest between two of the pegs. If the pointer gets stuck or rests upon one of the pegs, the spin shall be invalid and the wheel shall be re-spun. All spins that are declared invalid by the supervising floor-person shall be re-spun as per these rules.
- If the player is in between rounds of play when their ticket is drawn, they will not qualify for the promotion. In this case, there will be another ticket drawn.
- Casino employees are eligible to participate in this activity when off duty and out of uniform.
- A Third Party Provider of Proposition Player Services (TPPPPS) is eligible to participate in this activity when off duty.

Funding

The Matchmaker Wheel Promotion utilizes a fixed prize pool which shall be house funded. There shall be no additional gaming activity fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

No Purchase Necessary

The Matchmaker Wheel Promotion shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Lake Elsinore Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the jackpot without paying a table fee or placing a live wager. All players playing at a "No Purchase Necessary" table will play with specially marked chips that are not eligible for live game play. If a player is playing at a "No Purchase Necessary" table during the posted times, and receives a ticket, the ticket will be placed into the drawing. If their ticket is then drawn, and they spin the wheel and it lands on one of the designated Matchmaker spots, the player will win live game play chips with the value of their wager that was on the table at the time their ticket was drawn. All advertisement material shall state "No Purchase Necessary" when referencing the Matchmaker Wheel Promotion. This

requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Rules of Play

The Player's Rewards Program features a promotional element attached to the games listed below. This gaming activity is a loyalty rewards program open to all the Lake Elsinore Hotel & Casino (LEC) patrons. This promotion will reward players with points based on time of play at designated table games during pre-determined and eligible periods.

Controlled Games

The Player's Rewards Program shall be attached to all limits and versions of the approved games offered at the Lake Elsinore Casino, as shown below. All base game rules shall be played as previously approved by the Bureau of Gambling Control.

Advertisement Requirements

The Lake Elsinore Casino may advertise various names for this gaming activity. <u>Should the Lake Elsinore Casino advertise a different name, the BGC ID shown below shall be referenced on all advertisements relating to the Player's Rewards Program.</u>

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Lake Elsinore Casino at all times that the promotion is offered:

- Eligible games and time periods.
- Corresponding point value and promotion prize amount.
- Any other applicable restrictions.
- The rules and procedures, including the advertisements, shall not change once the promotion has been started.

Player Rewards Card

- Points shall be tracked utilizing the electronic Bravo/Genesis system.
- The player will present their card when seated at a designated game to establish a start time of play.
- A Casino employee will verify and track player rewards cards each half hour.
- Player reward points will be tracked by scanning the player rewards cards or, when necessary, on paper to be entered separately, should the player not have their card or if the scanner is out of service.
- Printable records of a player's points are available at any time upon customer request.

How Points are Earned Based on Time Played

Points shall be earned by the amount of time played. Each player that plays any of the controlled games attached to this promotion for the pre-determined and posted amount of time during live play will receive points. The range of points will be from one to one hundred points per hour of play.

- In order for the table to qualify for the promotion, there must be one player or more for all California games and four players or more for all Poker games.
- The Casino may offer bonus earn rates on play during off-peak hours or in specific games, within the approved range as shown above.
- Patrons shall be given ample notice of how many points will be awarded, as well as, the amount of time required to earn points for each eligible game. At anytime that bonus points are offered, the Casino shall advertise the specific amount of the bonus points and the specific dates and times the bonus points shall be earned.
- Furthermore, it will be displayed prominently via printed flyers, digital display, and any other forms of advertisements.

How Points are Redeemed

The Casino shall designate whether points may be redeemed at any time during the promotional period or at the end of the promotional period. All prizes shall have a pre-determined and designated point value.

- After a player has accumulated a predetermined and specific amount of points, based on time of play, a player may redeem their points for a predetermined and designated prize.
- After a player has been awarded a prize, they may also be eligible for a second and subsequent prize until the end of the promotion.
- Players may redeem their points for multiple prizes as long as the total amount of points required for the prizes are within the players' point balance.
- Upon request, a player may view the amount of points they have earned during the predetermined and designated promotional period. This will be verified by a Casino floorperson based on what has been recorded and tracked.

Prize

In all instances, prizes for a particular promotion will be pre-determined and posted on all advertisements relating to the promotion. Cash prizes are a fixed amount and are not progressive. All promotions offered in concurrence with the Player's Rewards Program shall be approved by the Bureau prior to offering the promotion for play.

Funding

The Player's Rewards Program will be fully funded by the Lake Elsinore Casino. There will be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

Administrative Fees

The Lake Elsinore Casino shall not retain an administrative fee, as the gaming activity is house funded.

No Purchase Necessary

The Player's Rewards Program shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Lake Elsinore Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the promotion without paying a table fee or placing a live wager. The NPN player must adhere to the same rules as the live player. All advertisements shall state "No Purchase Necessary" for the Player Loyalty Rewards Program.

Bureau Requirements

Advertising

Lake Elsinore Hotel and Casino may advertise various names for this gaming activity. Should Lake Elsinore Hotel and Casino advertise a different name, the BGC ID (GEGA-000633) shall be referenced on all advertisements relating to the Poker Tournaments. Furthermore, all rules and procedures for Poker Tournaments, including but not limited to the following, shall be prominently displayed in Lake Elsinore Hotel and Casino at all times that a Poker Tournament is offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by Lake Elsinore Hotel and Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- The rules and procedures for any and all gaming activities that are being offered in conjunction with the Poker Tournaments.
- Any other restrictions that apply to the Poker Tournaments.

Tournament Log

The Lake Elsinore Hotel and Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- Name of Gambling Establishment.
- Day, date, time and name advertised for the tournament.
- Total number of tables used.
- Name of controlled games offered.
- Method of entry.
 - If the method of entry used is different than the advertised entry method, then specify what the method is (gaming activity, points system, etc.). If the method of entry is through a gaming activity, then specify the gaming activity name and BGC ID.
- Number and amount of rebuys and/or add-ons offered.
- Source of all funds for tournament prize pool.
- Number of participants.
- Name of each fee charged, amount of each fee charged, total number of each fee collected, and cumulative amount of charged fees.
- Amount of the prize pool.
- Amount and reason for any deductions from the total collected prize pool.

- Name of gaming activities offered (when applicable).
 - Funding source
 - o Prize amount
 - Total number of prizes awarded
 - Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the amount paid out and amount paid for each place in the tournament.
- Signature of casino staff responsible for administering the tournament.

Eligible Controlled Games

The Poker Tournaments shall be attached to all Bureau approved Poker controlled games offered at Lake Elsinore Hotel and Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

Gaming Activities Offered During Tournament Play

Bounties

Bounty targets are tournament players who are selected prior to the start of the tournament. During the play of a tournament, either a single player or multiple players in a tournament may be designated as bounty targets. If a bounty target player loses all of their tournament chips during a hand of play and is eliminated from the tournament, the winner of that hand shall win a pre-determined and designated amount of money ranging in value between \$1 and \$10,000. The bounty prize maybe house funded or funded from the prize pool. It will be pre-determined and posted if the bounty is funded from the prize pool. If the bounty target player is in the final table of the tournament, and the final table decides to split the prize pool evenly, the bounty prize will become part of the total to split.

Points System

Object and Summary

During a predetermined and posted time period, Lake Elsinore Hotel and Casino may offer tournament players a predetermined amount of points that will entitle a player to a prize and/or entry into a grand finale tournament. The range of points will be from 1-100. A casino employee will track players' points on a log. At a minimum, the log must contain the player's name, how points were earned, and how many points were earned. Once a player uses points, to earn a prize or to be entered into another tournament, the points used will be deducted on the log. Players can check their total amount of points at any time by asking a casino employee. Points are non-transferrable and will only be valid for specific time purposes.

EXAMPLE: There are twenty-four (24) tournament events held during the Legends of Poker Tournaments at the Casino. Ten (10) of the tournaments will be pre-designated as points tournaments where the players who finish in the top 25 will be awarded a predetermined number of points (depending on which place they finish in) that will accumulate during the month. At the end of the point qualification, the winner of the top points winner could win a car or the top nine (9) winners will be granted a free entry into the \$10,000 main event.

Eligibility Requirements

• Casino employees are eligible when off duty. Third Party Proposition Players are not eligible to participate in Poker Tournaments.

Prize

Players may qualify for prizes ranging in value from \$10-\$25,000, such as cash, chips, merchandise, and trips. Players may also gain entry into a future tournament by utilizing the Points System.

Funding

The Points System will be house funded.

Tournament Variation

Freeroll Tournament

- It shall be predetermined and posted when a freeroll tournament shall be offered.
- Entry is gained by utilizing 1-100 points awarded during specified tournament play. This shall be displayed prior to the start of any qualifying tournament.
- The freeroll tournament prize pool is funded by \$5, which is taken from each player's buy-in for a tournament.
- The house may add extra funds to the existing freeroll tournament prize pool to increase the amount.

Tournament Entry

- Tournament entry is open to all customers.
- The specific structure will be on any and all Lake Elsinore Hotel and Casino advertisements and must be made available to patrons prior to the start of the tournament. The structure shall not change once sign-ups begin.
- Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the number of tournament chips provided shall be equal and posted for all players.
- Entry may be earned by winning a previous tournament, earning tournament play points, or via a promotion. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.

^{*\$5} from every player's buy-in shall be placed into a prize pool to fund free roll tournaments.

^{**}The entry fee shall be income for the Casino and/or to pay expenses and tips for the dealers and staff.

^{***}The service charge is used exclusively to pay the tournament staff for tips, etc. This is not income for the Casino.

^{****}The dealer appreciation fee shall be retained by Lake Elsinore Hotel and Casino and used exclusively to tip tournament dealers. This shall be an optional fee that tournament

entrants may pay in exchange for additional tournament chips. This fee shall not be included in the tournament prize pool.

Tournament Prize Amounts & Source of Funds

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The cardroom may provide prizes or add funds to the prize pool for special events.

- When the prize amount is guaranteed, the payout will be a cash value ranging from \$100 \$25,000. The cash will be paid to players from the buy-ins, rebuys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, the casino will fund the difference.
- When the prize is a non-cash item(s), the item(s) value will range from \$100 \$25,000.
 The prize(s) cost will be reimbursed from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the cost of the prize(s), the casino will fund the difference.
- Special tournaments may have the prizes fully funded by the house.

Tournament Prize Structure

When the prize is not guaranteed, the prize structure shall be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and "split" the total prize pool among them, it shall be permitted and shall be noted in detail on the casino's tournament log. All active players must agree on how the prize pool will be split.

Additional Prizes

Other prizes may include merchandise such as clothing, gift cards, jewelry, vehicles, trips, and/or entry into other tournaments.

No Purchase Necessary

The gaming activities attached to the Poker Tournaments shall be offered for free, on a general and indiscriminant basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Casino shall provide No Purchase Necessary tables for patrons who request to participate in the gaming activities attached to the Poker Tournaments without paying any entry into the tournament. The NPN player must adhere to all rules as the tournament player. All advertisements shall state "No Purchase Necessary" when referencing the gaming activities offered during the Poker Tournaments.

APPLICATION FOR GAMING ACTIVITY REVIEW ANSWERS TO THE 14 QUESTIONS

- 1) Every customer that walks in the door is eligible for this promotion.
- 2) The promotion has fixed amount prizes in conjunction with the Super Bowl football game.
- 3) The cash prize amounts are fixed.
- The promotion is completely house funded.
- 5) There are no special fees or collection.
- 6) The prizes are of fixed amounts so there is no seeding.
- 7) The cash prizes are distributed to the winners, although there can be more than one winner.
- 8) There is no re-seeding as the prize amounts are fixed.
- 9) There is no minimum of players needed to qualify.
- 10) No administrative fees or other fees will be retained.
- 11) Customers do not need to be playing in a game to qualify for the first part of the promotion and can be playing on a "No purchase necessary" table while qualifying for the second part of the promotion.
- 12) No flyers have been printed at this time.
- 13) To the best of our knowledge there are no copyrights or patents involved with this promotion.
- 14) The equipment used will be a 10 by 10 grid used for football pools as well as our regular poker tables.

A detailed description of the promotion follows:

In conjunction with the Super Bowl on February 1, 2004, we will offer a free football pool as well as bonuses having to do with the Super Bowl itself.

A 10 by 10 grid will be used for the football pool. As customers come in, they will sign their names in one of the squares. There is no purchase or qualification necessary to do this. If the first grid becomes full then a second grid will be made available. Just before the start of the Super Bowl the "pool" will be closed and numbers (from 0-9) chosen and written at random along the edges of the grid(s). The horizontal line will be for the home team and the vertical line will be for the visitors. At the conclusion of each quarter, the score of the game will determine the winner. If there is more than one winner, because of the use of more than one grid, the prize will be split. Winners need to be in the casino to claim their prize. Each quarter will be worth an aggregate \$500.

In addition to the football pool, customers will be given a choice of a home team or visiting team ticket. On the ticket, they will write their name and what they think the final total points scored in the Super Bowl will be and the ticket will be collected before the start of the Super Bowl. The ticket will be placed in buckets according to the team selected. There is no purchase or qualifying necessary to receive a ticket. After the Super Bowl is over a ticket will be drawn from the losing team's bucket until a winner is present that person will win \$100. If the total points written on the ticket match the points scored in the Super Bowl the amount will increase to \$500. The same procedure will be used for the winning team's tickets except the corresponding prize amounts will be \$200 and \$1000.

At the start of the Super Bowl each poker table will be designated a home or visitor team. All live tables, no-purchase tables, and instructional tables will qualify. When a table's corresponding team scores money will be added to the subsequent pot as follows:

- 1) \$25 for a touchdown
- 2) \$10 for a field goal
- 3) \$100 for a safety

SECTION III - JACKPOTS, CASHPOTS, BONUSES, PROMOTIIONS, ETC

- 1. The name of the proposed activity is "The Lake Elsinore 33 Club".
- Any customer walking through the door is eligible to participate in this promotion. There are no qualifications other than the customer must be 21 years old.
- A cash prize is awarded to player(s) whose NFL team scores exactly 33 points in a game. The customer must be present at the casino to claim the cash prize at the conclusion of the game.
- 4. The cash prize amount will start at \$1000 and increase \$333 every week there is no winner.
- 5. The gaming activity is house funded.
- 6. There are no special fees collected by the casino in conjunction with this activity.
- The cash prize is initially seeded at \$1000. If a NFL team scores exactly 33 points, all players who have that team, that are present at the casino, share the cash prize.
- The cash prize distribution only involves a NFL team that scores exactly 33 points. There are no "losing" or table shares involved.
- 9. If a team scores exactly 33 points in a game, and the cash prize is awarded, the cash prize will be reseeded at \$333. The cash prize will again increase \$333 every week there is no winner. Should the cash prize subsequently be won again, the cash prize would again be re-seeded at \$333.
- 10. Since this promotion has nothing to do with the actual play of any game, there is no minimum or maximum number of players that need to be dealt in. The casino does however, reserve the right to limit the number of participants allowed to take part in this promotion. This will be done on a "first come first served" basis.

An explanation of the promotion follows:

A sign up period (four days) to join the "Lake Elsinore 33 Club" will be announced and advertised. Customers can sign up by filling out an information card and showing valid identification (for proof of age). There are no other requirements or fees to join the club. When signing up each customer will be randomly assigned an NFL team. The results will be posted on a board in the casino. Players may only sign up once and cannot trade in their team. A limit of 320 customers will be able to join in on the 33 club (ten players for each NFL team).

Throughout the NFL season, if a team scores exactly 33 points in a game, the customers listed as having that particular team will be asked to identify themselves at the conclusion of the game. If more than one winner is present the prize will be split accordingly. The casino will seed the cash prize at \$1000 and will add \$333 every week that there is no winner (either no team scoring exactly 33 or no winner present). In the event the cash prize is won, the casino will immediately re-seed the cash prize at \$333. The cash prize will again increase \$333 every week it is not won. If the cash prize is won again, the casino will once again re-seed the cash prize at \$333.

SUMMARY OF THE GAME

The Lake Elsinore Hotel & Casino (LEC) proposes to add the gaming activity called the '33 Club'. The promotion consists of 320 persons picking a NFL football team. If that particular person's team scores a total of thirty three (33) points for that week, they will win the posted cash prize. There is no requirement for participation in any of the controlled games offered at the Casino to win this promotion.

THE PRIZE

The prize pool will initially be funded at \$1,000.00. When a participant's team scores a total of 33 points they will win the posted cash prize. A total of 10 participants will pick a single team. If, at the end of the regular season, the prize is not claimed, all monies will revert to the Casino.

LEC funds 100% of this promotion's prize pool. The prize pool will be initially funded at \$1,000.00. The prize pool will increased by \$333.00 per week if no prize is won or claimed. If a prize is won and claimed, the prize pool will be reseeded at \$1,000.00.

NO PURCHASE NECESSARY

The No Purchase Necessary (NPN) does not apply as there is no consideration to enter the promotion. The first 320 people who sign up and draw a team are entered.

ELIGIBILITY FOR THE PRIZE

All persons participating in the promotion must be present at LEC to win. Those persons must claim their prize within five (5) minutes of the conclusion of the football game. The person(s) claiming the prize must show government issued identification. All applicable government forms will be completed as required State and Federal law(s).

A 33 Club board will be placed in the Casino to notify participants of their team and of the current prize pool.



Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the Three Card Poker Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the Three Card Poker Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering the Three Card Poker Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.

Bureau Requirements

Advertising

The Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004726) shall be referenced on all advertisements relating to the Three Card Poker Progressive gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Casino at all times:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Administrative fees.
- No Purchase Necessary Information.
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Game

Three Card Poker Progressive gaming activity shall be attached to all limits and versions of the currently approved game offered at the Casino, as listed below. All base game rules shall be played as previously approved by the Bureau.

- Three Card Poker (GEGA-001180)
- Three Card Poker 6 Card Bonus (GEGA-003828)

Object and Summary

- To begin each round, players must make their regular base game wager. They may
 optionally place any bonus bet wagers along with the jackpot fee of \$1.00. A minimum
 of two players, a player and player-dealer, are required to play for the progressive
 jackpot.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- 3. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the left side of the gaming table.



- 4. The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).
- 5. The house dealer then follows standard approved procedures for dealing the base game.

Qualifying Hands

When a player is dealt an ace, king, queen, of the same suit, they are paid from the progressive jackpot shown on the progressive meter. Any straight flush, a hand that consists of three cards of the same suit in consecutive ranking, other than ace, king and queen, receives a fixed prize amount according to the pay table below.

Envy Bonus:

- A player paying the \$1.00 jackpot fee also qualifies to win an envy payout. If another
 player at the table hits a hand associated with an envy pay, all other players who
 paid the \$1.00 jackpot fee win the envy pay. The player hitting the hand received the
 normal prize pay only, but does NOT receive the envy pay.
- If a player's hand triggers an envy payout, the house dealer will leave the hand faceup on the layout; otherwise, the dealer will lock up the cards. The dealer will then move on to the next player.
- The house dealer pays any envy bonuses at the end of the round. In the event that
 more than one player is involved in a qualifying envy pay, then all players win
 multiple envy payouts.

Eligibility Requirements

The eligibility requirements are as follows:

- Back-line betting is not permitted in this gaming activiy.
- In the event that during a round of play, two or more players have qualifying hands, each player will receive the posted prize amount for their designated hand, subject to the terms of the Progressive Prize Rules below.

- When a player is dealt an ace, king and queen, of the same suit, they are paid from the progressive jackpot shown on the progressive meter.

- In the event there is more than one progressive winner at the same time, the winning players will split the posted progressive prize.
- When a player has a progressive winner, the dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact the floor person.
- Once the casino verifies the progressive win, the floor person shall insert the key and rotate it to "JPH" and then press "J-pot" button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- When the house dealer reconciles all action (on behalf of the player/dealer), he/she presses "Game Over." This resets the system to begin the next hand.
- Once the "J-pot" button is pressed, the prize is logged into Game Manager.

Fixed Prize

- When a player is dealt a straight flush, they are paid a fixed prize amount according to the payout table above.
- All fixed payouts will be paid by a Casino floor person. Once the proper paperwork
 has been filled out, the floor person will pay the winner(s) in casino chips. The
 payouts will not be made from the Casino dealer's tray. All fixed payouts will be
 deducted from the amount in the reserve fund. If there is a shortfall the casino will
 cover the payout.
- All monies collected and paid out shall be tracked both electronically and on a hand written log that will be maintained for examination by regulatory and law enforcement personnel.

Funding

The Casino will initially seed the jackpot at \$1,000. Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- \$0.20 will be immediately posted on the meter.
- \$0.80 will be tracked in a reserve fund.

Administrative Fees

The Casino shall retain an administrative fee of \$4 - \$6 per table hour from each jackpot collection fee placed and collected. The administrative fee shall be utilized to cover expenses incurred by the Casino for administering the Three Card Poker Progressive Jackpot.



No Purchase Necessary

The Three Card Poker Progressive gaming activity shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Casino shall provide NPN tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisements shall state ANo Purchase Necessary@ for the Three Card Poker Progressive gaming activity.

- 3. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
- 4. The house dealer then follows standard approved procedures for dealing the base game. The jackpot considers the best hand possible among the player's cards. A



player can qualify for the jackpot element of the game regardless of the outcome of the base game.

- Once the "J-pot" button is pressed, the prize is logged into Game Manager.

Envy Bonus:

- A player paying the \$1.00 jackpot fee also qualifies to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1.00 jackpot fee win the envy pay. The player hitting the hand receives the normal prize pay only, and does NOT receive the envy pay.
- If a player's hand triggers an envy payout, the house dealer will leave the hand face-up on the layout; otherwise, the dealer will lock up the cards. The dealer will then move on to the next player.
- The house dealer pays any envy Bonuses at the end of the round. In the event that more than one player is involved in a qualifying envy pay, then all players win multiple envy payouts.

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained, by the gambling enterprise, for examination by regulatory and law enforcement personnel.

All fixed payouts will be paid by a Casino floor person. Once the proper paperwork has been filled out, the floor person will pay the winner(s) in casino chips. The payouts will not be made from the Casino dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund.

<u>Funding</u>

1. The Casino will initially seed the jackpot in an amount between \$1,000 and \$2,000. Once there are sufficient monies in the Ultimate Texas Hold'em jackpot fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit it will be reseeded by the reserve fund in the amount between \$1,000 and \$5,000. The progressive prize pool shall increase daily based solely on the number of jackpot collection fees placed and collected each day. Furthermore, there is no cap on this progressive prize pool.



- 2. Each \$1.00 jackpot fee paid by a player will be broken down as follows:

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

Object and Summary

The High Hand Promotion (promotion) features a house-funded fixed prize. The object of the promotion is for a player to form the highest ranked five-card poker hand during a predetermined and posted time period.

To participate in the promotion players will need to participate in an eligible game, at a table with four active players or more. When players form a qualifying hand they will notify a casino representative, who will verify the hand and obtain all pertinent information. Once verified the qualifying hands will be tracked and posted as follows:

- At the beginning of the promotion players will attempt to make the highest ranked qualifying hand.
- Once a qualifying hand has been obtained that hand will be tracked and posted on the casino floor.

- At this point players will attempt to obtain a hand that is of equal or higher rank than the posted hand.
- If a higher hand is obtained the new High Hand will be posted and the old High Hand will be removed.
- This process will continue until the predetermined and posted time when the prize is awarded.
 - Players who are present will be paid immediately.
 - o Players who are not present, will forfeit the prize.

Qualifying Hands

In the event that multiple players achieve the same qualifying High Hand, and the advertised prize is cash or live casino chips, the prize will be split evenly amongst the winners.

• In the event that the prize cannot be split evenly, the casino will make up the shortfall.

In the event that multiple players achieve the same qualifying High Hand, and the advertised prize is clothing, electronics, food, gift cards, merchandise, tickets for concerts, tickets for sporting events, tickets for performances, trips, or vehicles, the advertised prize will not be awarded. Instead, the cash value of the prize will be split evenly amongst the winners.

Object and Summary

The Mega Bad Beat Jackpot (jackpot) features a house-funded fixed prize. The object of the jackpot is for a player to form a qualifying hand that is beaten by a better hand at the showdown of the base game.

To participate in the jackpot players will need to participate in an eligible game, at a table with four active players or more. Players shall place their wagers according to the base game rules, after all initial wagers have been placed, the house dealer will follow approved procedures for dealing the base game.

When the winning and losing hands are confirmed, those players with qualifying hands shall receive the posted percentage of the jackpot prize pool amount, as shown in the Prize Payout Structure below. A prize will also be awarded to active players who are at the same table where the qualifying losing and winning hands are obtained.

Qualifying Hands

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is no minimum amount of time that must be played in order for a player to qualify for this gaming activity.
- There is a minimum of four players required to be seated and actively playing in an above mentioned game for the table to qualify for the jackpot.
