

## **Kev Koom Tes Los Ntawm Ntau Lub Xeev Los Mus Qhia Txog Qee Yam Tseem Ceeb Ntawm**

### **Kev Ncaj Ncees Ib Puag Ncig**

Cov thawj kws lij choj sawv cev rau xeev California, Massachusetts, thiab New York, nrog rau cov uas sawv cev ntawm lub xeev Arizona, Connecticut, Delaware, Hawaii, Illinois, Maryland, Minnesota, Oregon, Rhode Island, thiab Vermont, tau tshaj tawm daim ntawv no los qhia txog qee yam tseem ceeb txog kev ncaj ncees ib puag ncig, uas yog los txhawb kom txhua tus neeg nyob teb chaws Asmeskas nyob tau, ua si, ua hauj lwm, xyam thiab teev ntuj tau mus rau tej thaj chaw uas ib puag ncig huv si thiab nyab xeeb. Peb tseem cog lus tias yuav nrhiav kev ncaj ncees txuas ntxiv rau ntau yam laj thawj ntxiv, xws li muaj kev ncaj ncees txog kev cai lij choj thiab tej cai hauv ciamb teb ntawm lub xeev.

Nyob thoob plaws teb chaws no, tsoom fwv hauv xeev, tsoom fwv Tribal, thiab tsoom fwv hauv zos, cov koom haum non-profit thiab cov chaw pab dawb, cov lag luam, thiab pab pawg nyob hauv zej zog tab tom koom tes los txhim kho thiab tiv thaiv cov chaw ib puag ncig uas peb nyob, thiab tiv thaiv kev noj qab haus huv ntawm pej xeem los ntawm kev daws teeb meem uas muaj hauv zej zog. Raws li daim ntawv qhia hauv qab no, lub hom phiaj tshwj xeeb yog los txhawb kev ncaj ncees ntawm cov chaw nyob ib puag ncig, kev noj qab haus huv ntawm pej xeem, kev txhim kho tej xwm txheej hauv zej zog, xws li: kev koom tes ntawm pej xeem; kev soj ntsuam zoo ntawm cov dej, av, thiab huab cua; kev tawm suab txhawb nqa rau kev tsim cai lij choj; los sis kev txhim kho zej zog thiab kev ruaj ntseg.

Tiam sis, vim tej kev txiav txim tshiab ntawm tsoom fwv teb chaws uas cuam tshuam nrog cov chaw uas tsis muaj kev ncaj ncees ib puag ncig, nws thiaj li tau ua rau tib neeg pib ntshai thiab txo cov hauj lwm rau fab no. Tsoom fwv teb chaws tau hais tias cov cai, cov kev pab cuam, thiab cov hauj lwm uas muaj feem xyuam txog yog “kev cais tawm tsis raws cai”, uas yog ib txoj kev piav qhia yuam kev thiab ua rau sawv daws tsis muaj kev nkag siab. Txuas ntxiv no, lo lus ntxiv hais tias cov hauj lwm no “tsis raws cais” yeej tsis txhais hais tias nws muaj tseeb li hais. Cov hauj lwm uas txhawb kev ncaj ncees rau ib puag ncig uas peb nyob tsis yog kev cais tawm txhaum cai, thiab tej kev txiav txim los ntawm tsoom fwv teb chaws los yeej yuav hloov pauv tsis tau qhov tseeb ntawd. Muaj hais los, kev ncaj ncees rau ib puag ncig uas peb nyob pab pej xeem thiab cov chaw ntiag tug zam tau tej yam kev ua uas txhaum cai thiab pab kho tej teeb meem uas twb muaj lawm. Tus Thawj Tswj Teb Chaws tsis muaj cai txwv cov cai, cov kev pab cuam, los sis cov hauj lwm uas raug cai ntawm lub xeev, Tribal, los sis tsoom fwv hauv zos, uas siv los txhawb kev ncaj ncees rau cov chaw ib puag ncig uas peb nyob.

Cov kev txiav txim los ntawm tsoom fwv teb chaws uas tawm tsam kev ncaj ncees rau ib puag ncig uas peb nyob tau cuam tshuam kev noj qab haus huv ntawm peb cov pej xeem, peb cov chaw nyob ib puag ncig, thiab peb kev khwv nyiaj txiag. Daim ntawv qhia no yog los teb cov lus txhawj xeeb thiab lus tsis nkag siab ntawm zej zog, hais txog cov hauj lwm uas cov neeg sawv cev hauv xeev tau ua thiab txhawb txhawm rau kev ncaj ncees ib puag ncig. Cov neeg sawv cev rau pej xeem thiab cov chaw ntiag tug yuav tsum muaj kev ntseeg siab tias lawv muaj cai ua tej hauj lwm uas txhawb kev ncaj ncees rau ib puag ncig uas peb nyob, thiab cov hauj lwm no tseem ceeb heev rau kev noj qab haus huv thiab kev txhawb lub zej zog. Vim daim ntawv qhia no tab tom tham txog cov cai uas cuam tshuam txog cov ntsiab lus thiab cov kev xyam uas muaj feem xyuam rau cov chaw uas peb nyob uas tsis muaj kev ncaj ncees, pej xeem thiab cov chaw ntiag tug yuav tsum nrhiav lawv tus kws lij choj los teb lawv cov lus nug txog tej cai los sis cov dej num uas txhawb lub hom phiaj no.

## **Kev Txhawb Kev Ncaj Ncees Ib Puag Neig Uas Peb Nyob Tseem Ceeb Heev**

Kev ncaj ncees rau ib puag ncig uas peb nyob txhawb kev ywj pheej thiab vaj huam sib luag, thiab nws pib los ntawm cov kev tawm suab kom pej xeem, kev khvv nyiaj txiag, kev ua hauj lwm, thiab rau cov neeg tuaj tshiab muaj cai nyob ruaj ntseg. Qhov hom phiaj no twb pib tshaj li 40 xyoo dhau los, nyob rau xyoo 1982, thaum cov neeg tawm suab pw thaiv txoj kev khiaj tsis pub hliv tshuaj lom rau qho chaw pov tseg khib nyiab uas nyob hauv lub zej zog uas muaj neeg dub nyob thaj tsam ntawm Warren, hauv lub xeev North Carolina. Kev ncaj ncees rau ib puag ncig uas peb nyob yog los txhawb kom txhua tus tib neeg muaj vaj huam sib luag tau cov pa thiab dej uas huv si, tau cov zaub mov uas zoo thiab muaj kev nyab xeeb. Tsis tas li, nws pab kom cov chaw peb nyob ib puag ncig zoo thiab kav ntev yam tsis muaj huab cua phem cuam tshuam. Nws yog ib lub hwj tsam zoo rau zej zog los nthuav lawv lub peevee xwm los mus txiav txim thiab tawm suab txog cov teeb meem uas cuam tshuam txog lawv cov cai kom lawv txais tau kev ncaj ncees thiab muaj vaj huam sib luag.

Cov hauj lwm txhawb kev ncaj ncees rau ib puag ncig uas peb nyob tseem ceeb heev rau kev sib luag ntawm kev noj qab haus huv. Piv txwv hais tias, yog tsis muaj li ntawd, tej txhia neeg yuav muaj feem raug lom vim cov txhuas<sup>3</sup> thiab muaj mob hawb pob los ntawm cov pa phem<sup>4</sup> ua ntus zus, tshwj xeeb nws kuj phom sij heev rau cov me nyuam yaus. Cov zej zog uas tsis muaj kev ncaj ncees rau ib puag ncig, feem ntawd muaj kev cov nyom txog kev thauj mus los thiab nws txoj kev siv<sup>5</sup>, tsis muaj zaub mov txaus thiab zoo<sup>6</sup>, thiab muaj teeb meem nrhiav tau kev pab rau<sup>7</sup> kev kho mob. Lawv kuj muaj kev cuam tshuam txog kev pov tseg khib nyiab uas tsis raws cai<sup>8</sup> thiab muaj ntawd qhov chaw muaj tej yam tsis zoo los paug<sup>9</sup> rau. Cov zej zog no kuj muaj tej chaw uas ntshawb cov pa phem los ntawm cov chaw pov tseg khib nyiab thiab chaw hlawv khoom pov tseg<sup>10</sup>, cov lag luam loj<sup>11</sup>, tsheb thauj khoom loj<sup>12</sup>, kev khaiv tsheb loj<sup>13</sup>, thiab tej qho chaw ua liaj ua teb los sis yug tsiaj coob heev<sup>14</sup>. Cov tib neeg uas nyob hauv cov zej zog no kuj tsis muaj kev txhawb los mus nyob rau tej vaj tse uas yuav nyab xeeb los sis pheej yig, tsis muaj kev thauj mus los, dej huv siv, thiab tsis muaj kev kho mob uas tsim nyog. Muaj ntawd tsis neeg nyob rau cov zej zog ntawd uas tseem ntsib kev phom sij txog kev noj qab haus huv thiab, vim lawv ua hauj lwm hauv tej lag luam uas ua rau lawv muaj kab mob los sis raug tshuaj lom, muaj pa phem, thiab muaj dej tsis huv los siv<sup>15</sup>. Lawv kuj nyob rau tej qho chaw uas sov heev, muaj cua daj cua dub, dej hnyab, los lawg, thiab muaj hluav taws kub hav zoov vim huab cua phem. Nws ua rau cov zej zog no tau txais kev txom nyem txog kev noj qab nyob zoo thiab kev khvv nyiaj txiag.<sup>16</sup>

Kev tshawb fawb<sup>17</sup> thiab tej xwm txheej uas tshwm sim rau cov neeg hauv zej zog qhia tau hais tias muaj qee tus raug cuam tshuam hnyav dua vim tsis muaj kev ncaj ncees ib puag ncig, xws li: cov zej zog uas muaj neeg txawv teb chaw<sup>18</sup> ntawd dua; cov neeg Indigenous thiab cov chaws Tribal<sup>19</sup>; cov zej zog txom nyem dua uas tau nyiaj txiag tsawg<sup>20</sup>; cov zej zog nyob deb nroog thiab tsis muaj kev tswj hwm los ntawm tsoom fwv<sup>21</sup>; cov zej zog thawj hom lus hais tsis yog lus Askiv<sup>22</sup>; cov neeg uas muaj kev tsis taus<sup>23</sup>; thiab cov neeg LGBTQ<sup>24</sup>.

Keeb kwm dhau los yeej keev muaj cov cai uas cais tib neeg tawm, thiab nws yog ib qho uas sawv daws pom tau meej tseeb tias nws cuam tshuam txog kev noj qab haus huv thiab kev ncaj ncees ib puag ncig. Los txog niq hnuh no, hauv peb lub teb chaws, los yeej tseem muaj kev cais tawm ntawm qee haiv neeg, txwv tsis pub lawv nyob rau qee qhov chaw thiab muaj cai los sis muaj vaj huam sib luag tau lub neej zoo. Vim muaj cov teeb meem no, ua rau tib neeg muaj

mob ntau dua, muaj sia nyob tsis ntev, muaj lub neej tsis zoo xws luag, thiab tsis muaj ntau lub hwj tsam. Tsis tas li ntawd xwb, ntau lub zej zog thiab coob tus neeg kuj tau ntsib teeb meem loj—tau ntau tiam los lawm—uas ua rau lawv tsis muaj feem koom nrog txoj kev khiav ua nom ua tswv tswj hwm pej xeem thiab siv tsis tau tej peev txheej kom muaj kev loj hlob los sis muaj hwj chim. Kev ncaj ncees rau cov chaw nyob ib puag ncig pab tshem tawm cov kev sib cais ntawd, pab daws cov teeb meem uas ib txwm muaj dhau los, thiab txhawb kev noj qab haus huv, kev nyab xeeb, kev zoo siab, thiab kev vam meej rau txhua tus hauv zej zog. Txuas ntxiv no, nws kuj rub tau sawv daws los muaj kev koom siab koom ntsws rau kev xaiv nom xaiv tswv, kev txiav txim uas cuam tshuam txog kev noj qab haus huv, kev ruaj ntseg thiab kev thaj yeeb ntawm lub zej zog. Txoj kev txhawb kev ncaj ncees rau cov chaw nyob ib puag ncig pab kom ua tau tej yam kom muaj txiaj ntsig, xyuas kom txhua tus tib neeg tau txais kev huab hwm thiab muaj nqes, txawm lawv nyob, ua si, ua hauj lwm, kawm ntawv, los sis mus teev ntuj qhov twg los xij.

### **Cov Kev Txiav Txim Ntawm Tsoom Fwv Teb Chaws Tsis Cuam Tshuam Txog Cov Hauj Lwm Raws Cai Ntawm Qhov Key Ncaj Ncees Ib Puag Ncig**

Qee cov kev txiav txim tshiab los ntawm tsoom fwv teb chaws ua rau tib neeg pib txhawj tsam tej hauj lwm cuam tshuam txog kev ncaj ncees ib puag ncig no tsis raws cai. **Tiam sis cov kev txiav txim ntawd tsis hloov los sis txwv** lub hom phiaj no kiag li. Cov kev txiav txim ntawd muaj xws li, ntau yam lus txib uas President Trump tau hais tawm thiab cov ntawv ceeb toom uas Tus Thawj Kws Lij Choj ntawm teb chaws Asmeskas, Pam Bondi, tau tshaj tawm. Nkawv tau hais yuam kev tias kev ncaj ncees ib puag ncig thiab cov hauj lwm txhawb txhua haiv neeg (diversity), vaj huam sib luag (equity), kev koom siab koom ntsws ntawm txhua haiv (inclusion), thiab kev lees txais txhua tus (accessibility) yog “kev cais tawm tsis raws cai.” Cov kev txiav txim ntawd kuj rhuav cov lus txib yav dhau los, uas tau tsim los txhawb kev ncaj ncees ib puag ncig uas txuas nrog tsoom fwv cov kev pab cuam. Lawv kuj tseem tso tseg txhua yam dej num daws cov teeb meem hnyav uas tej zej zog tau ntsib vim muaj cov pa phem tsis zoo, thiab lawv kuj tshem tawm cov kev pab cuam thiab nyiaj txiag uas tsoom fwv ib txwm muaj los txhawb kev ncaj ncees ib puag ncig.<sup>25</sup> Lawv tseem yuam kom Department of Justice txo cov hauj lwm uas txhawb kev ncaj ncees ib puag ncig uas Tus Thawj Kws Li Choj hauv Teb Chaws ntau nqi hais tias yog tej yam tsis tseem ceeb los sis ua tsis raws cai.<sup>26</sup> Vim muaj tej kev txiav txim no, thiaj li ua rau tib neeg nkag siab yuam kev txog kev ncaj ncees ib puag ncig thiab tej hauj lwm ntawd. Tiam sis, qhov tseeb tiag, cov kev txiav txim no tsis muaj feem los hloov txoj cai. **Tus Thawj Tswj Teb Chaws tsis muaj cai hloov tej cai uas Congress twb tau pom zoo lees txais lawm, thiab nws tsis muaj cai siv lus txib los sis ua ntawv ceeb toom los yuam kom tshem tej kev tiv thaiv uas tau sau tseg rau Txhooj Cai tswj teb chaws (Constitution), los sis cov cai hauv ib lub xeev twg.** Ntxiv no mus, txawm kev ncaj ncees ib puag ncig muaj kev tshuam txog txoj kev txhawb txhua haiv neeg (diversity), vaj huam sib luag (equity), kev koom siab koom ntsws ntawm txhua haiv (inclusion), thiab kev lees txais txhua tus (accessibility), los nws yeej muaj nws ib lub zoo hom phiaj teeb tseg uas muaj peev xwm txhawb tau pej xeem txhua tus<sup>27</sup> rau ib sab ib seem txawv.

### **Tsoom Fwv Teb Chaws Cov Cai Lij Choj Txog Ib Puag Ncig Yeej Txhawb Cov Kev Ncaj Ncees Ib Puag Ncig**

Muaj ntau txoj cai lij choj hauv tsoom fwv teb chaws uas pab txhawb cov hauj lwm ntawm pej xeem thiab cov chaw ntiag tug kom los txhawb kev ncaj ncees ib puag ncig. Cov

koom haum pej xeem uas txhawb lub hom phiaj no muaj cai kuaj xyuas txoj kev siv cov kev pab cuam seb puas muaj kev siv sib luag los ntawm txhua haiv neeg. Muaj ntau txoj cai lij choj txog ib puag ncig uas kuj tseem yuam kom cov koom haum pej xeem thiab chaw ntiag tug koom tes nrog cov pej xeem los mus txiav txim txog kev txhim kho lub neej yav tom ntej. Xws li, yuav tsum muaj kev koom tes ua ke txog txoj cai Clean Air Act ntawm tsoom fwv teb chaws, uas cov koom haum pej xeem yuav tsum tshaj tawm xov xwm ceeb toom rau pej xeem paub, muab sij hawm rau lawv tawm tswv yim, thiab tuav cov rooj sab laj rau pej xeem ua ntej yuav txiav txim teeb tsa tej qho chaw los yog tuam tsev ua hauj lwm tshiab, uas muaj feem tsim tau cov pa phem rau ib ncig.

### **Txhooj Cai Tswj Teb Chaws thiab Tsoom Fwv Teb Chaws Cov Cai Lij Choj Yeej Txhawb Kev Ncaj Ncees Ib Puag Ncig**

Cov nom tswv hauv xeev thiab hauv cheeb tsam tau txaus siab los tsim tej tsab cai uas muaj feem xyuam txog kev ncaj ncees ib puag ncig, raws li tsoom fwv teb chaws tus qauv thiab txoj cai Tenth Amendment. Xws li, nws yog ib txoj cai uas tso cai rau cov xeev los tsim lawv ib txhooj cai thiab kev pab cuam txhawb kev noj qab haus huv thiab kev nyab xeeb. Vim muaj txoj cai no, ntau lub xeev thiab txhua cheeb tsam hauv teb chaws tau sau tseg tias pej xeem txhua leej yuav tsum muaj lub hwj tsam zoo txais kev noj qab nyob zoo thiab nyob rau tej qho chaw uas huv si ruaj khov. Ntau txoj cai hauv xeev kuj tseem yuam kom muaj kev txhim kho tej thaj av, kev thauj mus los, thiab vaj tse los mus tso kev phom sij ntawm ib puag ncig. Qee txoj cai hauv xeev thiab hauv nroog kuj tseem yuam kom tsoom fwv teb chaws los sis cov chaw ua hauj lwm tshaj tawm xov xwm rau cov zej zog uas nyob ib puag ncig ntawm thaj chaw, yog hais tias muaj feem cuam tshuam txog kev noj qab haus huv ntawm pej xeem.

Cov cai lij choj tiv thaiv pej xeem uas zwm tseg rau Txhooj Cai Tswj Teb Chaws Asmeskas, tsoom fwv teb chaws thiab hauv xeev los kuj txhawb cov hauj lwm txhim kho kev ncaj ncees ib puag ncig. Qhov no tej zaum yeej yuav muaj tseeb rau ob tog tib si tib yam nkaus. Tshooj lus “The Equal Protection Clause” ntawm txoj cai Fourteenth Amendment txwv tsis pub cov koom haum hauv tsoom fwv thiab lub xeev los mus tsim kev ntxub ntxaug cais tawm lwm tug vim lawv haiv neeg, los sis txawm lawv yog poj niam los yog txiv neej.<sup>28</sup> Tshooj Title VI of the Civil Rights Act of 1964, txwv tsis pub muaj kev ntxub ntxaug vim haiv neeg, xim nqaj tawv, los sis ib tug neeg twg qhov keeb kwm rau txhua qhov chaw pab cuam ntawm tsoom fwv teb chaws, hauv xeev, hauv zos los yog cov koom haum ntiag tug uas txhawb pej xeem rau sab nyiaj txiag. Raws li Section 504 ntawm txoj cai Rehabilitation Act, txwv tsis pub muaj kev ntxub ntxaug tib yam nkaus raws hnub nyooog (txoj cai Age Discrimination Act of 1975), txawm yog poj niam los sis txiv neej (tshooj Title IX ntawm txoj cai Education Amendments of 1972). Tshooj VI kuj tseem yuam kom cov chaw uas tau nyiaj pab los ntawm tsoom fwv yuav tsum xyuas kom txhua tus neeg uas hais lwm hom lus uas tsis yog lus Askiv, muaj peev xwm koom tag nrho cov kev pab cuam, cov dej num, thiab tau cov txiaj ntsig, xws li mus koom cov rooj sib tham txog cov ntaww tso cai, cov rooj sib tham txhim kho zej zog, txais cov xov xwm ceeb toom txog cov xwm txheej ceev, los sis tau kev pab cuam qhia tej txuj ci tshwj xeeb.<sup>29</sup> Kev nkag siab hom lus hais yog ib qho kev tiv thaiv rau pej xeem kom muaj cai, thiab kuj yog ib feem tseem ceeb ntawm kev ncaj ncees ib puag ncig.

Ntxiv mus, tshooj VIII ntawm Txoj Cai Civil Rights Act of 1968, uas hu ua Federal Fair Housing Act, txwv tsis pub tsoom fwv thiab cov koom haum ntiag tug muaj kev ntxub ntxaug rau txoj kev muag los sis xauj vaj tsev, uas muaj nyob hauv lawv cov ntsiab lus, cov cai, kev

pab, los sis cov chaw pab cuam uas cuam tshuam nrog tej vaj tse, vim lawv yog neeg txawv teb chaws, xim nqaij tawv txawv, t xo j kev ntseeg, yog poj niam los sis txiv neej, kev ua neej, los sis keeb kwm ntawm tus neeg teb chaws.<sup>30</sup> Tej kev txiav txim txog kev faib chaw nyob, kev txwv kev pab cuam tshwj xeeb txog vaj tsev rau lwm tug, uas tsis ncaj ncees vim kev ntxub ntxaug txog lwm haiv neeg, yog ib txoj kev txhaum txoj cai Fair Housing Act.<sup>31</sup> Xaus no, txoj cai Americans with Disabilities Act txwv tsis pub muaj kev ntxub ntxaug rau cov neeg uas tsis taus hauv zej zog thiab tej chaw pej xeem.<sup>32</sup> Cov cai tiv thaiv pej xeem hauv xeev thiab hauv nroog kuj muaj txuas los ntawm tsoom fwv teb chaws cov cai tib Yam nkaus.<sup>33</sup>

### **Cov Hauj Lwm Ntawm Qhov Kev Ncaj Ncees Ib Puag Neig Raug Tiv Thaiiv Los Ntawm Txoj Cai First Amendment Thiab Cov Cai Rau Cov Koom Haum Nonprofit**

Cov koom haum uas txhawb kev ncaj ncees ib puag ncig raug tiv thaiv los ntawm txoj cai First Amendment nyob hauv Txhooj Cai Tswj Teb Chaws Asmeskas, uas txwv tsis pub tsoom fwv rau txim los sis yuam ib pawg neeg twg kom txhob tawm suab.<sup>34</sup> Tsoom fwv tsis muaj cai txwv kom ib tug neeg twg txhob tawm suab hais lus, tab txawm cov lus ntawm yog tej Yam lus tsis raug cai los sis yog cov lus tso hem thawj kom ntshai los xij.<sup>35</sup> Tsoom fwv kuj tsis muaj cai muab txiaj ntsig los sis nyiaj txiag, Yam tsis raug cai, los mus xiab ib lub koom haum twg kom rhuav tshem lawv txoj cai tawm suab.<sup>36</sup> Nws kuj tsis muaj cai yuav them los yog rho tawm qhov tax exempt status ntawm ib lub koom haum twg vim lawv tau tawm suab los tawm tsam los yog muaj txoj kev xav txawv tsis sib thooj.<sup>37</sup>

Cov kev pab cuam uas hais txog kev ncaj ncees ib puag ncig kuj suav tau lawm hais tias yog hom hauj lwm pub dawb raws li txoj cai ntawm tsoom fwv teb chaws rau cov koom haum nonprofit. Tus Thawj Tswj Teb Chaws tsis muaj cai txib thiab yuam kom hloov los sis them cov txiaj ntsig ntawm ib lub koom haum twg, raws li seem 501(c)(3). Qhov tseeb tiag, Internal Revenue Code txwv tsis pub ceg tswj kev cai lij choj los mus cuam tshuam rau kev tshawb xyuas pej xeem thiab cov koom haum txoj kev them los tsis them se.<sup>38</sup> Tsis tas li xwb, txoj kev rho lub npe tax-exempt rau ib lub koom haum uas niadj xyoo them se raws sij hawm mus rau Internal Revenue Service (IRS), tsis yog ib Yam uas ua tau yooj yim, vim hais tias cov cai tiv thaiv cov koom haum nonprofit<sup>39</sup> yuam kom IRS kuaj xyuas tej ntaub ntawv kom zoo ua ntej.

### **Lub Luag Hauj Lwm Sib Txawv Rau Cov Neeg Tribal thiab Cov Neeg Indigenous**
