#### Blazing Sevens Progressive Jackpot

Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the modified Blazing Sevens Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the modified Blazing Sevens Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play the modified Blazing Sevens Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau=s cease and desist notification.

# Advertising

The Ocean's Eleven Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004722) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in The Ocean's Eleven Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying Hands.
- Prize payout structure.
- The prize amount that shall be awarded.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

# **Eligible Controlled Games**

The Blazing Sevens Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at The Ocean's Eleven Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

• 21st Century Blackjack 8.0 (GEGA-000062)

#### **Object and Summary**

- 1. To begin each round, players must place a base game wager in order to qualify for the jackpot. Along with any bonus bets the player places a wager on, player(s) have the option to place a \$1.00 jackpot fee and become eligible for the jackpot.
- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- 3. Once all players place their controlled game wagers and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the progressive gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.

4. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

# **Qualifying Hands**

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. Only one of these prize payout options shall be offered at any one time that the Blazing Sevens Progressive Jackpot is being offered for play.

# **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- The Third Party Provider of Proposition Player Services is not eligible for this promotion.
- Casino employees are eligible to participate in this gaming activity when they are off duty and out of uniform.
- There is no amount of players required for the jackpot, other than what is previously approved for the base game.
- A player can qualify for the jackpot element of the game regardless of the outcome of the controlled game.
- Only seated players are eligible for payouts.

#### **Prize**

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

- a. Three seven's (7s) of the same color is paid 100% of the progressive jackpot amount shown on the progressive meter.
- b. All other hands are paid a fixed amount from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the casino will make up any shortfall.
- c. In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will share, in equal amounts, the posted progressive prize or the posted fixed amount. In the event the reserve fund is depleted, the casino will make up any shortfall. All hands will be paid the posted prize.
- d. When a player has a progressive winning hand, the dealer shall press the appropriate hand button on the keypad.
- e. The house dealer shall then contact a supervisor.
- f. Once the casino verifies the progressive win, the supervisor will press the confirm button. To complete the action, a Supervisor or Executive card (depending on jackpot level) swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed

- for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
- g. When the dealer reconciles all action, he presses "END GAME." This resets the system to begin the next hand.
- h. Once the Supervisor or Executive card (depending on jackpot level) is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the award will need to be manually backed out using the Game Manager manual adjustment feature.

All fixed payouts will be paid by a Casino floor person. Once the proper paperwork has been filled out, the floor person will pay the winner(s) in casino chips. The payouts will not be made from the Casino dealer's tray. All fixed payouts will be deducted from the amount in the reserve fund.

#### **Funding**

The Blazing Sevens Progressive Jackpot is a player funded progressive jackpot. The Casino will initially seed the jackpot at a minimum of \$1,000 and to a maximum of \$50,000. Once there are sufficient monies in the Blazing Sevens Progressive Jackpot fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records.

After the progressive jackpot is hit, it will be re-seeded by the reserve fund at an amount between a minimum of \$1,000 and a maximum of \$50,000. In addition this reserve fund will payout all fixed amounts. In the event the reserve fund is depleted, the casino will make up any shortfall. Once there are sufficient monies in the Blazing Sevens Progressive reserve fund, the re-seed amount, up to the amount that the Casino funded, will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the Blazing Sevens Progressive Jackpot fund shall be documented in the accounting records.

#### **Administrative Fees**

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- a. \$0.20 will be immediately posted on the meter.
- b. \$0.80 will be tracked in a reserve fund.

The Casino will take an administrative fee ranging from \$10-\$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

# No Purchase Necessary

Upon request, a NPN table will be set up where a dealer will deal hands to the player and the dealer will take the role of the player-dealer hand. Tournament chips that have no cash value will be used to simulate betting. The person(s) can play for any duration of time with no restrictions. If the player achieves a qualifying jackpot hand, he/she will be awarded that amount according to the pay table. An entry will then be made on the computer to adjust the meter immediately after the prize has been awarded.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in Ocean's Eleven Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Bonus Chip values
- Buy-in amount for Bonus Chips
- Whether the Bonus Chip is single use or multi use
- Procedures to redeem Bonus Chips
- Any other applicable restrictions and/or information

# **Eligible Controlled Games**

The Bonus Chip Promotion will be attached to all Bureau approved California games offered at Ocean's Eleven Casino at all times the gaming activity is being offered for play. All controlled game rules will be played as approved by the Bureau.

# **Object and Summary**

The Bonus Chip Promotion will be open to all patrons who buy-in for a pre-determined amount ranging from \$5 to \$100,000; those patrons will receive a specific amount of Bonus Chips to play in any controlled game listed above. When patrons buy-in to a pre-determined game for a pre-determined and posted amount ranging from \$5 to \$100,000, he/she will receive a pre-determined and posted amount ranging from \$5 to \$200,000. The Bonus Chips are of a different style and design from the standard live casino chip ("casino chips"). The Bonus Chips cannot be exchanged for cash and must be played on the gaming table, at the pre-determined game. Once the Bonus Chip(s) has been placed as a wager the following applies:

- If the player wins, the player will receive live casino chips for his/her bet from the playerdealer. The player either retains the Bonus Chips to be used again or it will be collected by the house dealer and placed in the drop box for accounting purposes.
  - The designation of single use versus multi use will be clearly posted before the promotional period begins.
- If the player pushes, the Bonus Chips will remain with the player until the hand loses.
- If the player loses, the Bonus Chips are given to the player-dealer. - Casino employees off duty and out of uniform are eligible for the promotion.
- The player-dealer position is not eligible to participate in the promotion.
- Tournament games are not eligible to participate in this promotion.
- Backline bettors may not participate in this gaming activity.
- Bonus Chips can not be used in combination with live casino chips.

# **Prize**

The prize will be a fixed amount ranging from \$5 to \$200,000 in the form of Bonus Chips.

#### Funding

The Bonus Chip Promotion will be fully funded by Ocean's Eleven Casino. There will be no additional fees or collections taken for this gaming activity.

# Administrative Fees

There will be no administrative fees collected by Ocean's Eleven Casino for this promotion.

# **No Purchase Necessary**

The Bonus Chip Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Ocean's Eleven Casino at all times that the gaming activity is being offered for play:

- Eligible games.
- Eligible time period(s).
- Prize.
- Number of prizes to be given.
- Requirements for claiming the prize.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

# **Eligible Controlled Game**

The Bracket Busters promotion shall be attached to all limits and versions of all Bureau approved Poker games offered at Ocean's Eleven Casino. All base game rules shall be played as previously approved by the Bureau of Gambling Control.

# Rules of Play

During a pre-determined and posted bracketed sports tournament, the casino will allow eligible players to select the winners of each sporting event by submitting a bracket form with all winners prior to the start of the bracketed sports tournaments. Once the bracket forms are turned into floor staff, they are maintained at the workstation for the duration of the game and kept in the gaming administration office throughout the sports tournaments. The following rules apply:

Players must have a predetermined and posted number of hours of play ranging from one (1) to one-thousand (1,000), scanned by their player rewards card (GEGA-001753), prior to the start of the bracketed sports tournament to be eligible to submit a bracket form.

Pre-determined and posted point totals ranging from one (1) to twenty (20) shall be assigned to each win during each round of bracketed play in the tournament. # **Object and Summary**

The California Games Jackpot gaming activity features a fixed jackpot prize. A mandatory \$0.25 fee will be collected from the person or entity in the player-dealer position every hand during the pre-determined and designated time the promotion is being offered. The fee will be paid with a \$0.25 value casino chip. The jackpot collection fee will be placed in front of the player-dealer's wager and collected by the house dealer. The jackpot fee is collected before any cards are dealt. The jackpot prize amount will be split amongst all players with the qualifying hand, excluding backline bettors, at the table. Backline bettors are not eligible to participate in or win the jackpot. When a player places a base game wager, and makes one of the below listed qualifying hands, they will be awarded the posted fixed prize amount. When a qualifying hand is announced, a floor person will verify the hand qualifies.

#### **Qualifying Hands**

When a player has placed a base game wager and achieves the qualifying hand associated with each game listed below, the player will be awarded the posted fixed prize amount. Only one qualifying hand option will be offered and all qualifying hands within the option chart must be offered together at all times.

# **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- At a minimum, there must be two players playing for the table to be eligible; a player and a player-dealer.
- Players are eligible to win this promotion more than once.
- When a qualifying hand is announced, a floor person will verify both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- Casino employees, only off duty and out of uniform, are eligible to participate in the jackpot.
- Players playing Three Card Poker 6 Card Bonus are not required to place a bonus bet to be eligible for this jackpot.
- Players in the player-dealer position are not eligible for the jackpot.
- Backline bettors are not eligible to participate in the jackpot.
- A Third-Party Provider of Proposition Player Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the California Games Jackpot when either in the player-dealer nor the player capacity.
- Tournament Games are not eligible for the jackpot.

# **Prize**

The jackpot prize is fixed with a minimum value of \$10 and a maximum of \$100,000. The jackpot prize will be paid in the form of cash, casino chips, merchandise, trips, electronics, cars, Poker Tournament (GEGA-000542) entries, California Games Ticket Drawing Promotion (GEGA-004699) tickets, Qualifying Hands Match/Free Play (GEGA-004537) promotional chips, or Table Games Free Play Bet Voucher Promotion (GEGA-004539) vouchers. If merchandise and the like are awarded instead of cash or chips, the prize will have an equivalent dollar value as the posted prize amount. The prize will be paid to the winner when a casino floor person verifies the winning hand and all the proper forms are completed.

# **Funding**

The California Games Jackpot prize is a fixed, player-funded jackpot and utilizes one jackpot reserve fund. A \$0.25 value casino chip jackpot collection fee, taken from the player-dealer, will fund the jackpot fund. The entire \$0.25 jackpot fee goes into the jackpot reserve fund. The jackpot collection fee will be collected prior to the dealing of any cards and dropped in a separate drop box marked as "Jackpot" by the house dealer.

Ocean's Eleven Casino will seed the jackpot at a minimum of \$10. The Casino will be refunded the seeded jackpot amount from the jackpot reserve fund, once the jackpot reserve fund has sufficient funds. When a qualifying jackpot hand is achieved, the fixed prize payout will come from the jackpot reserve fund and the jackpot will be re-seeded by the jackpot reserve fund at a minimum of \$10. Also, the Casino will make up any shortfall in payouts and/or re-seed and be reimbursed from the jackpot reserve fund when there are sufficient funds in the jackpot reserve fund.

# **Administrative Fees**

The Casino will retain an administrative fee of a maximum of \$16 per table per hour from the jackpot reserve fund. The administrative fee will be used for marketing and operation costs.

# **No Purchase Necessary**

The California Games Jackpot will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material will state "No Purchase Necessary" when referencing the California Games Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

# OCEAN'S ELEVEN CASINO CALIFORNIA JACKPOT GAMES

# **Summary of Game**

Ocean's Eleven Casino proposes to add a progressive Jackpot element to our existing player-dealer style California/Asian Games. These games include Pai Gow Poker and No-Bust Blackjack. None of the Designated or Qualifying Hands will modify or "piggyback" on existing Jackpot Games.

Similar to the existing Jackpot element attached to our Caribbean Stud game, player(s) will be assessed a fixed fee, per hand, and will qualify for cash prizes when a Designated Hand is obtained or beaten by another Designated Hand. Prizes are paid from a prize pool ("California Jackpot Games Fund") funded by the fee paid by participating player(s). To alleviate any confusion on the player's part, a small table sign or similar instrument may be used to display the name of the available Jackpot Game, Jackpot Collection Fee, Qualifying or Designated Hands, and Jackpot Prize Distribution.

Players may qualify for the full California Jackpot Games Prize without paying a fee, or other type of consideration, by participating in free a game where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

The rules and standards of play for the California Jackpot Games are the same as the base rules currently approved for No Bust Blackjack and Pai Gow Poker. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player-dealer position, collection of table fees, betting limits and how winners are determined and paid, will all be consistent with existing procedures for each of the respective games. Since the Jackpot element will be added to existing games, no new tables will be utilized for the play of this game. The only change to the equipment will be the addition of a separate collection box, which will be secured to the table and will be designated for the Jackpot Collection and used only for the collection of the Jackpot Fee. This will insure that Jackpot Collections are kept separate and accounted for differently than the table fee collection for the casino.

#### The Prize

California Jackpot Games provide two levels of prizes to participating players: (1) Bad Beat Jackpot Prize and (2) Super Jackpot Prize. The Bad Beat Jackpot Prize is awarded when one player in a game obtains a specified hand but loses to a player with a better specified best hand ("Qualifying Hands"). The Bad Beat Jackpot Prize is progressive. The amount of the Bad Beat Jackpot Prize will vary depending on the volume of play and frequency with which players obtain a Qualifying Hand. The Super Jackpot Prize is a fixed amount.

Ocean's Eleven Casino will maintain all Jackpot Collections for the No Bust Blackjack game in one account and the Pai Gow Poker game in another. These funds

will not be commingled. The Jackpot Prizes will be posted on either an electronic board or poster centrally located in the California Games section of the Ocean's Eleven Casino. The posting may further be made by a table sign or similar instrument located at each table where the Jackpot Game is offered. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize. Initial seeding of the Bad Beat Jackpot Prize is expected to be a minimum of \$1,000 and initial seeding of the Super Jackpot Prize will be a minimum of \$2,000. Both Jackpots will be reseeded to at least the minimum immediately after a Jackpot Prize is paid to a winning player(s). The Bad Beat Jackpot Prize will be increased at least one time per day at a designated time that will be posted and made available to the participants. The Super Jackpot is not progressive and will not be increased. Ocean's Eleven Casino may provide multiples (i.e., 2x or 3x, etc.) of the Bad Beat and Super Jackpot Prizes during designated posted hours, from the reserve fund to add monies to the California Jackpot Prize and to the excitement of the game.

When player(s) obtain the specified hand combination and claim the Jackpot Prize, the Qualifying Hands will be verified by the dealer and a floorperson. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures. The winning players' identification will be obtained and necessary paper work completed prior to the payout of the Jackpot Prizes. Ocean's Eleven Casino will record all prizes awarded and the names of the winners as part of its California Jackpot Games accounting records.

In the case of a Bad Beat Jackpot Prize; after a winning hand is confirmed, the player who lost with the designated hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated better hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand, regardless of which betting circle they placed their wager in or whether they went "partners" or "kum-kum".

Only one Jackpot Prize will be paid per round of play. In the unlikely event that more than two players achieve a Qualifying Hand in the same round of play, only the two highest ranking hands qualify. The remaining players at the table will share the twenty percent (20%) portion. If a player happens to have a Qualifying Hand for both the Bad Beat and the Super Jackpot, the player will win both Jackpot Prizes. Ocean's Eleven Casino reserves the right to inspect all Qualifying Hands and to refuse payment of a Jackpot Prize. In the event that it is determined that proper procedures were not followed, rules were violated, or cheating occurred at any level, the payment will be refused for all participants. Ocean's Eleven Casino will document the event both by written report and video surveillance. The record of events surrounding a refusal to pay a Jackpot Prize will be memorialized and maintained Ocean's Eleven Casino in accordance with internal policy and procedures. These records will be made available to both Division and other law enforcement personnel, for review.

# · Funding

California Jackpot Games Prizes will be funded by a separate collection fee paid by players prior to the start of each hand ("Jackpot Collection"). The Jackpot Collection will be \$1.00 per hand, and will be paid by the player in the first player/dealer position. If more than one player is in the first player/dealer position (commonly referred to as kum-kum banking) then they will each pay half of the Jackpot Collection Fee. At all times, the amount of the Jackpot Collection will be conspicuously posted at each participating table, as well as on brochures relating to the California Jackpot Game(s).

Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. Ocean's Eleven Casino will provide the initial seeding of the California Games Jackpot Fund and may from time-to-time provide additional infusions of money to add to the size of the pool and the excitement of the game.

# **Jackpot Collection & Accounting Procedures**

The Jackpot Collection from all California Games will be collected, counted, secured and recorded in the same manner as the table fees paid to Ocean's Eleven Casino. The dealer will collect this fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be separate from the box used for table fees. Currently, all Jackpot Collection Boxes are located on the opposite side of the casino collection box. The locked Jackpot Collection Boxes will be gathered by casino security staff at designated times and transported to the secure count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards utilized by Ocean's Eleven Casino in collecting its table fees. The count of the Jackpot Collection will be separate and distinct from the counting of the casino's table fees. In addition, all count team activity is under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report ("Jackpot Collection Report") which will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City of Oceanside for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating California Games gaming table during each period the box is collected; generally once a day.

# No Purchase Necessary Procedures

California Jackpot Games will be offered for free, on a "general and indiscriminate" basis, to patrons who wish to participate in a 'No Purchase Necessary' game. Ocean's Eleven Casino will provide instructional or demonstration tables for all patrons who request to participate in California Games Jackpot Games without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary instructional or demonstration tables will be

eligible to win the full, posted Jackpot Prize if they participate in a game where they obtain the designated Jackpot Hand. All advertisements, flyers, brochures, and signs will have the word "No Purchase Necessary" along with instructions on how a patron can get details on how to participate for free (they will be told to contact a representative at the Welcome Desk or a casino supervisor.) There is no minimum participation in a No Purchase Necessary game. If one patron wants to participate for free, the casino dealer will deal one hand to that patron and the remaining hands to the remaining empty seats. With the exception of the participating No Purchase Necessary player's hand, the dealer will monitor and play all remaining hands the house way as if other players were participating. This simulates a full game and will allow the patron the optimal opportunity to qualify for the Jackpot Prize. If a designated hand is obtained, only the portion of the Jackpot Funds the No Purchase Necessary Player qualified for will be awarded. The remaining funds will stay in the Jackpot Fund.

# Third Party Providers of Proposition Player Services

Third Party Providers of Proposition Player Services (TPPPPS), as defined by Section 19984 of the California Business and Professions Code, their agents and employees, are not eligible to win any portion of the Jackpot Prize. If a TPPPPS receives a Qualifying Hand, its portion of the Jackpot Prize will not be paid and will remain in the California Jackpot Games Fund. If a TPPPPS is a participant in a Qualifying Hand with another player(s), the TPPPPS will not be eligible to receive its portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other player(s). This will be posted in all published rules, brochures and flyers relating to the California Jackpot Games.

#### Flat Administrative Fee

Ocean's Eleven Casino will retain a flat administrative fee of \$4.00 per table, per hour from the California Jackpot Games Fund based on the number of table hours that California Games Jackpot Games are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the California Jackpot Games Fund, nor will it be based on a percentage of the amount of money in the fund.

# **Eligibility for the Jackpot Prizes**

All players in participating California Jackpot Games (other than the TPPPPS), who obtain a Qualifying Hand and who have made a wager in the first player-dealer position or who have made a wager and paid the table fee in any non-player-dealer betting circle, regardless of the amount wagered, are eligible to win any of the California Jackpot Games Prizes. Patrons participating in the second or subsequent player-dealer position (commonly referred to as "backline banking") are not eligible to win the Jackpot Prize. Only the player(s) in the first or seated player-dealer position are eligible to win a Jackpot Prize. If there is more than one player with a wager in the first player-dealer position, the Jackpot Prize will be divided pro-rata, based on size of wagers, between the players in the first player-dealer position.

All players in the player position (the non-player-dealer positions), with the exception of the TPPPPS, who have made a wager and have paid the table fee for any betting circle, regardless of the amount wagered, are eligible to win the Jackpot Prize. Eligible players in the player positions on a single seat location will share the Jackpot Prize in equal shares regardless of the amount of their wagers. This will include "backline bettors"

# **Bad Beat Jackpot**

A hand that contains an ace-high flush or better in back and a pair in front lose to a full house or better in back with a higher pair in front. The Joker can be used.

# **Super Jackpot**

A hand that contains Aces-over-10's full house (Aces full) or better in back and a pair in front loses to a four-of-a-kind or better in back with a higher pair in front. The Joker can be used.

# **Super Jackpot Variations**

- a. A hand that contains a 10s full house or better in back with a pair in front loses to a better hand which beats both the front and back hands. The Joker can be used.
- b. A hand that contains a Jacks full house in back or better with a pair in front loses to a better hand which beats both the front and back hands. The Joker can be used.
- c. A hand that contains four of a kind or better in back with a pair in front beaten by a higher four of a kind in back or better with a higher pair in front. The Joker can be used.
- d. A hand that contains four of a kind or better in back with a pair in front beat by a Royal Flush in back and a higher pair in front. The Joker can be used.

Any Ace-King suited loses to Natural (two Jokers).

# CARIBBEAN STUD POKER JACKPOT

# SUMMARY OF GAME

Ocean's Eleven Casino proposes to add a progressive jackpot element to the game of Caribbean Stud Poker. Similar to the Jackpot games attached to Poker and Pai Gow Poker, players will be assessed a fixed fee, per hand and will qualify for a prize when a designated second hand is beaten by a designated first hand. Prizes are paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating players. Players may qualify for the full Caribbean Stud Poker Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

The rules and standards of play for the Caribbean Stud Poker Jackpots are the same as in Pai Gow Poker Jackpot Games. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player-dealer position, collection of table fees, betting limits and how winners are determined and paid will all be consistent with the approved version of Caribbean Stud Poker.

Since the jackpot element will be added to an existing game, the only change to the equipment will be in the addition of a separate collection box, which will be secured to the table and will be designated for the Jackpot Collection and used only for the collection of the jackpot funds. This will insure that Jackpot Collections are kept separate and apart from the table fee collection.

# THE PRIZE

A prize ("Jackpot Prize") will be awarded when one player at a game obtains a specified second hand but loses to a player who obtains a better specified first hand ("Qualifying Hand"). As this is a progressive jackpot, the amount of the Jackpot Prize will vary depending on the volume of play and frequency in which players obtain a Qualifying Hand. Ocean's Eleven Casino will control the allocation of the Jackpot Collection to Jackpot Prize. The available Jackpot Prize will be posted on either an electronic board or poster centrally located in the California Games section of the Casino. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize.

When players obtain the specified hand combination and claim the Jackpot Prize, the qualifying hands will be verified by the dealer and a floorperson. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures. The winning players' identification will be obtained and necessary paper work completed prior to the payout of the Jackpot Prizes. Ocean's Eleven Casino will

record all prizes awarded and the names of the winners as part of its Caribbean Stud Poker Jackpot accounting records.

# **FUNDING**

Caribbean Stud Poker Jackpot Prizes will be funded by a separate collection fee paid by players prior to the start of each hand ("Jackpot Collection"). The Jackpot Collection will be either \$1.00 or \$2.00 per hand depending on the stakes of the game. The amount of the Jackpot Collection will be posted within view of each participating table.

Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. Ocean's Eleven Casino will provide the initial seeding of the Jackpot Fund and may from time-to-time provide additional infusions of money to add to the size of the pool and the excitement of the game.

The Jackpot Collection will be posted by the player in the first Player-Dealer position. When there is more than one player participating in the first Player-Dealer position, the player who has the most money in action in the first Player-Dealer position will be responsible for posting the full Jackpot Collection.

# JACKPOT COLLECTION & ACCOUNTING PROCEDURES

The Jackpot Collection from all Caribbean Stud Poker will be collected, counted, secured and recorded in the same manner as the table fees paid to Ocean's Eleven Casino. The dealer will collect this fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be different from the box used for table fees. The locked Jackpot Collection Boxes will be guthered by casino security staff at designated times and transported to the secure Ocean's Eleven Casino count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by Ocean's Eleven Casino in collecting its table fees and in other United States garning jurisdictions. In addition, all count team activity is under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report ("Jackpot Collection Report") that will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City of Commerce for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating Caribbean Stud Poker gaming table during each shift,

# NO PURCHASE NECESSARY PROCEDURES

Caribbean Stud Poker Jackpots will be offered for free, on a "general and indiscriminate" basis, to patrons who wish to participate in a No Purchase Necessary game. Ocean's Eleven Casino will provide instructional tables for all patrons who request to participate in Caribbean Stud Poker Jackpots without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary instructional tables will be eligible to win the full-posted Jackpot Prize if they participate in a game where players obtain the designated Jackpot Hands. A person(s) that comes to play the jackpot at the "no purchase necessary" table will be dealt the maximum of eight hands. The no purchase necessary player will play only one hand and the casino dealer will play the remaining.

If the player wins the jackpot, only the portion of money that his/her hand qualifies for will be paid. The remainder will remain in the jackpot fund.

This will be done in the interest of fairness and in the spirit of the law, and as to give the no purchase necessary player the maximum opportunity to win the a portion of the jackpot prize.

# THIRD PARTY PROVIDERS OF PROPOSITION PLAYER SERVICES

Third Party Providers of Proposition Player Services, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("Prop Player"), are not eligible to win any portion of the Jackpot Prize. If a Prop Player receives a Qualifying Hand, its portion of the Jackpot Prize will not be paid and will remain in the Jackpot Fund. If a Prop Player is a participant in a Qualifying Hand with another player(s), the Prop Player will not be eligible to receive its portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other players.

# FLAT ADMINISTRATIVE FEE

Ocean's Eleven Casino will retain a flat administrative fee from the Jackpot Fund based on the number of table hours that Caribbean Stud Poker Jackpots are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the Jackpot Fund. Ocean's Eleven Casino reserves the right to adjust its flat Administrative Fee based on market factors and cost of operating Caribbean Stud Poker Jackpots. Ocean's Eleven Casino projects that its Administrative Fee will be in the range of \$3.00 to \$6.00 per table hour. Ocean's Eleven Casino will designate the flat Administrative Fee and will provide advance ample notice of its flat fee to all customers in accordance with Regulations adopted by the California Gambling Control Commission and/or the California Division of Gambling Control Regulations.

# **ELIGIBILITY FOR THE JACKPOT PRIZE**

Only patrons participating in the first Player-Dealer position is eligible to win the Jackpot Prize. If there is more than one player with a wager in the first player-dealer position, the Jackpot Prize will be divided pro-rata based on the amounts of their respective wagers between the players. All players in the player position, who have made a wager and have paid the table fee for any betting circle, regardless the amount wagered, are eligible to win and share the Jackpot Prize. Eligible players in the player position will share the Jackpot Prize in equal shares regardless of the amount of their wagers.

Super Jackpot: A full house ("second hand") beaten by the higher full house or better ("first hand").

After the winning hands in a Super Jackpot are confirmed, the player who lost with the designated second hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

Royal Jacknot: A flush or less ("second hand") beaten by a Royal Flush ("first band").

# **Customer Appreciation PROMOTION RULES**

- 1. To participate, a player must obtain a "Ocean's Eleven Players Card" by; providing a valid form of identification (includes date of birth) and having a picture taken.

A player intending to redeem his hours <u>must check his records</u> at the kiosk to **determine "reward availability**" then notify a floorperson and proceed to the cashiers' cage to receive his reward voucher. Any hours remaining will continue to accrue.
- 7. Any hours not redeemed at the end of the promotion will be of no future value.
- 8. <u>Any effort to circumvent the system</u> in order to obtain hours will result in a reduction of hours or disqualification from the promotion.

No purchase necessary. \*Demo tables available upon request. See floorperson for details.

Although the Bureau has approved this jackpot, jackpots with an electronic component are currently under Bureau review. - Any other restrictions that apply to this gaming activity

# **Object and Summary**

The EZ Baccarat Progressive Jackpot adds an optional \$1.00 player-funded progressive and fixed jackpot elements to the games of EZ Baccarat (GEGA-002990) and EZ Baccarat Panda 8 (GEGA-003724). The EZ Baccarat Progressive Jackpot considers both the player and banker hands. To begin each round, players must make their regular base game wager on the player or banker line. Players may optionally place any bonus bets along with the jackpot fee of \$1.00. Once the house dealer removes all jackpot fees from the table, the jackpot fees will be dropped into a separate and locked jackpot collection box. The house dealer then follows standard approved procedures for dealing the base game. When a winning jackpot hand is confirmed, the player with the qualifying jackpot hand will receive either a posted percentage of the progressive jackpot prize or a fixed prize, depending on the winning qualifying hand.

1. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the jackpot fee on the sensor. The sensor will then light up.

2. Once all players have placed their base wagers and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees will be dropped into a separate and locked jackpot collection box and accounted for separately.

# **Qualifying Hands**

If the banker hand wins with a two or three-card total of 7 points, and the player hand totals 0, all EZ Baccarat Progressive Jackpot wagers will win, according to the qualifying hands listed below. Only hands that have been Bureau approved and predetermined and designated by the Casino are eligible. Patrons will be provided with ample advance notice of what the qualifying hands are, as well as the requirements for completing the qualifying hands. Furthermore, the qualifying hands will be displayed prominently within the Casino at all times the EZ Baccarat Progressive Jackpot is being offered for play.

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying progressive and fixed hands within a chart must be offered together at all times.

# **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

 There is no time requirement for how long a game must be played in order to be eligible for a fixed or progressive jackpot prize.

- A player must play through the end of the round in order to qualify for a fixed or progressive jackpot prize.
- A player who is playing multiple hands is eligible to win more than one prize during a round of play.
- There is no limit to the number of times a player may win a fixed or progressive jackpot prize during any given promotional period.
- A player must make a base game wager in order to be eligible for a fixed or progressive prize.
- A minimum of two players, a player and a player-dealer, are required in order for the table to be eligible to participate in this promotion.
- In the event that more than one player qualifies for the progressive jackpot prize during the same round of play, all players with the qualifying hand shall share the prize in equal amounts.
- A player can qualify for the jackpot regardless of the outcome of the controlled game.

- All other hands are paid a fixed amount from the reserve fund, they do not get deducted from the amount shown on the meter.
- In the event more than one progressive qualifying hand is hit during the same round, all winning players will share, in equal amounts, the posted progressive prize amount.
  - o In the event there is an odd number of chips, the player closest to the player-dealer shall receive the extra chip(s).
- In the event that more than one player qualifies for a fixed jackpot prize during the same round of play, all players with the qualifying hand shall receive the posted prize amount.
- In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed from the reserve fund once sufficient monies are available.

# **Prize Payout Structure**

Players that make one of the advertised qualifying hands, as shown above, will be eligible to win their share of the posted EZ Baccarat Progressive Jackpot prize amounts, according to the payout option as shown below. Patrons will be provided with ample advance notice of the prize payout being offered for play. Furthermore, it will be displayed prominently within the Casino at all times the EZ Baccarat Progressive Jackpot is being offered for play.

# **Funding**

The EZ Baccarat Progressive Jackpot is a \$1.00 player funded progressive jackpot. The Casino will initially seed the jackpot at a minimum of \$1,000 and to a maximum of \$50,000. Once there are sufficient monies in the EZ Baccarat Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records.

After the progressive jackpot is hit, it will be re-seeded from the reserve fund at an amount between \$1,000 and \$50,000. In addition this reserve fund will payout all fixed prize amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the reserve fund, the re-seed amount will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records. All increases and decreases to the EZ Baccarat Progressive Jackpot reserve fund will be documented in the accounting records.

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- a. \$0.15 will be immediately posted on the meter
- b. \$0.85 will be tracked in a reserve fund

# **Administrative Fees**

The Casino will retain an administrative fee ranging in an amount between \$5-\$20, taken per table hour. The administrative fee will be taken from the reserve fund. The fee will cover the cost associated with the complicated computer system and program in addition to technicians having to service the systems.

# **No Purchase Necessary**

The EZ Baccarat Progressive Jackpot will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material will state "No Purchase Necessary" when referencing the EZ Baccarat Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>

#### Equipment

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI). If there is a malfunction or the digital reader breaks, the jackpot will not be offered.

- When a player has a progressive qualifying hand, the house dealer will press the appropriate hand button on the keypad.
- The house dealer will then contact a supervisor.

- Once a supervisor verifies the progressive win, the supervisor will press the confirm button. To complete the action, a supervisor or executive card (depending on jackpot level) swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting).
- When the house dealer reconciles all action, he/she presses "END GAME." This resets the system to begin the next hand.
- Once the supervisor or executive card (depending on jackpot level) is swiped the prize is logged into Game Manager
  - If the progressive pay needs to be backed out (voided) at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.

Ocean's Eleven Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-000130) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Ocean's Eleven Casino at all times that the gaming activity is being offered for play:

- Eligible games.
- Prize Amount.
- Number of hours of play that is required to receive a ticket.
- Eligible time period(s).
- No Purchase Necessary Procedures.
- Any other restrictions that apply to this gaming activity.

# **Eligible Controlled Game**

The Guess the Score promotion shall be attached to all Bureau approved controlled games offered at the Ocean's Eleven Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

# Rules of Play

During a pre-determined and posted scoring event, the casino will allow eligible players to select the final score of the sporting event by submitting a ticket with the name of each team and the team's corresponding final point total. In addition to the sport's teams, the player's name will be on the ticket. Players submit their tickets to the floor staff where they are held at a workstation in a locked container until the end of the sporting event. The following rules apply:

Players must have a predetermined and posted number of hours of play ranging from one to one hundred, scanned by their player rewards card (GEGA-001753) prior to the start of the sporting event to be eligible to submit a ticket.

Immediately after the sporting event, players' tickets will be reviewed by a floor person. If a patron has correctly guessed the final score of the game, that patron will receive the prize.

#### **Eligibility**

- There is no minimum number of players required to participate in the promotion.

The player who obtains the highest ranking predetermined qualifying hand during a predetermined and posted time period will win a predetermined and posted prize ranging in value from \$10 to \$50,000. The top hand shall be tracked on a display board in a prominent area of the Casino. The player with the high hand that meets all of the eligibility requirements must have their hand verified by a casino representative. After the hand is confirmed as the highest ranking qualifying hand in the predetermined designated time period, that player shall receive 100% of the posted prize amount.

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum of three players must be dealt into the game in order for the table to qualify for the promotion.
- Casino employees are eligible to participate in the promotion when off duty and out of uniform.
- No round of play needs to be reached in order to be eligible. A player needs to win the round in order to be eligible for the qualifying high hand.
- In order to qualify for the promotion, the player dealt the winning high hand must use both of their two hole cards.
- All qualifying hands must be verified by a casino representative in order to be eligible.
   Any deviation from a standard deck shall nullify a hand.

# Attachment to Application for Gaming Activity Review Name of Activity: Jackpots

# Description of Rules of Game:

The standards of play for the Poker games are the same standards and rules as have been submitted and approved by the Division previously. The Jackpot element of play will attach to all existing Poker games approved for play in Ocean's Eleven Casino. The rules and standards of play for those games will not change; we will merely add the Jackpot element. The number of cards used, the type of deck, the dealer, the number of players involved, provisions for collection of house fees, betting limits and schemes and how winners are determined and paid will all be consistent with those procedures and details currently in existence and previously approved by the California Division of Gambling Control.

The Jackpot element involves a progressive prize pool available to players who are participating in a card game. (It will be available whether the player is participating at a live Poker game or a no purchase necessary or demonstration table.) The jackpot prize will be awarded when a player at a Poker game obtains the second best specified hand but loses to another player at the same table obtaining the best-specified hand. All prizes will be awarded from a prize pool, which will be funded from fees paid by participating players. Ocean's Eleven Casino will provide initial seed money and may, from time to time and at its discretion, add additional funds to any jackpot. The jackpot prize will also be available to players participating in no purchase necessary Poker games at free demonstration tables. This will allow any player to have an equal opportunity to win the prize pool without paying any table fee collection or jackpot collection.

Prior to the start of each hand, players will contribute a set amount for the jackpot collection. Jackpot fees from each Poker game will be deposited at the table in a collection box, which is separate and apart from the box used for collecting table fees. The jackpot collection will be collected, counted and recorded separately on a Jackpot prize pool collection report, which will be maintained by our Accounting Department. The same accounting principles and safeguards as the Casino utilizes in the collection, counting and recording of its table fees will be utilized when dealing with jackpot collections. All jackpot funds will be maintained in a secure and separate account.

As this is a progressive jackpot, the amount of the prize available to participants in a Poker game at any given time will be posted on an electronic board centrally located in the Casino. When a player obtains the specified hand and claims the jackpot prize, the winning hand will be verified and the player's identification will be obtained prior to the payout of the prize. All prizes awarded and the names of the winners will be kept as part of our jackpot records. When a winning hand is confirmed, the player with the second best hand will receive 40% of the posted prize pool amount for that game, the player with the best hand will receive 20% of the prize pool and the remaining 40% of the prize pool

will be evenly distributed among all other players at the table with the winning hand, except the players that received a "Missed Blind" button.

All of the funds collected, as part of the jackpot collections will become part of the total prize pool available with the exception of a flat administrative fee, which will be withheld and accounted for. The flat administrative fee will be determined by the Casino and will take into consideration market conditions and the administrative cost of operating the jackpot element. Ocean's Eleven Casino currently anticipates that this administrative fee will be in the range of \$2.00 to \$6.00 per table hour. When a set rate has been finally determined all customers will be advised of that rate by its publication in any rule sheet or rule book which will be available to all customers.

As the jackpot element will be added to existing Poker games, there will be no new tables or equipment utilized for the play of this game. The only change to the equipment will be in the addition of a separate collection box, which will be secured to the table and will be designated as the jackpot collection and used only for the collection of the jackpot funds. This will insure that jackpot collections are kept separate and apart from the table fee collection.

A round of play for any Poker game incorporating the jackpot element will not change or deviate from the currently existing and previously approved format for all games. Should a player obtain the hand specified for a jackpot, the round of play will conclude with the pot being awarded to the winning hand. Thereafter, the existence of a specified jackpot hand will be confirmed and the posted jackpot prize will be awarded as stated above. Thereafter, a new round of play will begin. As we have not implemented the jackpot element, we do not have any video of the game being played.

This game has been approved for play at the Commerce Casino in Commerce, California and The Bicycle Casino in Bell Gardens, California.

# Jackpot Drop Dealing Procedures

- · Taking the Jackpot drop from the Blind
  - o Player will post money for their Blind.
  - o The dealer will scramble and shuffle the cards.
  - o The dealer will take the Jackpot drop from the Blind.
  - o If any color change of the chip is needed, the entire transaction will occur in front of the dealer's tray.
  - O The dealer will take the chip and hold it in their left hand with their index finger and thumb. The slot must remain completely visible to the surveillance cameras.
  - o The dealer will then open their left hand to show that the chip had been dropped.
  - o The dealer will now cut the cards and deal out the hand.

# **Jackpots**

In all jackpot Poker games, any exposing of cards or conversation relating to the value of a hand will void any possible jackpot on that hand.

In jackpot games, the dealer is to count the stub of the deck to verify completeness and scramble the deck every hand.

Jackpots at Ocean's Eleven Casino are raised daily. An estimation is made of the number of hands in each game per hour and is correlated with the number of games by hour and is multiplied to figure the approximate current jackpot drop for that period. A figure of 40% to 60% of that number is added to the jackpot and posted at the designated time with 40% to 60% retained to make up for the seed. However, the percentage of the posting is always adjusted to reflect the rate of the number of jackpots that are actually hit and the actual jackpot count.

The "seed" is an amount of money the house posts in advance for a jackpot after a jackpot has been hit. This is money that is advanced by the house and must be made up out of the jackpot pool, otherwise jackpots would all start at \$0.

In all jackpot Poker games, a predetermined set amount is taken from each pot and placed into the jackpot drop. For all games with betting limits of \$1-\$2, the jackpot collection will be \$.50. For all other games with betting limits up to \$9-\$18, the jackpot collection will be \$1.00. These amounts will be posted at the tables. This revenue goes into the jackpot pool that is separated from all other monies in the Casino and is kept in a separate jackpot account. This money belongs to the players.

If jackpots are in the process of being changed, and a jackpot is hit, the jackpot will be paid at the amount it was being raised to. If the jackpot board change has not begun, and a jackpot is hit, the amount paid will be as it appears on the board.

After a jackpot is hit, the dealer will immediately count down the deck to make sure that the exact number of cards and the proper suits and rank are in compliance with a standard deck. Should there be a deviation, i.e. a card missing, two cards of the same suit, extra cards, etc., the jackpot may be declared null and void.

Any communication among players, whether verbal or not, indicating that one player already has a jackpot hand or is drawing to a jackpot hand or makes remarks or signs that lead other players to believe that this is the time to attempt to play for a jackpot hand – such communication will render any subsequent jackpot null and void.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Ocean's Eleven Casino at all times the promotion is being offered:

- Eligible games and time periods.
- Coupon/ticket value(s).
- Procedures to redeem coupons or free play chips.
- Any other applicable restrictions.

# **Controlled Game**

The Match Play/Free Play Coupon Promotion may be attached to all limits and versions of the currently Bureau approved California games offered at the Ocean's Eleven Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

#### Rules of Play

Patrons are awarded match play or free play coupons or tickets via hand-delivery on or off the premises by authorized gambling establishment personnel, advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Players who receive a match play coupon or ticket will be eligible to win the specific amount printed on the coupon or ticket if he/she places a wager on an eligible game equal to the amount listed on the match play coupon or ticket. The player would give the coupon or ticket to a floor person or key employee. The floor person or key employee would log the coupon or ticket. #### **Eliqibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

# **SUMMARY OF THE GAME**

Ocean's Eleven Casino proposes to add an entry ticket promotion for a daily progressive cash drawing to its existing No Bust Blackjack game. Under this proposal, four (4) cards per deck being used in a No Bust Blackjack game will be stamped with the word "entry" on the value side. Players who receive one of the cards will receive a ticket for an entry into a cash drawing. Players may qualify for the promotion without paying a fee, or other consideration, by requesting a free ticket and/or participating at a free instructional game where there is no live wagering, no Jackpot Collection, and no table fees ("No Purchase Necessary").

With the exception of the rules and procedures related to the funding and distribution of the No Bust Blackjack 'Treasure' element, the rules and standards of play for the No Bust Blackjack game remain the same. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player/dealer position, collection of table fees, betting limits, and how winners are determined and paid will all be consistent with existing procedures.

Since the promotional element will be added to an existing No Bust Blackjack game, there will be no new tables for the play of this game. The only change to the equipment will be four (4) cards per 53 card deck used in the No Bust Blackjack 'Treasure' Promotion will be stamped "entry" on the value side. The cards which will be stamped are random in choice.

#### THE PRIZE

Ocean's Eleven Casino proposes to add an entry ticket promotion for a daily progressive cash drawing to its existing No Bust Blackjack game. Under this proposal, four (4) cards per deck being used in a No Bust Blackjack game will be stamped with the word "entry" on the value side. Players who receive one of the cards will receive a ticket for an entry into a cash drawing. Players may qualify for the promotion without paying a fee, or other consideration, by requesting a free ticket and/or participating at a free instructional game where there is no live wagering, no Jackpot Collection, and no table fees ("No Purchase Necessary").

With the exception of the rules and procedures related to the funding and distribution of the No Bust Blackjack 'Treasure' element, the rules and standards of play for the No Bust Blackjack game remain the same. # **Object and Summary**

The Poker Jackpots gaming activity features a progressive jackpot prize. A prize is awarded to players participating in any designated poker game, as stated above, when a designated poker hand, which contains two hole cards, is beaten by a better qualifying hand, which contains two hole cards, at the showdown. Additionally, if the Jumbo Jackpot is being offered, if both the winning and losing hands contain pairs in the hole cards, the Jumbo Jackpot will be won. When the winning and losing hands are confirmed, those players with the qualifying jackpot hands shall receive the posted percentage of the progressive jackpot prize payout structure.

Also, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all the other players at the qualifying table who have participated in the designated game, as shown below.

#### **Qualifying Hands**

Players who achieve one of the following advertised winning or losing qualifying hands during the play of an eligible poker game shall be eligible to win their share of the Poker Jackpots prize amount. Only winning and losing hands that have been Bureau approved and pre-determined and designated by the Casino are eligible.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Players with qualifying winning and losing hands must play through the final betting round in order to qualify for the jackpot.
  - o If a player with one of the qualifying hands folds prior to the final betting round, the table will be in-eligible for the jackpot.
- When a qualifying hand is announced, a floor person shall verify that both hands qualify.
   Any deviation from a standard deck will nullify the jackpot.

# **Prize**

The jackpot prize is progressive with a minimum value of \$500 and a maximum of \$1,000,000. The jackpot prize shall be paid in the form of cash, check or live casino chips. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how many days have transpired in order for the posted jackpot prize to increase progressively each day. The Jumbo Jackpot will be awarded if both the winning and losing hands have pocket pairs. The prize amount, if greater than the standard bad-beat jackpot prize, will be awarded when both the winning and losing hand contain pairs and all other jackpot policy and procedures are followed. #### **Funding**

The Poker Jackpots gaming activity utilizes one jackpot account which shall be funded by the previously approved fees collected on the Jackpots attached to Poker Games (GEGA-002252). The Ocean's Eleven Casino will initially seed each of the three prize pools with amounts ranging from \$500 to \$100,000. Each Poker Jackpots gaming activity prize pool is separately increased daily, from the reserve account, at pre-determined and designated times with an amount ranging from \$50 to \$5,000. #### **Object and Summary**

The Poker Pyramid is a player-funded promotion that features a specific fixed prize amount for each qualifying hand. A board is used to arrange the prize amounts that are available for players to win. The board consists of two parts: the qualifying hands, which make up the base, and the prize amounts, which make up the pyramid (see below for an example of a pyramid). Players who achieve a qualifying hand while participating in a Bureau approved controlled game, as listed above, are awarded a predetermined and posted prize from the pyramid. When a casino representative confirms the player has achieved a qualifying hand, the player will immediately receive the corresponding prize amount on the pyramid. The casino representative removes the prize and the qualifying hand from the list of eligible hands on the pyramid. After the removal of a prize, the next prize in sequence will be awarded to the next qualifying hand achieved. Prizes are awarded from left to right, one row at a time until the row is empty, before the next row of prizes to be awarded begins. An entire row of prizes must be completed before the next row of prizes will be offered. No specific sequence is required to make the qualifying hands. This will continue until there is one prize left (the top of the pyramid) and, therefore, one qualifying hand left on the pyramid base. The Casino will display the Poker Pyramid board (with qualifying hands and prizes) prominently near the eligible gaming tables.

# **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours posted for the gaming activity.

- Each game will have a corresponding pyramid for payouts. Each controlled game will be independent of the other controlled games and will have its own pyramid board.

Tickets are earned at a rate of one ticket for every 60 minutes played. The drawing tickets are eligible for only the promotional period they are earned in. The Casino will print the drawing ticket and the only information on the ticket will be the person's player reward card number (GEGA-002288). Only players with a player reward card (GEGA-002288) will be able to participate in the jackpot at live poker game tables. When a player sits at an eligible table, the player will give their player reward card (GEGA-002288) to the house dealer and the house dealer will then scan the player's reward card (GEGA-002288). The player reward card (GEGA-002288) information is entered electronically via the Poker Atlas system. In addition, the player will have to see a casino representative to have their ticket(s) printed. If a patron does not possess nor wants to have a player reward card, the Casino will allow the player to play at a No Purchase Necessary table to play for the required time to earn a ticket. The ticket in this instance will have only the patron's name on it. The drawing ticket enters the player into a drawing for a chance to win a prize with a value between \$10 and \$10,000.

Winners will be randomly drawn from all ticket entries. A portion of the posted amount may be paid and/or rolled over to the same time slot the next scheduled drawing day if a winner did not claim the prize on the first drawing.

# **Poker Ticket Drawing Promotion**

  - If a patron does not want nor have a player reward card (GEGA-002288), the Casino will allow the player to participate at a No Purchase Necessary table to play for the required time to earn a ticket. The ticket in this instance will only have the patron's name on it.
- There is a minimum of three players that must be playing in a poker game in order for the table to be eligible for the drawing.
- Players must see a casino representative to have their ticket(s) printed.
- A player who participates in an approved controlled game, as listed above, for the
  posted amount of time (at a minimum of 60 minutes) will be awarded with a drawing
  ticket. Tickets are earned at a rate of one ticket for every 60 minutes played.
- There is no limit to the number of tickets and prizes a player may win during any given promotional period.
- The wheel must make one complete revolution for the spin to be valid.
- Any interference with the rotation of the wheel will invalidate the spin, and the wheel will be re-spun.
- The casino representative on duty will draw the winning tickets.
- When a ticket is drawn and the name and/or number on the ticket is announced, the patron has two minutes to claim their prize.
  - If the patron does not claim their prize in the allotted time, the ticket will be placed back in the container and another ticket will be drawn. This process will continue until a pre-determined number of drawings has taken place or until the prize is claimed.
  - A portion of the posted amount may be rolled over to the same time slot the next scheduled drawing day if a winner did not claim the prize during the first drawing.
- Tournament game tables are not eligible for this gaming activity.
- Casino employees are eligible to participate in the promotion when off duty and out of uniform.

#### **Poker Ticket Drawing Promotion**

- A Third-Party Provider of Proposition Player Services (TPPPS) is eligible to participate in this gaming activity when off duty.
- Tickets are non-transferrable and can only be used by the player who earned them. The winning player will have their identification checked by a casino representative before the prize is awarded.

# **Prize**

The Poker Ticket Drawing Promotion features a fixed prize element. A player who plays in an approved controlled game for at least 60 minutes will be entered into a drawing where the winner of the drawing will be awarded a prize or a chance to spin a wheel for cash and prizes. The cumulative value of any and all prizes won will range from \$10 to \$10,000. Examples of prizes include: cash, live casino chips, merchandise, tournament entries (GEGA-000542), and special event tickets. The prize(s) will be pre-determined and posted by the casino.

#### **Funding**

The Poker Ticket Drawing Promotion is fully funded by the currently approved Jackpots attached to Poker Games (GEGA-002252). Therefore, there will be no additional jackpot fees or collection fees taken for this promotion. All fee collections and table limits are for the designated base games and are Bureau approved, pre-determined and posted at each table.

# **Administrative Fees**

Ocean's Eleven Casino will not retain an administrative fee as administrative fees are already collected from the currently approved Jackpots attached to Poker Games (GEGA-002252).

## No Purchase Necessary

The Poker Ticket Drawing Promotion will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material will state "No Purchase Necessary" when referencing the Poker Ticket Drawing Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

#### **SUMMARY**

Based on customer demand and industry trends, Ocean's Eleven Casino (OEC) proposes to add a gaming activity for the currently approved poker tournaments: GEGA-000542. The promotion will award players who make a pre-determined hand in a tournament a cash prize via a player funded progressive jackpot, commonly referred to as a Bad-Beat Jackpot.

#### **PRIZE**

The prize will be a progressive cash amount that will be initially seeded at the minimum of \$1,000.00 and will increase by a minimum of \$1.50 per player that buys in to the tournament when there is a weekly poker tournament (satellite and special tournaments are not included). All weekly tournaments will be eligible and play for the same jackpot and jackpot prize. All jackpot funds collected from each player's buy-in for all weekly tournaments will go into one posted progressive jackpot, The loser of the hand will receive 25% of the posted progressive jackpot, 25% of the posted progressive jackpot will be awarded to the winner, and the remaining 50% of the posted progressive jackpot prize will be equally divided among the players that participated in that particular hand at that particular table.

#### **FUNDING**

This promotion will be funded by each player that buys-in to the weekly poker tournament (satellite and special tournaments are not included). \$1.50 will be taken from each player's buy-in, which will not be included in the tournament prize pool. \$1.00 will be posted to the progressive jackpot and \$.50 will go to the reserve fund. The \$1.00 will be placed in the posted jackpot will be added to the following jackpot and not the one that the player currently buys-in for. When a player buys into a weekly tournament, they will be playing for the posted progressive jackpot prize at the time of the tournament. All jackpot fees collected for that tournament will be added to the posted progressive jackpot after the tournament and will be available during the next weekly tournament.

Once the posted jackpot is awarded, all monies in the reserve jackpot fund will be posted and immediately be made available for players to win. If during a weekly tournament, the jackpot is hit and awarded, the reserve fund will be used to reseed the posted progressive jackpot immediately and will be available to be won during that same tournament. Another reserve will then be started and funded by the \$.50 of each \$1.50 collected for each players' buy-ins during weekly poker tournaments (satellite and special tournaments are not included).

An administrative fee of \$.15 for each jackpot collection fee collected may be taken by OEC to administer the jackpot. This includes, but is not limited to; accounting, surveillance, security, administrative processing including IRS forms and internal forms used to track and safeguard the jackpot fund.

#### **NO PURCHASE NECESSARY**

A person who wishes to participate in this promotion for free, on a "no purchase necessary" (NPN) basis may do so by being at the NPN poker table during the tournament. The NPN player must adhere to all rules as the tournament player.

An OEC card dealer will deal the cards to the NPN player(s) and to all empty spots simulating a full game. All hands will be monitored and played by the dealer to simulate a live game. No collection, fees, or wagers will be made at this table. If a player at the NPN player qualifies for a portion of the jackpot, they will receive that amount and the remainder will be kept in the jackpot fund.

#### **ELIGIBILITY TO WIN**

All players who participate in the hand where the jackpot is hit will qualify to win a portion of the prize. The same will apply to any NPN participants. A minimum of three players must enter into the weekly Poker Tournament, otherwise, that weekly tournament will be in-eligible to participate in the jackpot. Furthermore, there is must be two players seated at a table in order to be eligible for the jackpot. Both hole cards for the winning and losing hands must play in order to qualify for the jackpot. Players with qualifying winning and losing hands must play through the final betting round, which is after 'the river,' in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round, the table will be in-eligible for the jackpot.

#### **WINNING EVENT**

Any four of a kind must be beaten by any better four of a kind. Both players must use both of their hole cards and their kicker (the fifth card) must beat the boards (community cards) kicker. After a bad-beat jackpot hand is made play will stop while the OEC floor person verifies all aspects of the game which may include a review of the surveillance coverage for the table. Any deviation from rules, policy and/or procedures will deem the jackpot hand(s) null and void and no monies will be awarded.

When monies are awarded, all policy and procedures and required local state and federal tax documentation will be recorded without exception. All forms and documents will be saved for seven (7) years.

#### THIRD PARTY PROVIDER OF PROPOSITION PLAYER SERVICES

Third Party Provider of Proposition Player Services, as defined in Section 19984 of the California Business and Professions Code, will not participate in this promotion, as they do not play within their capacity, at the poker table.

#### **BASE GAME RULES**

All base game rules that have been approved by the Bureau of Gambling Control for the poker games and poker tournaments, that the jackpots are attached to, will be followed. There are no changes whatsoever.

Poker Tournament Jackpots. Other names may be used. In all cases the assigned GEGA number will be affixed to all signage, flyers, advertisements, etc.

# **Bureau Requirements**

#### Advertising

The Ocean's Eleven Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-000542) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Ocean's Eleven Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by Ocean's Eleven Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- The rules and procedures for any and all gaming activities that are being offered in conjunction with the poker tournaments.
- Any other restrictions that apply to the Poker Tournaments.

#### Advertising for Gaming Activities Associated with the Poker Tournaments

- The rules and procedures for any and all gaming activities that are being offered in conjunctions with the Poker Tournaments.
- All information related to prize ranges and amount for all gaming activities associated with the Poker Tournaments
- Patrons will be given ample notice of which gaming activity option is being offered, and it will be displayed prominently via printed flyers, digital display, and any other forms of advertisements Ocean's Eleven Casino uses to promote the tournament(s).
- Bounty(s) gaming activity may be offered to tournament patrons who pay the buy-in and entry fee. If the bounty is offered, the gaming activity advertising will be prominently posted with the prize amount and how the bounty will be funded.
- Poker Tournament Jackpots (GEGA-000617) will be offered to tournament patrons who pay the buy-in and entry fee, and to "No Purchase Necessary" patrons. The promotions will be prominently posted with how the prize is funded.

#### **Tournament Log**

The Ocean's Eleven Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. - Amount and reason for any deductions from the total collected prize pool
- Name of gaming activities offered (when applicable)
  - o Funding source
  - o Prize amount
  - Total number of prizes awarded
  - Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the total amount paid out and amount paid for each place in the tournament
- Printed name and signature of casino staff responsible for administering the tournament

# **Eligible Controlled Games**

The controlled games that may be played during Poker Tournaments at Ocean's Eleven Casino shall only be those as listed below. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-001746)
- Omaha (GEGA-001707)
- Omaha High-Low Split 8 or Better (GEGA-001747)
- Seven Card Stud (GEGA-001748)
- Seven Card Stud High-Low Split 8 or Better (GEGA-001706)

#### **Gaming Activities Offered During Tournament Play**

#### **Bounties**

Bounties are house funded and may be offered to tournament patrons who pay the buy-in and entry fee. If bounties are offered, when the "advertised bounty" player(s) is/are knocked out ending their tournament play, then the player eliminating the "advertised bounty" player(s) will be awarded the prize. If the advertised bounty player(s) are not knocked out during the tournament, then the prize goes to the bounty player(s).

- The bounties will be paid during the tournament or as soon as their tournament play ends. If there are multiple winners, the prize will be split evenly.
- The prize amount will range from \$25 to \$2,500 and be paid out in live chips, cash, or a combination of both.
- When a bounty(s) is offered during tournament play, then the bounty prize amount will be funded from the Casino general account, not from entry fees or buy-ins.

#### Point System

# **Tournament Prize Amounts & Source of Funds**

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The cardroom may provide prizes or add funds to the prize pool for special events.

 When the prize amount is guaranteed the payouts will be a cash value ranging from \$5,000-\$1,000,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, Ocean's Eleven Casino will fund the difference.

#### **Tournament Prize Structure**

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and "split" the total prize pool among them, it shall be permitted and shall be noted in detail on the casino's tournament log.

Possible Additional Prizes: The prize will be Casino funded and may be a fixed cash amount, merchandise, jewelry, trips, extra tournament chips, and vehicles.

#### **No Purchase Necessary**

The casino shall provide NPN tables for patrons who request to participate in the gaming activities attached to the Poker Tournaments without paying any entry into the tournament. The NPN player must adhere to all rules as the tournament player. All advertisements shall state "No Purchase Necessary" when referencing the gaming activities offered during the Poker Tournaments.

<sup>\*\*</sup>The service charge is used exclusively to pay the tournament staff for tips, etc. This is not income for the casino.

<sup>\*\*\*</sup>The staff add-on fee shall be retained by the casino and used exclusively to compensate staff for services related to tournament. This shall be an optional fee that tournament entrants may pay in exchange for additional tournament chips. This fee shall not be included in the tournament prize pool.

## **Racing for Dollars**

## **Advertisement Requirements**

Ocean's Eleven Casino may advertise various names for this gaming activity. Should Ocean's Eleven Casino advertise a different name, the BGC ID listed below shall be referenced on all advertisements relating to the Racing for Dollars promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in Ocean's Eleven Casino at all times that the promotion is being offered:

- Eligible games and time periods.
- Time amount required to be played and the corresponding promotion prize amount.
- The time required to be played to earn a prize.
- Possible prizes
- The dates(s) and time(s) the promotion shall be offered.
- Any other applicable restrictions.

## **Controlled Games Offered**

The Racing for Dollars gaming activity may be attached all Bureau approved games offered at Ocean's Eleven Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

## **Rules of Play**

This gaming activity is a player rewards program open to all Ocean's Eleven Casino patrons. This promotion will reward players with a prize based on time of play at designated table games during pre-determined and eligible periods.

## **How Prizes are Earned Based on Time Played**

- 1. Wheel has 100 spots with varying dollar amounts.
- 2. Drawings held once per hour, 7 days a week, 24 hours a day.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Ocean's Eleven Casino at all times that the gaming activity is being offered for play:

- Eligible controlled games.
- Date and time of eligible sporting events.
- Scoring events that trigger the drawing.
- Availability of No Purchase Necessary.
- Amount to be added to the pot (prize amount).
- Any other restrictions that apply to this gaming activity.

## **Eligible Controlled Game**

The Sport's Scores promotion shall be attached to all limits and versions of all approved Poker games offered at Ocean's Eleven Casino. All base game rules shall be played as previously approved by the Bureau of Gambling Control.

## Rules of Play

The Sport's Scores gaming activity features a promotional element which shall be attached to the approved poker games at the Casino. If a pre-determined and posted scoring event occurs during the sporting event, a gambling enterprise employee shall place a tag, corresponding to each active poker table, in a receptacle for each live poker game, and live No Purchase Necessary poker table, at the time of the scoring event. The gambling enterprise employee will then draw one live game tag from the receptacle and then distribute that fixed and predetermined amount of cash or chips into the pot of the next hand to be dealt by the dealer. ## **Object and Summary**

The Three Card Poker Progressive Jackpot considers the best advertised qualifying hand(s) among each individual player's cards. Players may place an optional \$1 jackpot fee for a chance to win the Three Card Poker Progressive Jackpot. Also, when a player places the optional \$1 jackpot fee they will also qualify to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1 jackpot fee win the envy payout. The player with the qualifying hand receives the normal prize pay only, and does NOT receive the envy pay. The Three Card Poker Progressive Jackpot will be offered at multiple tables during the promotional period.

1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bet wagers along with the jackpot fee of \$1.00. A minimum of two players are required to play for the progressive jackpot.



- 2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.

- Corresponding time played and points amount
- The date(s) and time(s) the gaming activity shall be offered
- How the number of points earned corresponds to the amount in prize value
- The possible prize(s) offered for meeting the requirements of the gaming activity
- The possible bonus rates offered on play during off-peak hours or in specific games
- The redemption period will be displayed in the Ocean's Eleven Casino to give players ample notice

Ocean's Eleven Casino may offer bonus rates (for example, double points) on play during offpeak hours or in specific games, within the range as shown above. Furthermore, it will be displayed prominently via printed flyers, digital display, and any other forms of advertisements.

## **How Player Points are Redeemed**

Ocean's Eleven Casino will decide if patrons may either redeem their points at any time during the promotion or at the end of the promotional period. ## **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Only seated players who are dealt a designated hand are eligible for payouts.
- A minimum of two players, a player and a player-dealer, are required to play for the progressive jackpot.
- Backline bettors are not eligible to place a jackpot collection fee or receive the prize amount for a qualifying hand.

#### Funding

The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the reserve fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit, it will be re-seeded by the reserve fund in the amount of \$1,000. In the event the reserve fund is depleted, the Casino will make up any shortfall and will not be reimbursed.

The progressive prize pool shall increase daily based solely on the number of jackpot collection fees placed and collected each day. Furthermore, there is no cap on this progressive prize pool. Each \$1.00 jackpot fee paid by a player will be broken down as follows:

## **Object and Summary**

Patrons are awarded Match Play, Free Play Voucher or a Promotional Chip after earning a qualifying hand. Qualifying hands shall be based on one of the preselected and posted schedule options listed below. Players who receive a Match Play Voucher will be eligible to win the specific amount printed on the Match Play Voucher if they places a wager on an eligible game equal to the amount on the Match Play Voucher. Players who receive a Free Play Voucher or Promotional chip will be eligible to win the specific amount on the Free Play Voucher or Promotional Chip on an eligible game without being required to place a bet. A casino representative will then take the chips back to the player-dealer. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

**EXAMPLE**: A person receives a qualifying hand at a qualifying game and receives a Match Play Voucher with a value of \$5.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. If the player wins the hand, they will receive \$10.00 just as if they had placed a \$10.00 bet and the player-dealer will collect the voucher.

## Free Play Voucher or Promotional Chip

The Casino will offer Free Play Vouchers or Promotional Chips having a face value from \$5 to \$1,000 each. The amount will be clearly printed on the Free Play Voucher or Promotional Chip. The Free Play Vouchers or Promotional Chip shall be offered to all patrons after earning a qualifying hand. Qualifying Hands shall be based on one of the preselected and posted schedule options listed below. The Free Play Voucher will also state redemption/expiration date. There are no expiration or redemption dates needed for Promotional Chips as they are used immediately. The Free Play Vouchers or Promotional Chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash. Promotional chips have no cash value, all voucher rules apply. Players who receive a Free Play Voucher or Promotional Chip will be eligible to win the specific amount printed on them on an eligible game without being required to place a bet. ## One Time Use Free Play Voucher

When a player has played the Multiple Use Table Games Free Play Bet Voucher or Promotional Chips on a Bureau Approved California Game and the player wins, the casino employee will verify the win and the player shall win the value that is printed on the Free Play Voucher or Promotional Chip, the Free Play Voucher or Promotional Chip will be paid by the player in the player-dealer position and the player may continue to use the voucher or promotional chip until it loses. If the player loses the Free Play Voucher or Promotional Chip, a casino representative will verify the loss and the Free Play Voucher or Promotional Chip will be given to the player in the player-dealer position.t. The player-dealer may redeem the promotional chips or vouchers at their discretion at the casino cage. Vouchers will be verified and accounted for before shredding them by the casino cage staff. The voucher or promotional chip may not be used for bets with payouts greater than 3:2.

## **Qualifying Hands**

Players that make one of the following advertised qualifying hands shall be eligible to win Match Play or Free Play Vouchers. The following qualifying hand chart options shall not be offered together at any time nor may any combination of the different qualifying hand chart options be offered together at any time that this gaming activity is being offered. Players that make the designated qualifying hands will be eligible to win their share of the Fixed Poker Super Jackpots prize pool, based on the payout structure option being used, as shown below. Only one of these prize payout structure options shall be offered at any one time that the jackpot is being offered for play. No combination of the prize payout structure options shall be offered together at any time that this gaming activity is being offered.

Patrons shall be provided with ample advance notice of which prize payout structure option is being offered for play. Once the Casino designates a prize payout structure option, the payout structure shall not be adjusted or changed until the jackpot has been hit and awarded. Furthermore, the prize payout structure will be displayed prominently via printed flyers, digital display, and any other forms of advertisements.

## **Option C**

- Players who obtain a qualifying Losing Hand shall win the corresponding percentage of the prize pool, depending on the selected prize payout structure option.
- If multiple players obtain a qualifying Losing Hand, only the highest ranked Losing Hand will win the Losing Hand share of the prize pool.
- If multiple players obtain the same qualifying Losing Hand, all eligible players will win and evenly split the Losing Hand share of the prize pool.
- If there is an odd number of chips the player closest to the dealer in a clockwise direction will be awarded the extra chip.
- Players who obtain the qualifying Losing Hand will not be eligible for the Table Share or the Floor Share.
- Players who obtain a qualifying Winning Hand shall win the corresponding percentage of the prize pool, depending on the selected prize payout structure option.
- If multiple players obtain a qualifying Winning Hand, only the highest ranked Winning Hand will win the Winning Hand share of the prize pool.
- If multiple players obtain the same qualifying Winning Hand, all eligible players will win and evenly split the Winning Hand share of the prize pool.

- o If there is an odd number of chips the player closest to the dealer in a clockwise direction will be awarded the extra chip.
- Players who obtain the qualifying Winning Hand will not be eligible for the Table Share or the Floor Share.
- Active players who are at the same table where the qualifying losing and winning hands are obtained, will split the Table Share percentage of the prize pool, depending on the selected prize payout structure option.
  - If there is an odd number of chips the casino will make up the short fall and will not be reimbursed.
- Active players who are at a table, within the casino, where the table limit is the same as
  the table limit for the table where the losing and winning hands are obtained, will evenly
  split the Floor Share percentage of the prize pool, depending on the selected prize pool
  structure option.
  - If there is an odd number of chips the casino will make up the short fall and will not be reimbursed.

## **Funding**

The Fixed Poker Super Jackpots consists of a player-funded prize pool. During all eligible games, when four or more players are dealt in on a hand, a \$2 jackpot fee is taken from the pot, after the flop, and will then be placed in a separate and locked jackpot fee box, which will be apart from the regular house collection fees. If the hand does not reach the flop the jackpot fee will not be collected and the Fixed Poker Super Jackpots will not be offered for that hand.

Additionally, whenever the Casino is required to seed the jackpot prize pool or cover a shortfall due to inadequate funds in the reserve fund, the Casino shall be reimbursed once there are sufficient funds in the reserve account.

## **Administrative Fees**

The Casino shall retain an administrative fee of \$5 to \$25 per table per hour. The administrative fee shall be taken from the reserve fund. This fee shall cover the costs associated with prizes, administering and accounting for the jackpot.

#### **No Purchase Necessary**

The Fixed Poker Super Jackpots shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material shall state "No Purchase Necessary" when referencing the Fixed Poker Super Jackpots. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>
