#### **Rules of Play**

The Bonus Chip Promotion will be open to all patrons who buy-in to a pre-determined game for a pre-determined amount ranging from \$10 to \$100,000. Participants will receive a specific amount of Bonus Chips in any controlled game listed above.

#### **Purchasing Bonus Chips**

Players may purchase bonus chips at the cage at pre-determined and posted times. When patrons buy-in to a pre-determined game for a pre-determined and posted amount ranging from \$10 to \$100,000, they will receive an amount ranging from \$1 to \$10,000 in bonus chips for buying into a predetermined game.

#### **Bonus Chips:**

The prize shall be awarded to a player when he/she redeems one of the aforementioned advertisements. The player will receive the advertised amount of bonus chips. The bonus chips are of a different style and design from the standard casino chip. The bonus chips can not be exchanged for cash and must be played on the gaming table. Once the bonus chip has been placed as a wager the following applies:

- Bonus chips shall not be used to pay collections.

### **Eligibility**

The Bonus Chip Promotion will be open to players who buy into a pre-determined game and who will receive a specific amount of Bonus Chips.

- The required buy in will range from \$10 to \$100,000.
- Players shall not exchange Bonus Chips for live chips.
- The Bonus Chips are non-transferable between players.

#### **Object and Summary**

The Cash and Prize Drawings Promotion features a promotional element attached to the Bureau approved California games as listed above, offered at Parkwest Casino Lotus. The promotion will reward players with a ticket(s) based on the pre-determined and designated qualifying hand at designated table games during pre-determined and eligible periods.

Players may also earn a ticket(s) by playing certain table games based on pre-determined and designated time periods; 1–20 tickets can be earned per hour of play. A player's time will be tracked through the Player Loyalty Rewards Program (GEGA-002789) or manually on a log controlled by a Casino employee.

## Cash and Prize Drawings

The Casino may offer bonus tickets, 1 to 20, during off-peak hours or in specific games; this applies to both qualifying hands and based on time played. Patrons will be given ample notice for the amount of time and how many tickets will be awarded. A patron can earn tickets by achieving a below listed qualifying hand and on time played.

The drawing ticket is a standard raffle ticket divided into two sections, one section for the player and one section for the Casino. The player must retain their portion of the ticket to claim the prize. Furthermore, the player fills out the Casino section of the ticket with their first and last name, game, table number and date, gives the Casino portion of the ticket to a Casino employee to deposit in the secure container. The ticket will then be used for drawings for the Cash and Prize Drawings Promotion.

The section with the player information will be retained by the Casino and deposited in a secure container. The container will be maintained on the Casino floor and monitored by the surveillance system and Casino personnel. The tickets will be mixed up using a clear rotating plastic bin. The winning ticket will be drawn by a casino floor person. The tickets are only valid for the current promotional period and expire at the end of the promotional period. The plastic bin will be emptied and the remaining tickets destroyed at the end of the promotional period.

### Qualifying Hands

A player who achieves one of the qualifying hands listed below shall earn one ticket to be entered into a Cash and Prize Drawing for a predetermined and posted prize. An iTouch, iPad, or similar tablet computer device, with a bar code reader, will be affixed to the gaming table and a gambling establishment employee will scan the player's card. The gambling establishment employee will then input the player's average wager and time played into the computer tablet device.

- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management. 2015 one except the network administrator(s) has access to the back-end systems where the data is stored. Access to the data is by user level with multiple levels based on what the user will be doing. Marketing managers will have access to customer data for marketing purposes (i.e., emails, texts, mass mailing, etc.)
- A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available at anytime at their request.

### **How Player Rewards Points are Earned Based on Time Played**

Points shall be earned based on the amount of time played. Each player that plays a certain table game during live play will, at certain times, receive points, which will gain them eligibility to win pre-determined and designated prizes. The range of points will be 1 to 200,000 points for each hour of play. The Lotus Casino may offer bonus rates (for example, double points) on play during off-peak hours or in specific games, within the range as shown above. ### **How Player Rewards Points are Redeemed**

Players may either redeem their points at any time during the promotion or at the end of the promotional period. The redemption period will be displayed in The Lotus Casino to give players ample notice. Points not redeemed by the end of the promotional period will expire within 30 days of the promotional period. All prizes shall have a pre-determined and designated value. wager is collected by the player/dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

**"Free Play Chip(s)"**

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips are initially in the form of a coupon which will be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Each coupon will state the specific qualifying game(s) that the free play chip(s) may be used on.

Promotional chips are used as the player's bet and placed on the betting circle. Promotional chips are never taken into the dealer's tray, nor are they ever paid from the dealer's tray.

EXAMPLE: A person receives a free play chip coupon for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player/dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

8. Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.

If a player wins a hand on a base game where they have played a match play coupon or free play chip, he/she will be awarded 100% of the face value on the coupon or chip.

Once the original seeded amount is depleted the funds may be re-seeded by the Casino. Appropriate records will be kept and available for inspection as required by law.

#### **Object and Summary**

During predetermined and posted promotional periods, patrons who are Customer Incentive Program members (GEGA-004485), and who sign-up and pay a corresponding monthly fee, are eligible to receive one or more predetermined and posted prizes throughout the promotional period.

All VIP Prime Members are subject to the same monthly fee, are eligible to receive the same prize(s), and will have the same amount of time to claim their prize(s) as all other VIP Prime Members during the posted promotional period. ### **Object and Summary**

The California Games Jackpot gaming activity features a fixed and progressive jackpot prize. Players must pay an optional \$1 jackpot fee in order to be eligible to win the prize and achieve a designated qualifying hand as listed below. A prize is awarded to players, who have paid the \$1 jackpot fee, in any designated California game referenced above, when the player-dealer has been dealt a qualifying hand. After the hand has been confirmed, those players who paid the jackpot fee shall receive the posted prize from the progressive jackpot or the fixed prize jackpot dependent on the qualifying hand.

### **Qualifying Hands**

When the player-dealer makes one of the following advertised qualifying hands during the play of an eligible California game, all players who paid the jackpot fee shall be eligible to win their share of the posted California Games Jackpot progressive prize amount, as shown below. The payout shall be split evenly for the posted progressive amount among the players who placed a jackpot bet and the posted fixed amount will be given to each player who placed a jackpot bet. Only the following hands that have been Bureau approved, predetermined, and designated by

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled games during the predetermined and specified hours designated and posted for the gaming activity.



## California Games Jackpot

- When a qualifying hand is announced, a casino representative shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is a minimum of two players (player and player-dealer) required to be dealt in during an eligible game in order for players to be eligible for the California Games Jackpot prize amount.
- The \$1 jackpot collection fee shall be placed on the designated betting circle.
- Players are eligible to win this promotion more than once.
- Backline bettors are eligible to participate in this jackpot. However, the base game rules must allow for backline betting and there must be an open backline betting position.
- Only off duty, out of uniform, casino employees shall be eligible to participate in the California Games Jackpot promotion.
- Third-Party Provider of Proposition Player Services, on and off duty, shall not be eligible to participate in the California Games Jackpot promotion.
- A patron in the player-dealer position shall be eligible to win their share of the fixed/progressive prize, so as long as they pay the jackpot fee and achieve a qualifying hand.
- Patrons playing in tournament games are not eligible to participate in the promotion.

### **Prize**

The jackpot prize is fixed and progressive with a minimum value of \$5 and a maximum of \$1,000,000. Every eligible game has the opportunity to win either the progressive or the fixed prize, depending on the qualifying hand.

The fixed jackpot prize shall be paid out in the form of cash, live casino chips, merchandise, trips, tournament entries, and electronics. If the value of the prize is lower than the advertised fixed jackpot, the Casino will make up the difference with another form of prize listed above.

The progressive jackpot prize shall be paid out in the form of cash or live casino chips, and the amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

### **Prize Payout Structure**

There is only one prize pool. The California games patrons will be playing for the same progressive and fixed prizes. The payout shall be split evenly for the posted progressive amount among the players who placed a jackpot bet and have qualifying hands. If a qualifying hand is made with a fixed prize amount, each player who placed a jackpot bet will receive the entire posted amount. Payouts will be made to each active player and any backline positions for this position, then payout to the next active position and backline bettor and continue in this procedure.

### **Funding**

The California Games Jackpot gaming activity utilizes one Jackpot account which shall be funded by a \$1 jackpot collection fee which shall be dropped in a separate drop box marked as "Jackpot." The prize pool shall be initially seeded at a minimum of \$5,000 by Parkwest Casino Lotus. Parkwest Casino Lotus will be reimbursed the seed amount when the reserve account has sufficient funds. When the \$1 jackpot collection has been taken, \$0.25 of the jackpot fee will go to the progressive prize pool and \$0.75 of the jackpot fee shall be placed in the reserve account. The jackpot has a \$1,000,000 cap. Once the jackpot reaches the cap amount, all other jackpot collection fees collected shall be placed in the jackpot reserve account. All fixed prizes will be taken from the reserve account. When a qualifying jackpot hand is achieved and

paid out, the jackpot amount will be re-seeded by Parkwest Casino Lotus with an amount ranging from \$5,000 to \$50,000. Parkwest Casino Lotus shall cover any shortfall and shall be refunded by the reserve account when there are sufficient funds. If there are insufficient funds in the reserve account, the casino shall absorb the cost until there are sufficient funds in the reserve account.

### **Administrative Fees**

Parkwest Casino Lotus shall retain an administrative fee of \$5-\$10 per table per hour from all approved California games and will be taken from the reserve account. This fee will be used to cover advertising for the jackpot prize, security to pull and count the boxes, accounting, equipment, surveillance, and the cost of the gambling establishment personnel that administer the jackpot.

### **No Purchase Necessary**

The California Games Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the California Games Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.
