### WHO MUST FILE?

Commercial coventurers must register with the Attorney General's Registry of Charities and Fundraisers Charitable Trusts prior to engaging in any coventure activities in California unless exempt pursuant to Government Code section 12599.2, subdivision (be).

#### WHEN TO FILE?

Commercial coventurers, as set forth above, must register annually in California for each calendar year in which the coventure activity occurs, unless exempt. The deadline for filing the registration form is January 15 of the applicable year.

### FEE MUST ACCOMPANY REGISTRATION

A registration fee of \$500 must accompany each annual registration form. Checks should be made payable to the ATTORNEY GENERAL'S REGISTRY OF CHARITIES AND FUNDRAISERSCHARITABLE TRUSTS. Registration forms not accompanied by full payment will not be processed and will be returned.

### FEES MAY BE IMPOSED FOR DELINQUENT FINANCIAL REGISTRATION

Government Code section 12586.1 authorizes the Attorney General to charge late fees for each month or part of a month for registrations not received by January 15. This section can be found on the Charitable Trusts Section website at www.oag.ca.gov/charities under "Laws & Regulations."
