NOTICE OF MODIFICATIONS TO TEXT OF PROPOSED REGULATIONS

Notice published August 5, 2025

Pursuant to the requirements of Government Code section 11346.8, subdivision (c), and section 44 of Title 1 of the California Code of Regulations (CCR), the Department of Justice (DOJ) is providing notice of changes made to proposed regulation sections 900 through 906, of title 11, division 1, chapter 9 of the CCR and the incorporated documents, Child Abuse or Severe Neglect Indexing Form, BCIA 8583, Child Abuse Central Index (CACI) Self Inquiry Request for Out-Of-State Foster Care & Adoption Agencies Form, BCIA 4056, Child Abuse Central Index (CACI) Inquiry Request Form, BCIA 4057, and Facsimile Inquiry For Child Abuse Central Index (CACI) Check, BCIA 4084. These proposed regulations were the subject of a Notice of Proposed Rulemaking published in the California Register (Register 2025, No. 4-Z) on January 24, 2025. These changes are in response to comments received regarding the proposed regulation and for clarification purposes.

Changes made to the text after the 45-day comment period are illustrated in **bold double underline** for proposed additions and ~~**bold double strikethrough**~~ for proposed deletions.

Additionally, DOJ is proposing changes to the following documents incorporated by reference:

- DOJ proposes to repeal the 03/09 version of the Facsimile Inquiry for Child Abuse Central Index (CACI) Check (BCIA 4084, rev. 03/09), rather than the 11/09 version that was previously noticed on January 24, 2025.
- DOJ proposes to amend the Child Abuse Central Index (CACI) Self Inquiry Request for Out-Of-State Foster Care & Adoption Agencies Form (BCIA 4056, rev. 11/2024) that was previously noticed on January 24, 2025.
- DOJ proposes to amend the Child Abuse Central Index (CACI) Inquiry Request Form (BCIA 4057, rev. 06/2024) that was previously noticed on January 24, 2025.
- DOJ proposes to amend the Request for Child Abuse Central Index (CACI) Search Form (BCIA 4084, rev. 06/2024) that was previously noticed on January 24, 2025.
- DOJ proposes to amend the Child Abuse or Severe Neglect Indexing Form (BCIA 8583, rev. 06/2024) that was previously noticed on January 24, 2025.
- DOJ proposes to adopt the Instructions for Completing the Child Abuse or Severe Neglect Indexing Form (BCIA 8583) (rev. 03/2025).

Changes made to the BCIA 4056, BCIA 4057, BCIA 4084, and BCIA 8583 after the 45-day comment period are illustrated in **bold blue double underline** for proposed additions and ~~**bold red double strikethrough**~~ for proposed deletions.
