This emergency action adopts regulations implementing the statutory certification requirements for cigarettes pursuant to the California Cigarette Fire Safety and Firefighter Protection Act upon transition the administration of the state's fire safety compliant cigarette program from the State Fire Marshal to the Department of Justice (DOJ) effective January 1, 2023. (Health & Saf. Code, §§ 14950-14959; AB 1742.) This emergency is deemed pursuant to Health & Safety Code, section 14954, subd. (e).) This action also amends regulations to implement the California tobacco directory related to the DOJ fire safety certifications. This emergency is deemed pursuant to Revenue and Taxation Code, § 30165.1, subd. (n).)

OAL approves this emergency regulatory action pursuant to sections 11346.1 and 11349.6 of the Government Code.

This emergency regulatory action is effective on 6/19/2023 and will expire on 12/19/2023. The Certificate of Compliance for this action is due no later than 12/18/2023.
