1. **DEFINITIONS**

- "Accessible Component" means a component of a Covered Product that could 1.1 be touched by a person during normal or reasonably foreseeable use.
- "Covered Products" means Fashion Accessories that are (a) Manufactured by 1.2 Settling Defendant, or (b) distributed for resale or sold for resale by Settling Defendant, or (c) sold or offered for retail sale as a Private Label Covered Product by Settling Defendant where Settling Defendant is (i) the Private Labeler or (ii) a sister, parent, subsidiary, or affiliated entity that is under common ownership of the Private Labeler of such product.

2.1 The parties to this Consent Judgment ("Parties") are the Center for Environmental Health ("CEH") and defendant Iron Fist International, Inc. ("Settling Defendant").

- 2.2 On August 24, 2011, CEH served a 60-Day Notice of Violation on Settling Defendant under Proposition 65 (The Safe Drinking Water and Toxic Enforcement Act of 1986, California Health & Safety Code §§ 25249.5, *et seq.*), alleging that Settling Defendant violated Proposition 65 by exposing persons to Lead contained in wallets, handbags, purses, and clutches, without first providing a clear and reasonable Proposition 65 warning.
- 2.3 Settling Defendant offers Fashion Accessories for sale in the State of California or has done so in the past.
- 2.4 On June 24, 2009, CEH filed the action entitled *CEH v. Lulu NYC LLC*, *et al.*, Case No. RG 09-459448, in the Superior Court of California for Alameda County, alleging Proposition 65 violations as to wallets, handbags, purses and clutches.
- 2.5 On October 5, 2011, CEH filed an action entitled *CEH v. Bioworld Merchandising, Inc., et al.*, Case No. RG11598596, in the Superior Court of California for Alameda County, alleging violation of Proposition 65 with regard to the "manufacture, distribution, sale and/or use" of "wallets, handbags, purses and clutches made with leather, vinyl or imitation leather materials" (the "*Bioworld* Action"). On November 2, 2011, CEH filed a Doe amendment adding Settling Defendant as a defendant in the *Bioworld* action.
- 2.6 On or about February 8, the *Bioworld* Action (among other cases) was consolidated with the *Lulu* Action for pre-trial purposes under Lead Case No. RG 09-459448.
- 2.7 For purposes of this Consent Judgment only, the Parties stipulate that this Court has jurisdiction over the allegations of violations contained in the operative Complaint applicable to Settling Defendant (the "Complaint") and personal jurisdiction over Settling Defendant as to the acts alleged in the Complaint, that venue is proper in the County of Alameda, and that this Court has jurisdiction to enter this Consent Judgment.
- 2.8 Nothing in this Consent Judgment is or shall be construed as an admission by the Parties of any fact, conclusion of law, issue of law or violation of law, nor shall compliance

with the Consent Judgment constitute or be construed as an admission by the Parties of any fact, conclusion of law, issue of law, or violation of law. Nothing in this Consent Judgment shall prejudice, waive or impair any right, remedy, argument or defense the Parties may have in any other legal proceeding. This Consent Judgment is the product of negotiation and compromise and is accepted by the Parties for purposes of settling, compromising and resolving issues disputed in this action.

3. INJUNCTIVE RELIEF

3.1 **Specification Compliance Date.** To the extent it has not already done so, no more than 30 days after the Effective Date, Settling Defendant shall provide the Lead Limits to its current Vendors of Fashion Accessories and shall instruct each Vendor to use reasonable efforts to provide Fashion Accessories that comply with the Lead Limits on a nationwide basis.

3.2 Lead Limits.

Subject to Section 3.4 below, commencing on January 1, 2013, Settling Defendant shall not purchase or Manufacture any Covered Product that will be sold or offered for sale to California consumers that exceeds the following Lead Limits:

- 3.2.1 Paint or other Surface Coatings on Accessible Components: 90 parts per million ("ppm").
 - 3.2.2 Leather (including composited leather) Accessible Components: 300 ppm.
 - 3.2.3 Polyvinyl chloride ("PVC") Accessible Components: 200 ppm.
- 3.2.4 All other Accessible Components other than cubic zirconia (sometimes called cubic zirconium, CZ), crystal, glass or rhinestones: 300 ppm.
- Retail Compliance. Subject to Section 3.4 below, commencing on May 1, 2013 (the "Final Retail Compliance Date"), Settling Defendant shall not sell or offer for sale in California any Covered Product, as specifically defined herein, that exceeds the Lead Limits specified in Section 3.2. For purposes of this Section 3.3, when Settling Defendant's direct customer, if any, sells or offers for sale to California consumers a Covered Product after the applicable Final Retail Compliance Date, Settling Defendant is deemed to "offer for sale in California" that Covered Product. For purposes of this Section 3.3, Settling Defendant shall not

shall be displayed in such a manner that it is likely to be read and understood prior to the authorization of or actual payment.

3.5 Action Regarding Specific Products.

- 3.5.1 On or before the Effective Date, Settling Defendant shall cease selling the Iron Fist Yellow Polka Dot Party Wallet with Black Bow, Style No. IFL0746WEB, as identified in CEH's 60-day pre-suit notice (the "Section 3.4 Product"). On or before the Effective Date, Settling Defendant shall also: (i) cease shipping the Section 3.4 Product to any of its customers that resell the Section 3.4 Product in California, and (ii) send instructions to its direct customers that resell the Section 3.4 Product in California instructing them to cease offering the Section 3.4 Product for sale in California.
- 3.5.2 If Settling Defendant has not complied with Section 3.4.1 prior to executing this Consent Judgment, it shall instruct its California stores and/or customers that resell the Section 3.4 Product either to (i) return all the Section 3.4 Products to the Settling Defendant for destruction; or (ii) directly destroy the Section 3.4 Products.
- 3.5.3 Any destruction of Section 3.4 Products shall be in compliance with all applicable laws.
- 3.5.4 Within sixty days of the Effective Date, Settling Defendant shall provide CEH with written certification from Settling Defendant confirming compliance with the requirements of this Section 3.4.

4. ENFORCEMENT

- 4.1 Any Party may, after meeting and conferring, by motion or application for an order to show cause before this Court, enforce the terms and conditions contained in this Consent Judgment. Enforcement of the terms and conditions of Section 3.2 and 3.3 of this Consent Judgment shall be brought exclusively pursuant to Sections 4.3 through 4.4.
- 4.2 Within 30 days after the Effective Date, Settling Defendant shall notify CEH of a means sufficient to allow CEH to identify any Covered Products currently supplied or offered by Settling Defendant as of that date, for example, a unique brand name or characteristic system of product numbering or labeling. Information provided to CEH pursuant to this Section 4.2 may

be designated by Settling Defendant as competitively sensitive confidential business information, and if so designated shall not be disclosed to any person without the written permission of Settling Defendant. Any motions or pleadings or any other court filings that may reveal information designated as competitively sensitive confidential business information pursuant to this Section shall be submitted in accordance with California Rules of Court 8.46 and 2.550, *et seq*.

- 4.3 **Notice of Violation.** CEH may seek to enforce the requirements of Sections 3.2 or 3.3 by issuing a Notice of Violation pursuant to this Section 4.3.
 - 4.3.1 **Service of Notice.** CEH shall serve the Notice of Violation on Settling Defendant within 45 days of the date the alleged violation(s) was or were observed, provided, however, that CEH may have up to an additional 45 days to provide Settling Defendant with the test data required by Section 4.3.2(d) below if it has not yet obtained it from its laboratory.
 - 4.3.2 **Supporting Documentation.** The Notice of Violation shall, at a minimum, set forth for each Covered Product: (a) the date(s) the alleged violation(s) was observed, (b) the location at which the Covered Product was offered for sale, (c) a description of the Covered Product giving rise to the alleged violation, and of each Accessible Component that is alleged not to comply with the Lead Limits, including a picture of the Covered Product and all identifying information on tags and labels, and (d) all test data obtained by CEH regarding the Covered Product and related supporting documentation, including all laboratory reports, quality assurance reports and quality control reports associated with testing of the Covered Products. Such Notice of Violation shall be based at least in part upon total acid digest testing performed by an independent accredited laboratory. Wipe, swipe, x-ray fluorescence, and swab testing are not by themselves sufficient to support a Notice of Violation, although any such testing may be used as additional support for a Notice. The Parties agree that the sample Notice of Violation attached hereto as Exhibit A is sufficient in form to satisfy the requirements of subsections (c) and (d) of this Section 4.3.2.

4.3.3 Additional Documentation. CEH shall promptly make available for inspection and/or copying upon request by and at the expense of Settling Defendant, all supporting documentation related to the testing of the Covered Products and associated quality control samples, including chain of custody records, all laboratory logbook entries for laboratory receiving, sample preparation, and instrumental analysis, and all printouts from all analytical instruments relating to the testing of Covered Product samples and any and all calibration, quality assurance, and quality control tests performed or relied upon in conjunction with the testing of the Covered Products, obtained by or available to CEH that pertains to the Covered Product's alleged noncompliance with Section 3 and, if available, any exemplars of Covered Products tested.

- 4.3.4 **Multiple Notices.** If Settling Defendant has received more than four Notices of Violation in any 12-month period, at CEH's option, CEH may seek whatever fines, costs, penalties, or remedies are provided by law for failure to comply with the Consent Judgment. For purposes of determining the number of Notices of Violation pursuant to this Section 4.3.4, the following shall be excluded:
- (a) Multiple notices identifying Covered Products Manufactured for or sold to Settling Defendant from the same Vendor; and
- (b) A Notice of Violation that meets one or more of the conditions of Section 4.4.3(b).
- 4.4 **Notice of Election.** Within 30 days of receiving a Notice of Violation pursuant to Section 4.3, including the test data required pursuant to 4.3.2(d), Settling Defendant shall provide written notice to CEH stating whether it elects to contest the allegations contained in the Notice of Violation ("Notice of Election"). Failure to provide a Notice of Election shall be deemed an election to contest the Notice of Violation.
 - 4.4.1 **Contested Notices.** If the Notice of Violation is contested, the Notice of Election shall include all then-available test data regarding the alleged violation. Within 30 days the parties shall meet and confer to attempt to resolve their dispute. Should such attempts at meeting and conferring fail, CEH may file an enforcement motion or

application pursuant to Section 4.1. If Settling Defendant withdraws its Notice of Election to contest the Notice of Violation before any motion concerning the violations alleged in the Notice of Violation is filed pursuant to Section 4.1, Settling Defendant shall make a contribution to the Proposition 65 Fashion Accessory Testing Fund in the amount of \$12,000 and shall comply with all of the non-monetary provisions of Section 4.4.2. If, at any time prior to reaching an agreement or obtaining a decision from the Court, CEH or Settling Defendant acquires additional test data regarding the alleged violation, it shall promptly provide all such test data to the other Party.

4.4.2 **Non-Contested Notices.** If the Notice of Violation is not contested, Settling Defendant shall include in its Notice of Election a detailed description of corrective action that it has undertaken or proposes to undertake to address the alleged violation. Any such correction shall, at a minimum, provide reasonable assurance that the specifically identified Covered Product will no longer be offered by Settling Defendant or its customers for sale in California. If there is a dispute over the sufficiency of the proposed corrective action or its implementation, CEH shall promptly notify Settling Defendant and the Parties shall meet and confer before seeking the intervention of the Court to resolve the dispute. In addition to the corrective action, Settling Defendant shall make a contribution to the Fashion Accessory Testing Fund in the amount of \$10,000, unless one of the provisions of Section 4.4.3 applies.

4.4.3 Limitations in Non-Contested Matters.

- (a) If it elects not to contest a Notice of Violation before any motion concerning the violation(s) at issue has been filed, the monetary liability of Settling Defendant shall be limited to the contributions required by this Section 4.4.3, if any.
 - (b) The contribution to the Fashion Accessory Testing Fund shall be:
 - (i) One thousand seven hundred fifty dollars (\$1750) if Settling Defendant, prior to receiving and accepting for distribution or sale the Covered Product identified in the Notice of Violation, obtained test results demonstrating that all of the Accessible Components in the Covered

Product identified in the Notice of Violation complied with the applicable Lead Limits, and further provided that such test results would be sufficient to support a Notice of Violation and that the testing was performed within two years prior to the date of the sales transaction on which the Notice of Violation is based. Settling Defendant shall provide copies of such test results and supporting documentation to CEH with its Notice of Election;

- (ii) One thousand five hundred dollars (\$1500) if Settling Defendant is in violation of Section 3.3 only insofar as that Section deems Settling Defendant to have "offered for sale" a product sold at retail by Settling Defendant's customer, provided however, that no contribution is required or payable if Settling Defendant has already been required to pay a total of ten thousand dollars (\$10,000) pursuant to this subsection. This subsection shall apply only to Covered Products that Settling Defendant demonstrates were purchased or Manufactured by Settling Defendant prior to January 1, 2013.
- (iii) Not required or payable, if the Notice of Violation identifies the same Covered Product or Covered Products, differing only in size or color, that have been the subject of another Notice of Violation within the preceding 12 months.
- 4.5 Additional Enforcement for Noncompliant Non-Covered Products. If CEH alleges that Settling Defendant sold or offered for retail sale to California consumers a Fashion Accessory: (i) that is not a Covered Product, (ii) that contains Lead in an amount that exceeds any of the applicable lead limits, and (iii) for which Settling Defendant did not provide a clear and reasonable warning as required by Proposition 65 ("Noncompliant Non-Covered Product"), then prior to CEH serving a 60-Day Notice under Proposition 65 on Settling Defendant, CEH shall provide notice to Settling Defendant pursuant to this Section 4.5.
 - 4.5.1 The notice shall contain the information required for a Notice of Violation in Section 4.3. If the information is insufficient to allow Settling Defendant to identify the

Noncompliant Non-Covered Product and/or Vendor, it may request that CEH provide any further identifying information for the Noncompliant Non-Covered Product that is reasonably available to it.

- 4.5.2 Within 30 days of receiving a notice pursuant to Section 4.5, or of any requested further information sufficient to identify the Noncompliant Non-Covered Product, whichever is later, Settling Defendant shall serve a Notice of Election on CEH. The Notice of Election shall:
- (a) Identify to CEH (by proper name, address of principal place of business and telephone number) the person or entity that sold the Noncompliant Non-Covered Product to Settling Defendant;
- (b) Identify the manufacturer and other distributors in the chain of distribution of the Noncompliant Non-Covered Product, provided that such information is reasonably available;
- (c) Include either: (i) a statement that Settling Defendant elects not to proceed under this Section 4.5, in which case CEH may take further action including issuance of a 60-Day Notice under Proposition 65; (ii) a statement that Settling Defendant elects to proceed under this Section 4.5, with a description of corrective action that meets the conditions of Section 4.4.2., and a contribution to the Fashion Accessory Testing Fund in the amount required under Section 4.5.6, or (iii) a statement that Settling Defendant contends that the Noncompliant Non-Covered Product is released from liability by a Qualified Settlement under Section 4.5.4 along with a copy of such Qualified Settlement.
- 4.5.3 A party's disclosure pursuant to this Section 4.5 of any (i) test reports, (ii) confidential business information, or (iii) other information that may be subject to a claim of privilege or confidentiality, shall not constitute a waiver of any such claim of privilege or confidentiality, provided that the Party disclosing such information shall clearly designate it as confidential. Any Party receiving information designated as confidential pursuant to this Section 4.5.3 shall not disclose such information to any unrelated person or entity, and shall use such information solely for purposes of resolving any disputes

under this Consent Judgment.

- 4.5.4 No further action is required of Settling Defendant under this Consent Judgment if the Noncompliant Non-Covered Product is otherwise released from liability for alleged violations of Proposition 65 with respect to Lead in the Noncompliant Non-Covered Product by the terms of a separate settlement agreement or consent judgment entered into by CEH under Health & Safety Code § 25249.7 ("Qualified Settlement").
- 4.5.5 If Settling Defendant elects not to proceed under Section 4.5, then neither Settling Defendant nor CEH has any further duty under this Section 4.5 and either may pursue any available remedies under Proposition 65 or otherwise. If Settling Defendant elects to proceed under Section 4.5.2(b)(ii), then compliance with that Section shall constitute compliance with Proposition 65 as to that Noncompliant Non-Covered Product.
- 4.5.6 If Settling Defendant elects to proceed under this Section 4.5 and is not relieved of liability under Section 4.5.4, Settling Defendant shall make a contribution to the Fashion Accessory Testing Fund in the amounts that follow unless one of the provisions of Section 4.4.3(b) applies, in which case the applicable amount specified in Section 4.4.3(b) if any, shall instead apply. The contribution shall be \$5,000 if at least one of the person(s) identified by Settling Defendant pursuant to Section 4.5.2 (i) is a person in the course of doing business as defined in Health & Safety Code § 25249.11(b) and (ii) has a principal place of business located within the United States, and \$10,000 for all other notices.
- 4.5.7 If Settling Defendant makes a contribution pursuant to this Section and at a later date CEH resolves the alleged violation with the direct or indirect Vendor of the Noncompliant Non-Covered Product, CEH shall notify Settling Defendant and Settling Defendant shall be entitled to a refund of the lesser amount of its contribution or the settlement amount paid by such Vendor. If the settlement or consent judgment between CEH and the direct or indirect Vendor of the Noncompliant Non-Covered Product does not provide for the refund to be paid directly by the Vendor to Settling Defendant, then

CEH shall pay the refund to Settling Defendant within 15 days of receiving the Vendor's settlement payment.

4.5.8 Any notice served by CEH pursuant to this Section 4.5 shall not be considered a Notice of Violation for purposes of Section 4.3. Nothing in this Section 4.5 affects CEH's right to issue a 60-Day Notice under Proposition 65 against any entity other than a Settling Defendant.

5. PAYMENTS

- Judgment, Settling Defendant shall pay the sum of \$15,000, and on or before December 27, 2012, Settling Defendant shall pay the sum of \$15,000, for a total sum of \$30,000 as a settlement payment. The payment due within five (5) days of entry of this Consent Judgment shall be paid in two separate checks as follows: (a) \$9,830 made payable to the Center for Environmental Health; and (b) \$5,170 made payable to Lexington Law Group. The \$15,000 payment due on December 27th shall be made by check payable to Lexington Law Group. All of these payments shall be delivered to the offices of the Lexington Law Group (Attn: Howard Hirsch), 503 Divisadero Street, San Francisco, California 94117-2212. Any failure by Settling Defendant to comply with the payment terms herein shall be subject to a stipulated late fee in the amount of \$100 for each day after the delivery date the payment is received. The late fees required under this Section shall be recoverable, together with reasonable attorneys' fees, in an enforcement proceeding brought pursuant to Section 4.1 of this Consent Judgment.
- 5.2 **Allocation of Payments.** The total settlement amount for Settling Defendant shall be allocated as follows:
- 5.2.1 \$3,930 as a civil penalty pursuant to Health & Safety Code § 25249.7(b), such money to be apportioned by CEH in accordance with Health & Safety Code § 25249.12 (25% to CEH and 75% to the State of California's Office of Environmental Health Hazard Assessment).
- 5.2.2 \$5,900 as a payment in lieu of civil penalty to CEH pursuant to Health & Safety Code § 25249.7(b), and California Code of Regulations, Title 11, § 3203(b). CEH will use

such funds to continue its work educating and protecting people from exposures to toxic chemicals, including heavy metals. In addition, as part of its Community Environmental Action and Justice Fund, CEH will use four percent of such funds to award grants to grassroots environmental justice groups working to educate and protect people from exposures to toxic chemicals. The method of selection of such groups can be found at the CEH web site at www.ceh.org/justicefund.

5.2.3 \$20,170 as reimbursement of a portion of CEH's reasonable attorneys' fees and costs.

6. MODIFICATION

- 6.1 **Written Consent.** This Consent Judgment may be modified from time to time by express written agreement of the Parties with the approval of the Court, or by an order of this Court upon motion and in accordance with law.
- 6.2 **Meet and Confer.** Any Party seeking to modify this Consent Judgment shall attempt in good faith to meet and confer with all affected Parties prior to filing a motion to modify the Consent Judgment.

7. CLAIMS COVERED AND RELEASED

- This Consent Judgment is a full, final and binding resolution between CEH on behalf of itself and the public interest and Settling Defendant, and its parents, subsidiaries, affiliated entities that are under common ownership, directors, shareholders, officers, employees, and attorneys ("Defendant Releasees"), and each entity to whom they directly or indirectly distribute or sell Covered Products, including but not limited to distributors, wholesalers, customers, retailers, franchisees, cooperative members, licensors, and licensees ("Downstream Defendant Releasees") of any violation of Proposition 65 that was or could have been asserted in the Complaint against Settling Defendant, Defendant Releasees, and Downstream Defendant Releasees, based on failure to warn about alleged exposure to Lead contained in Fashion Accessories that were sold by Settling Defendant prior to the Effective Date.

10.4 Except as otherwise provided in this Consent Judgment, each Party shall bear its own attorneys' fees and costs.

11. TERMINATION

- 11.1 This Consent Judgment shall be terminable by CEH or by Settling Defendant at any time after September 1, 2017, upon the provision of 30 days advanced written notice; such termination shall be effective upon the subsequent filing of a notice of termination with Superior Court of Alameda County.

No supplementation, modification, waiver, or termination of this Consent Judgment shall be binding unless executed in writing by the Party to be bound thereby. No waiver of any of the provisions of this Consent

Judgment shall be deemed or shall constitute a waiver of any of the other provisions hereof whether or not similar, nor shall such waiver constitute a continuing waiver.

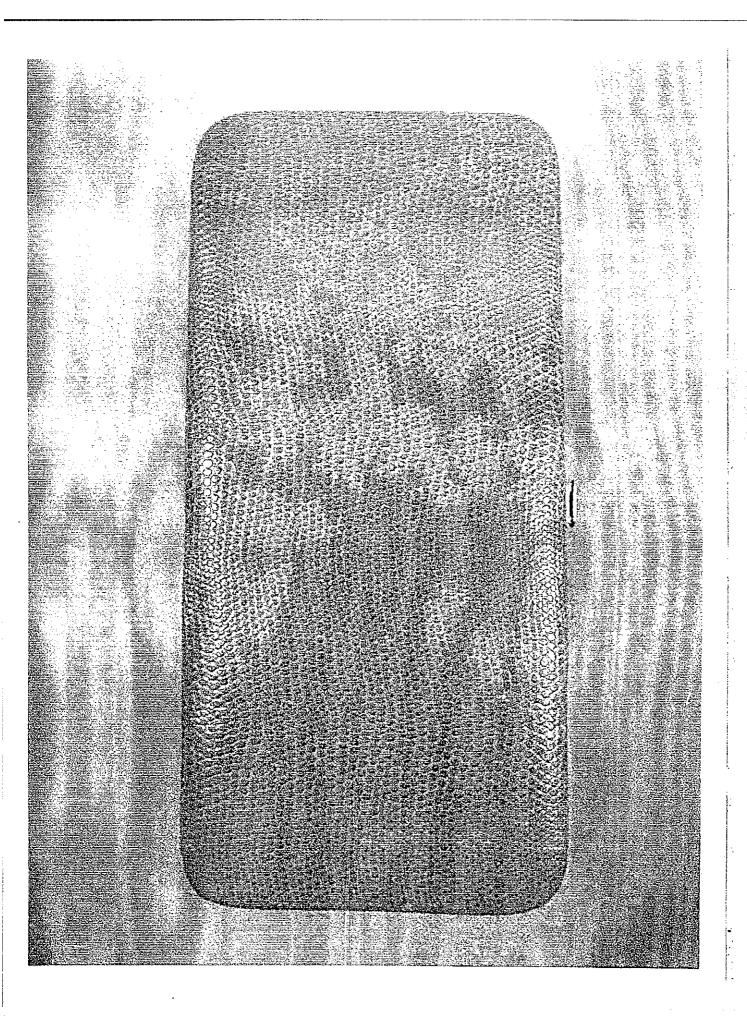

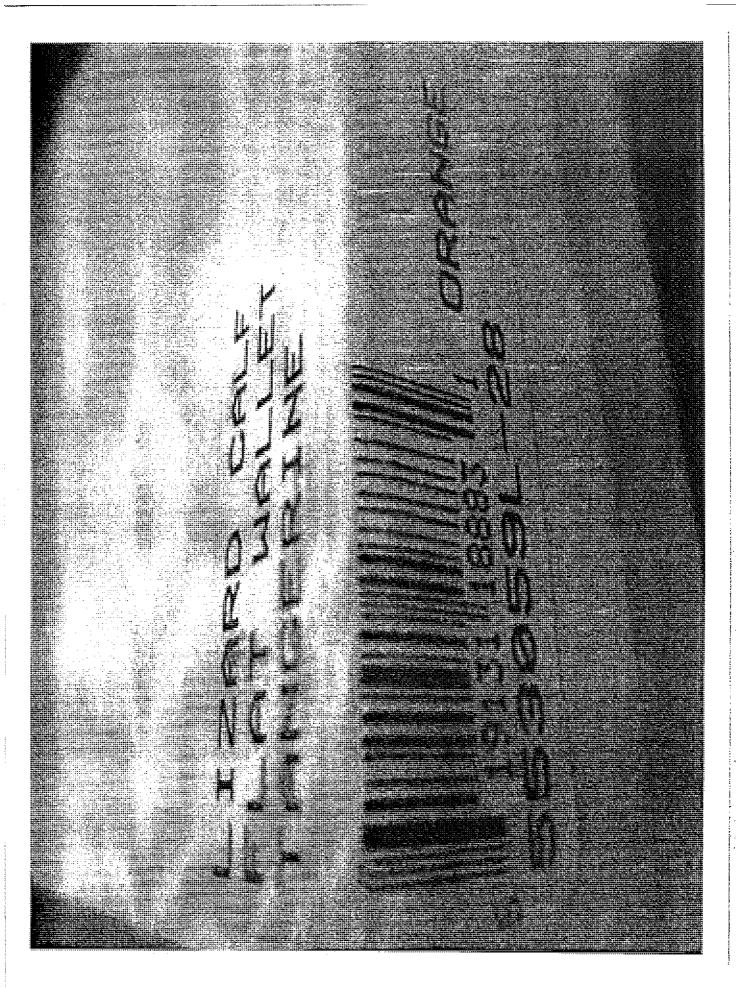
