Dear Sir or Madam:

The American Environmental Safety Institute serves this Notice of Violation ("Notice") upon J.M. Huber Corporation (hereinafter "Huber") pursuant to and in compliance with California Health and Safety Code ("H&S Code") §25249.7(d) and 22 California Code of Regulations ("CCR") §12903. This Notice satisfies a prerequisite for Noticing Party to commence an action against the Companies to enforce the Safe Drinking Water and Toxic Enforcement Act of 1986. The violations addressed by this Notice occur in every county and city in California. This Notice is being served upon each violator, the California Attorney General, the district attorney of every California county and the city attorney of every California city with a population (according to the most recent decennial census) of over 750,000. If the Companies have a current registration with the California Secretary of State that identifies a Chief Executive Officer, President, or General Counsel, this Notice is being addressed to, and served upon, one of those persons.

Attached as Exhibit A to this Notice is a copy of "The Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65): A Summary." The attached Summary was prepared by the California EPA and provides general information about the Safe Drinking Water and Toxic Enforcement Act of 1986. Copies of the Summary are not required to be, and are not being, provided to the public enforcement agencies.

Description of the Noticing Entity, the Violator, and the Violations Addressed by this Notice:

- ◆ This Notice is provided by the American Environment Safety Institute. The American Environmental Safety Institute is a California non-profit corporation and is acting in the public interest pursuant to California Health and Safety Code Section 25249.7(d), its business address is 555 Bryant Street, #218, Palo Alto, California 94301. Deborah A. Sivas, President of the American Environmental Safety Institute, is a responsible individual within the American Environmental Safety Institute.
- ◆ The violator's name and address is: J.M. Huber Corporation, 333 Thornall Street, Edison, NJ 08837-2220.
- ◆ The violations addressed by this Notice began on February 27, 1988, have occurred on numerous occasions each and every day since February 27, 1988, and are ongoing and continuing.
- ◆ This Notice of Violation covers the "warning provision" of Proposition 65, which is found at H&S Code §25249.6.
- ◆ The name of each chemical that is listed pursuant to the Safe Drinking Water and Toxic Enforcement Act of 1986 involved in the violations addressed by this Notice is Lead and lead compounds (carcinogen); and Lead (reproductive); (the "Listed Chemicals"). The Listed Chemicals are listed (and has been so listed for more than twelve months) by the Governor of the State of California as being a chemical known to the State of California to cause cancer or reproductive toxicity, or both cancer and reproductive toxicity. See Exhibit B attached hereto.
- ◆ The type of consumer products causing the exposures addressed by this Notice are toothpaste consumer products where Huber's products are used as ingredients in toothpaste products ("Products"), including but not limited to Jason Natural Products, Inc.'s toothpaste Products (e.g., Oral Comfort, Healthy Mouth, Powersmile, Nutrismile, and Sea Fresh), but excluding any toothpaste Products manufactured by Burt's Bees, Inc.; Church & Dwight Co., Inc.; Colgate-Palmolive Company; GlaxoSmithKline Consumer Healthcare, LP; Kiss My Face Corp.; Laclede, Inc.; Levlad, Inc.; Personal Products Company, a Division of McNeil-PPC, Inc.; Rowpar Pharmaceuticals; Tom's of Maine, Inc.; The Procter & Gamble Distributing Company; The Procter & Gamble Manufacturing Company; The Gillette Company; Zooth, Inc.; and Xlear, Inc.
- ◆ The routes of exposure for the violations addressed by this Notice are dermal contact and/or ingestion during use of the Product(s).

- ◆ There are numerous sources of the exposures addressed in this Notice. These exposures occur in homes, the workplace and everywhere else in California where these products are consumed. These exposures occur principally off the property of the Noticed Company.
- ◆ In the course of doing business, Huber knowingly and intentionally have exposed, and continues to expose, individuals (especially children) to the Listed Chemicals in the Products. No clear and reasonable warning is or has been provided by Huber to individuals regarding exposure to the Listed Chemicals or regarding the fact that the Listed Chemicals are known to the State of California to be a carcinogen and/or reproductive toxin.


2. I am the attorney for the noticing party.
