Re: NOTICE OF VIOLATION AGAINST CALIFORNIA PIZZA KITCHEN, INC., OF CALIFORNIA HEALTH & SAFETY CODE SECTION 25249.6

Dear Mr. Slayton and Appropriate Public Enforcement Agencies:

Rafael Delgado, Jr. ("Delgado") is a citizen of the state of California acting in the interest of the general public seeking to further, among other causes, the protection of the environment, toxics reduction, the promotion and improvement of human health, the improvement of workers and consumer rights, environmental education and corporate accountability. Mr. Delgado has identified violations of California's Safe Drinking Water and Toxic Enforcement Act of 1986 ("Proposition 65" or "Act"), which is codified at Cal. Health & Safety Code §25249.5 *et seq.*

Mr. Delgado has documented violations of Proposition 65 by California Pizza Kitchen, Inc (the "Violator"). This letter serves to provide Mr. Delgado's notification of these violations to California Pizza Kitchen, Inc., a Delaware corporation. Pursuant to §25249.7(d) of the statute, Mr. Delgado intends to bring an enforcement action sixty (60) days after effective service of this notice unless the appropriate public enforcement agencies have commenced and are diligently prosecuting an action to rectify these violations.

Information available to Mr. Delgado as of the date of this letter indicates that ongoing violations have occurred every day since at least December 14, 2011, at the Violator's restaurant located at 735 S. Figueroa St., #305, Los Angeles, CA 90017, and will continue every day until clear and reasonable warnings are provided to customers.

A copy of the Proposition 65 summary prepared by the Office of Environmental Health Hazard Assessment is attached, to the copy of this letter served to the Violator.

In the course of its business, the Violator knowingly and intentionally sells alcohol to its customers without first giving clear and reasonable warning to such individuals, as required by Proposition 65, Article 6, §12601(b)(1)(D)(2).

Mr. Delgado intends to file a private enforcement action as provided for in the Act for the alleged violations by the Violator, unless California agrees in an enforceable written instrument to: (1) recall the

listed products so as to eliminate further exposures to the identified chemicals; or (2) affix clear and reasonable Proposition 65 warning labels; and (3) pay an appropriate civil penalty. Consistent with the public interest goals of Proposition 65, Mr. Delgado is interested in seeking a constructive resolution to this matter, and invites violator, should it seek early resolution of this matter, to communicate directly with Delgado's attorneys. Such resolution will avoid further unwarned consumer exposures, as well as resource intensive litigation.


**CERTIFICATE OF MERIT**  
Health and Safety Code Section 25249.7(d)

**Re: Rafael Delgado Jr.'s Notice of Proposition 65 Violations by California Pizza Kitchen, Inc.**

I, Miguel A. Custodio, Jr., hereby declare:

1. This Certificate of Merit accompanies the attached sixty-day notice in which it is alleged the party identified in the notice violated California Health & Safety Code Section 25249.6 by failing to provide clear and reasonable warnings.
2. I am an attorney for the noticing party.
3. I have consulted with one or more persons with relevant and appropriate experience, extensively reviewed Proposition 65, Article 6, §12601(b)(1)(D)(2), and have assembled evidence attached to the copy for the California Attorney General as Exhibits 1 and 2 to this Certificate of Merit regarding the lack of warnings for the listed chemical that is the subject of the notice.
4. Based on the information obtained; Proposition 65, Article 6, §12601(b)(1)(D)(2); and on other information in my possession, I believe there is a reasonable and meritorious case for the private action. I understand that "reasonable and meritorious case for the private action" means that the information provides a credible basis that all elements of the plaintiff's case can be established and that the information did not prove that the alleged violator will be able to establish any of the affirmative defenses set forth in the statute.
5. The copy of this Certificate of Merit served on the Attorney General attaches to it factual information sufficient to establish the basis for this certificate, including the information identified in California Health & Safety Code §25249.7(h)(2).


